At the outset Sh. T. Pritam Singh, Regional Director and Convener, SRC welcomed the Chairperson and all members and apprised about the work done by the SRC along with the directions received from NCTE Hqrs from time to time.

The Committee considered the reply submitted by the institution vide letter dated 06.11.2019 and 25.11.2019 in response to the Final Show Cause Notice and found the following deficiencies: -

- 1. The institution has not submitted a copy of the Building plan approved by the Competent Authority.
- 2. The institution has not submitted latest Faculty list approved by the affiliating University.
- 3. The land documents submitted by the institution are not readable. The institution has not submitted Certified English Translated copy of Land Document.
- 4. The institution has not submitted notarized copy of NEC in English translated version and also not submitted a notarized copy of LUC.

In view of the above, the Committee decided to seek the above documents from the Institution by sending a last reminder (Letter) before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents / representation mentioned above within 21 days from the date of issue of the letter.



The Committee has taken up the following agenda items of 399th Meeting.

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee perused the order dated 22.3.2021 of the Hon'ble High Court of Delhi and reconsidered the institutions application dated 4.11.2020.

The Committee noted that after promulgation of the NCTE Regulations, 2014, the institution submitted an Affidavit dated 12.5.2015 for B.Ed. 2 units. Accordingly SRC, NCTE issued conditional RPRO. Subsequently the Management vide letter dated 25.6.2016 requested the SRC to reduce strength from 2 units to 1 basic unit of 50 students in B.Ed. programme.

The SRC agreed to the request made by the institution and accordingly vide order No. SRO/NCTE/APSO0619/B.Ed./KL/2017-18/94775 dated 11.9.2017 is issued for reduction of intake from 2 units to 1 unit in the B.Ed course.

Now the Management of the institution again seeking permission for increase of intake which is not permissible, as such SRC cannot consider the request made by the Management as per the NCTE Regulations. If the Management wants to increase their intake they have to make an application to the NCTE against the notification inviting applications to be issued by the NCTE Hqrs.

Therefore, the Committee decided that the request made by the institution for increasing the seats in its B.Ed. programme from 1 unit to 2 units may not be considered as per the existing provisions of the NCTE Act.

The recognition of the institution was withdrawn on the following grounds:

- 1. The institution has submitted photocopy of R.T.C. and Sale Deed. However, the institution has not submitted certified copy of land document. The land document submitted is in the name of an individual which not permissible under NCTE Regulations, 2014.
- 2. The survey no. mentioned in the building plan is 523/2A but the survey no. mentioned in the land document is 253/2A, 253/3A. The Multipurpose hall area is not mentioned in the building plan.
- The survey no. mentioned in BCC is 253/2A but the survey no. mentioned in the land document is 253/2A, 253/3A. The BCC submitted by the institution is not in the format prescribed by the NCTE.
- 4. The institution has not submitted Form 'A' issued by the Branch Manager. The FDRs submitted by the institution has been expired.
- 5. The Built-up area is not readable in the building plan. Multipurpose hall area is not mentioned in the building plan.
- 6. Date of joining in the faculty list is not mentioned for "Prof. Guruballappa J. Hattalli, Prof. Bandenawaz H. Awati, Prof. Priya Shetti, Prof. Mahadev Shinde, Dr. Vijayalaxmi Ningappa Kenganal, Prof. Sharadabai D Manami, Prof. Jnyneshwari B ShirahattimathProf. Muttappa N Kokatnur, Prof. Sadashic A. Huggi and Prof. Anand Honwad".
- 7. Faculty list submitted by the institution is not approved by the affiliating body.
- 8. 3 Lecturers have been shown appointed before promulgation of NCTE Regulations dated 09.06.2017, thus not having NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017.
- 9. The institution is required to submit latest staff list approved by the affiliating body for all the existing programmes.
- 10. As per order no. F.SRO/NCTE/B.Ed/2004-2005/8830 dated 30.11.2004 the institution shall shift to its own premises/building

within three years from the date of recognition. However as per VT report, the institution is not functioning from its own building and the institution has not clarify the same.

- 2. The Regional Director, SRC is directed to obtain clarification from the NCTE Hqrs. with regard to the B.Ed. (ODL), as the norms & standards published for the programme in 2014 regulations states that the Self Instructional Material prepared by the Institution should be approved by the Distance Education Bureau (DEB) of UGC. Not many institutions are obtaining approval from the DEB. In such a situation the NCTE Hq. may clarify, the SRC, NCTE how to go about. It may be viewed as most urgent.
- 3. The Committee directed the Regional Director, SRC to initiate follow up action on left out matters which the Committee decided earlier and to take necessary action to ensure their logical end.
