3.	<p><b>Kalaimagal College of Education, No.89/2, N.H.46, Atturkuppam Village, Natrampalli Panchayat, Tirupattur Taluk, Vellore District, Tamilnadu.</b></p> <p><b>File No. - APSO4685, Course - B.Ed.</b></p> <p><b>In response to the decision taken by the SRC in its 401<sup>st</sup> meeting held on 11<sup>th</sup> – 12<sup>th</sup> August 2021.</b></p> <p><b>The decision may be read as under:-</b></p> <p>The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -</p> <p>The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 18.09.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.</p> <ol style="list-style-type: none"> <li>1. The institution applied for shifting of premise at the new location but the same is still not finalized.</li> <li>2. The land documents submitted by the institution is neither certified nor notarized.</li> </ol>

	<ol style="list-style-type: none"> <li>3. The notarized English translation of Sale Deeds belongs to Survey numbers 390/A/1 and 386/1 whereas the LUC submitted for S.F.Nos 383/1A, 383/1B, 386/1A, 386/2, 387/2B, 387/3A, 390/3A, 390/A/1B, 392/1B. Both do not match with each other.</li> <li>4. The NEC submitted for survey numbers 383/1B2B, 282/1A2A, 392/A1B, 390/3A, 387/3A, 387/2B/386/1A which do not match with LUC and land documents.</li> <li>5. The building plan submitted by the institution is not approved by the competent authority.</li> <li>6. BCC submitted by the institution is not legible.</li> <li>7. The institute submitted a copy of letter dt. 19.03.2020 issued by the affiliating University for approval of Principal only. Vide letter dt. 19.12.2016 One Principal, 9 Asstt. Professors and One Physical Director was approved. The institute did not submit the latest approval of faculty issued by the University. Further, the faculty strength is not enough for B.Ed. course of two Units and proforma of faculty is not legible as signature and stamps of Registrar is not visible.</li> <li>8. Faculty shown to be appointed in 2014 and onward, it is not established that whether these faculty are still working in the college or left? The institution is required to submit Bank Statement showing and establishing disbursement of salary to staff for last five years as required under Clause 10(3) of NCTE Regulations, 2014.</li> <li>9. Website of the institution is not functional and without upload the information as required under NCTE Regulations, 2014.</li> <li>10. Faculty namely R.Elumalai appointed on 15.09.2017 do not possess NET qualification and hence not qualified as appointed after the date of NCTE's notification dt. 09.06.2017.</li> <li>11. The website of the institution is not updated with the information prescribed under para 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.</li> </ol> <p>Hence, the Committee decided to <b>withdraw the recognition</b> granted to <b>Kalaimagal College of Education, No.89/2, N.H.46, Atturkuppam Village, Natrampalli Panchayat, Tirupattur Taluk, Vellore District, Tamilnadu</b> for conducting <b>B.Ed.</b> programmewith effect from the academic session i.e. 2021-2022 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.</p>

	<p>by the SRC and the following observations were made:-</p> <p>The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide dated 23.06.2020. The Committee observed the reply submitted by the institution and found the following deficiencies.</p> <ol style="list-style-type: none"> <li>1. The initial recognition was granted to the institution namely S.V.S. College of Education under the management of Trust namely Sri Venugopal Swamy Educational Trust.</li> <li>2. The Committee in light of letter No. ED476UBV2007 dt. 07.12.2007 issued by the Govt. of Karnataka and letter No. ACA-3/A3/SVSCE:2007-08 dt. 20.09.2007 issued by the Vice Chancellor, Bangalore University decided that the request of the institution regarding change of name of institution from S.V.S. College of Education to Anugraha B.Ed. College is accepted and ratified. The Committee also decided not to allow change in the name of the trust. Necessary change in the website of the SRC, NCTE be made.</li> <li>3. The Committee further decided to issue the Final Show Cause Notice for submission of compliance of adherence of conditions of NCTE Regulations, 2014 be issued to the institution under its new name. The withdrawal order issued as per the decision of SRC taken in the 401<sup>st</sup> meeting be treated as cancelled.</li> </ol>

1.	<b>Language Pandit Colleges/course in the State of Telangana – Direction of the Hon’ble High Court Order in respect of W.P. No. 5634 of 2019 tilted as Anaganti Bhavani and 8 others Vs. State of Telangana and 7 others dated 29<sup>th</sup> April, 2019.</b>
	<p>The Committee perused the matter pertaining to the equivalence of Telegu Pandit Training Programme offered in the States of Andhra Pradesh and Telangana with that of B.Ed. as per direction given by the Hon’ble High Court of Telangana.</p> <p>The Committee noted the Govt. of Andhra Pradesh G.O. Ms. No. 80 dated 2.5.2005 interalia prescribed the following General Educational Qualifications for the Language Pandit Training courses. :-</p> <p><b>a) <u>Telugu Pandit Training Course</u></b></p> <p>(i) B.A. (Telugu Literature) or B.A. (Oriental Language-Telugu) or B.O.L in Telugu</p> <p>(ii) B.A. with optional Telugu</p> <p>(iii) M.A. (Telugu)</p> <p><b>Note: Apart from the above, educational qualifications, a pass in SSC is a must.</b></p> <p><b>b) <u>Hindi Pandit Training Course:</u></b></p> <p>(i) University Graduation degree with Hindi as one of the full elective subjects or BOL(Hindi)</p> <p>(ii) Praveen of Dakshina Bharat Hindi Prachar Sabha or Vidwan of Hindi Prachar Sabha, Hyderabad or any other equivalent recognised qualification in Hindi (B.A Standard)</p> <p>(iii) M.A. (Hindi)</p> <p><b>Note: Apart from the above general educational qualifications, a pass in SSC is must.</b></p> <p><b>c) <u>Urdu Pandit Training Course</u></b></p> <p>(i) B.A. (Urdu Literature) or B.A. (OL-Urdu) or B.O.L</p> <p>(ii) B.A. with optional Urdu.</p> <p>(iii) M.A. Urdu.</p> <p><b>Note: Apart from the above educational qualification, a pass in SSC is a must.</b></p> <p>As this programme is offered in the combined State of the Andhra Pradesh and also continued in the separated states of Telangana and Andhra Pradesh. In order to present the stand of the NCTE to the Hon’ble High Court of Telangana, it is decided to obtain the following information pertaining to the Telegu Pandit or other Language Training</p>

	<p>Programme from the competent authority i.e. the Director, SCERT of Telangana and Andhra Pradesh.</p> <ul style="list-style-type: none"> <li>(i) <i>List of the institutions offering this programme both Govt./University/Aided Private Managements</i></li> <li>(ii) <i>For recruitment whether this course is considered as equivalent to B.Ed. or D.El.Ed.</i></li> <li>(iii) <i>The products of such a programme are appointed as Secondary Grade Teachers/Graduate Teachers or Primary Teacher</i></li> <li>(iv) <i>Whether the institutions offering this programme obtained recognition from the NCTE/Revised Provisional Order issued or not in compliance to NCTE Regulations, 2014 of the NCTE</i></li> </ul> <p>Before arriving at the final conclusion, the above information may be obtained and the matter may be placed before the next meeting of the SRC from both the States. The SRC office shall also place the status of all the Language Training Programme TEIs.</p>
2.	<p><b>Consideration of proposal from Govt of Telangana -TWD- Telangana Tribal welfare Residential Educational institutions Society(TTWREIS)-Hyderabad – Permission to make an application to SRC, NCTE for establishment of Teacher Educational Institutions exclusively for Tribals-reg. – addressed to the Chairperson, NCTE</b></p> <p>The Regional Director, SRC received a request letter from the Special Secretary to Government of Telangana seeking permission to establishment of Teacher Education Institutions exclusively for Tribals. The same was perused by the Committee.</p> <p>The Committee appreciated the initiative of the Tribal Welfare Department, Govt. of Telangana and unanimously resolved to recommend to the Chairperson, NCTE to accord special permission to the Tribal Welfare Department, Govt. of Telangana for making an application for obtaining recognition for (i) 2 years' B.Ed. (ii) 4 years' BA.B.Ed. / B.Sc.B.Ed. Integrated Programme and (iii) 4 years' Integrated B.P.Ed. programme exclusively for Tribal Students. The Committee also felt that this initiative from NCTE will go a long way to provide quality teacher education to the Tribal Students.</p>
3.	<p><b>Consideration of matter of Teacher Education Centres in Kerala</b></p>

	<p><b>Offering B.Ed. course without recognition from NCTE.</b></p> <p>The Committee thoroughly debated on the existence of teacher education centres in Kerala offering B.Ed. course without obtaining proper recognition from NCTE since last couple of years.</p> <p>No Revised Provisional Recognition Order (RPRO) was issued to these institutions for running the B.Ed. course of two years' duration as per NCTE Regulations, 2014. Under this circumstances the institution are not eligible to continue from the date of promulgation of NCTE Regulations, 2014 i.e. 28.11.2014. Hence the recognition shall stand cancelled/withdrawn with effect from the date of promulgation of the NCTE Regulations, 2014 i.e. 28.11.2014.</p> <p>The committee viewed it very seriously and decided to inform the Calicut University which is running these teacher education centres to close down them immediately.</p> <p>Further, the Regional Director, SRC is also advised to write a letter to the Secretary (Education), Govt. of Kerala to direct all the Registrar of Universities in Kerala State not to allow any teacher education centre to offer any of the teacher education programmes in Kerala without obtaining proper permissions from the Govt. of Kerala and the NCTE.</p> <p><b>The RD, SRC shall also issue a formal order of withdrawal/cancellation of above programmes as per the above decision of the SRC.</b></p>
4.	<p><b>Consideration of matters pertaining of 395 D.Ed. Institutions of Andhra Pradesh which have not submitted reply to SCN issued as per decision of SRC in its 401<sup>st</sup> meeting in compliance of letter No. RC. No.ESE02-22025/43/2020-(SCERT) TRG-DSE dated 25.03.2021 received from Sri V. Chinaveerabhadradu, I.A.S. Director, School Education, Andhra Pradesh.</b></p> <p>The Committee discussed the matter pertaining to the withdrawal of recognition to the TEIs offering D.El.Ed. programme in Andhra Pradesh as desired by the School Education Department, Govt. of Andhra Pradesh. It is resolved to withdraw the recognition of all such TEIs who have failed to respond to the notice (published on the NCTE website) and also sent to the TEIs through e-mail. The RD, SRC is advised to serve withdrawal orders accordingly.</p> <p>Further Final SCN be issued to those D.El.Ed. colleges who have replied to the notice and still if there are any deficiency(ies) to comply them within the stipulated time.</p>

The Committee also decided that continuation order be issued to the Institution for B.Ed. programme for 1 basic unit of 50 students.</b></p> <p><b>The Committee further directed to change in the records and website accordingly.</b></p>

A show cause notice dt. 01.09.2009 was issued to the institute for submission of application alongwith fee and other relevant documents. Another SCN dt. 07.01.2021 in time with RPRO and shifting was also issued. Moreover the building plan submitted at the time of recognition and now submitted in response to reply to RPRO is mismatched. The institute in its reply dt. 22.02.2021 submitted that there is no change of land and building since grant of recognition in 2003.”</i></p> <p>In light of above, the Committee decided to seek a clarification on the above points from the institution before further deciding to cause VT for <b>shifting of premises</b> for inspection of infrastructure &amp; instructional facilities etc. of <b>Catherine College of Education, Visakhapatnam Revenue Division, Box# 9, Bheemunipatnam Visakhapatnam-531163, Andhra Pradesh.</b></p>
