

The Appellate Authority vide order No. 89-173/E-186226/2021 Appeal/18<sup>th</sup> Meeting, 2021 Appeal No.APPLSRC20214029 dated 02.09.2021 appeal remand back the order appealed against. Till date the institution has not submitted the original / notarized documents for the deficiencies identified by the Appellate Committee and as such the Committee decided to send a notice to the institution to submit the required documents to office the RD, SRC. The recognition of the institution was withdrawn on the following grounds:

- (i) The institution is required to submit certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarised copy of English version of land documents
- (ii) The institution is required to submit an attested/notarised copy of Land Use Certificate issued by the Competent Authority
- (iii) The institution has not submitted a copy of Non-Encumbrance Certificate issued by the Competent Authority. The institution is required to submit an attested/notarised copy of Non - Encumbrance Certificate issued by the Competent Authority.
- (iv) The institution is required to submit an attested/notarised copy of the approved Building Plan (if institution is running more than one Teacher Education programme, it shall be required to submit an exclusive earmarked building plan for each of the recognised Teacher Education programme)
- (v) An attested/notarised copy of site plan showing all the plot/Survey No. mentioned in the land documents in one location alongwith land area and built up area.

1. The institution is required to submit the latest staff list duly

approved by the affiliating University.

In view of the above, the Committee decided to seek the above documents from the Institution by sending a last reminder (Letter) before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents / representation mentioned above within 21 days from the date of issue of the letter.

13. Repalle Christian College of Education, Reppalle, Guntur-522265, Andhra Pradesh.

File No. - APS00016, Course - B.Ed.

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The SRC considered the Report submitted by the Committee constituted by the SRC and found the following deficiencies: -

- 1. The management has not constructed exclusive building for teacher education program. The building that is available is constructed by the society to conduct its trust activities such as school etc. On the day of visit there is no classwork that is going on as no single student is seen. The library and labs are ill equipped and not updated and the labs were not put to use at any point of time. The faculty is not available as per approved list.
- 2. Only four people were present and on interaction with the Committee members found that they are not regular to the institution. Only for the inspection sake they were called for a day. Though the institution is pretty old, no single record is maintained, and any document is asked for, they were not able to provide. Further on verification it is found that all the admitted students are from Odisha, Jharkhand etc. they are not attending any class work rather simply attending the examination including practicals. It is a clear case that the institution is running for commercial gains.
- 3. The total built up area of the existing building is 2040 sq.mtrs. which is not sufficient for running B.Ed. course alongwith school.
- 4. The institution did not appoint non-teaching staff and librarian.
- 5. Facilities for Physical & Health Education, Art & Craft, Work Experience and IT Literacy are not available in the college.
- 6. Suitable teaching learning resources (kits) for mathematics education are not available.
- 7. Equipments for the curriculum laboratory are not available.
- 8. Facilities in the ICT Resource Centre are not available.
- 9. Furniture in the Art & Resource Centre and Health and Physical Resource Cenre are not available.
- 10. Facilities in the Health and Physical Resource Cenrtre are not

available.

- 11. Educational Journals are not provided in the library.
- 12. Only 1 Encyclopedia is provided in the library which is not sufficient.
- 13. Online resources are not available in the library.
- 14. Details regarding practice teaching and finances, FDRs are not provided to the Committee.
- 15. Website of the institution is not functional.

Therefore, the SRC decided to withdraw the recognition from the academic session 2021-2022 **u/s 17 of NCTE Act, 1993**. However an opportunity is given to the institution before issuing the withdrawal orders, the institution may reply if there is any grieivnace alongwith the documentary evidences including an Affidavit within 21 days from the date of issue of the Notice. After perusal of the reply, if there is any, the withdrwal order will be issued to the Institution.

14. Bharathi B.P.Ed College, Khasara No. 101/a1, 101/a2,100/3, 99/1,93/a2,41/1c,42/2,43,26/3, Plost No. 101/A1, 12/2B, Street, Kandulapuram Village, Cumbum Post & Taluk, Prakasam District-523340, Andhra Pradesh.

File No. – SRCAPP181, SRCAPP2609, SRCAPP1236, SRCAPP2602, Course – B.P.Ed., B.Ed., D.El.Ed., D.El.Ed.-Al

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The SRC considered the report of the Committee who visited the institution on on 30.09.2021 and found the following deficiencies: -

- 1. Approach road to reach the institution is not available.
- 2. The institution is situated in the agricultural land.
- 3. All labs are ill equipped and non-functional.
- 4. Library is in bad shape and not in use.
- 5. The management failed to present the faculty though the advanced information was given to the institution by NCTE and affiliating University.
- 6. There is no faculty list approved by the affiliating body.
- 7. The building shown to the Committee is not as per the building plan.
- 8. The land and other facilities are not sufficient to run B.P.Ed., B.Ed., D.El.Ed. and D.El.Ed (AddI Intake) courses.
- 9. Students were not available at the time of visit.
- 10. The institution is not maintaining any essential records.
- 11. All admissions are made by the students of Odisha and Jharkhand State.
- 12. Neither any practical nor teaching work is conducted by the

institution.

13. The institution is in a very shabby state and the Management's aim is only to make money by illegal practices.

Therefore, the Committee decided to withdraw the recognition from the academic session 2021-2022 **u/s 17 of NCTE Act**, 1993. However an opportunity is given to the institution before issuing the withdrawal orders, the institution may reply if there is any grieivnace alongwith the documentary evidences including an Affidavit within 21 days from the date of issue of the Notice. After perusal of the reply, if there is any, the withdrwal order will be issued to the Institution.

The management has misled the NCTE and VT Members, affiliating University and the State Government, obtained recognition and permission by providing all the false information for B.Ed., B.P.Ed. D.El.Ed. and additional intake in D.El.Ed. courses.

The situation in the institution demand further probing by an appropriate body for iniating necessary action against the Management and VT Members associated with it.

The request of the management for closure of B.P.Ed. course is deferred for the next meeting.

15. Star B.Ed. College, Plot No.1, Main Road, Medikonduru Village and Post office& Taluka, Guntur Distrit-522438, Andhra Pradesh.

has submitted its reply on 10.03.2021. The Committee observed the reply submitted by the institution and found the following deficiencies.

- The institution submitted building plan but the same is not approved by the Bangalore Development Authority. Further, the multipurpose hall is not available in the institution as per the building plan as required under clause 6(ii)(b) of Appendix 4 of NCTE Regulations, 2014.
- 2. The institution submitted building completion certificate but the same is not approved by the competent authority.
- 3. The institution submitted a copy of letter dt. 26.12.2019 issued by the Registrar, Bengaluru North University inter-alia approving 8 faculty. The faculty strength is not enough for one unit of B.Ed. course as stipulated under clause 5.1 of Appendix 4 of NCTE Regulations, 2014 and latest approval of faculty issued by the University alongwith proforma of faculty signed by the University has not been submitted.
- 4. Website of the institution is not functional with upload the information required under clauses 8(6), 8(14) and 10(3) of NCTE Regulations, 2014.
- 5. The institution did not submit documents related to managing society / trust.
- 6. Details of other courses being run in the same premise have not been submitted.
- 7. The institution is required to submit **consolidated Staff list** duly approved by the Registrar of the affiliating body as per the prescribed Format **approved after issuance of this notice / last reminder**. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.)

- 1. The institution submitted a copy of Encumbrance Certificate of Property but the same belongs to the year 2009. The institution is required to submit the latest one.
- 2. The institution submitted a copy of building plan but the same is neither approved by the competent authority nor it is legible to ascertain the size of rooms, halls, labs, library etc.
- 3. The institution submitted a copy of letters dt. 05.08.2009, 21.08.2015 and 08.10.2015 issued by the Registrar, Gulbarga University regarding approval of Principal and 9 faculty only. The institution did not submit the latest approval of faculty issued by the University.

The institution is required to submit consolidated Staff list duly approved by the Registrar of the affiliating body as per the prescribed Format approved after issuance of this notice / last reminder. (In case the institution is running more than one teacher education programme, it is required to submit staff list duly

approved by the Affiliating body for each of the recognised teacher education programme being run by the Institution.).

Also, the institution is required to submit the bank statement of last 6 months showing disbursement of salary to faculty through bank account as stipulated under clause 10(2) of NCTE Regulations, 2014.

The Committee visited the institution and observed that this institution is running in a school without any earmarked facilities for the college. The library, labs and other facilities required for the institution are not made available. The faculty is not appointed and the class work is not taking place at any point of time. The University has not extended the affiliation since last couple of years. However, the Management by way of submitting false information to the Hon'ble High Court at Hyderabad and obtaining orders for continuation. The Committee found that it is fake institution not complying any norms & standards prescribed by the NCTE.

Therefore, the Committee decided to withdraw the recognition from the session 2021-22 **u/s 17 of NCTE Act**, 1993. However an opportunity is given to the institution before issuing the withdrawal orders, the institution may reply if there is any grieivnace alongwith the documentary evidences including an Affidavit within 21 days from the date of issue of the Notice. After perusal of the reply, if there is any, the withdrwal order will be issued to the Institution.

The RD, SRC is advised to give the detailed note in the withdrawal orders and the same may be submitted to the Hon'ble High Court at Hyderabad through our Standing Counsel.
