In view of the difficulty being faced by the Universities, the SRC requests the Member Secretary, NCTE to write a letter to the Secretary, UGC to direct the DEB for issuance of certificate / letter on the Self Instructional Material (SIM) submitted by the Universities offering B.Ed. programme through ODL mode after following due procedure and examination. The RD, SRC is advised to do the needful in this regard.
