	<p>The first meeting of the Sub-Committee held on 22.10.2019 and decided the following:-</p> <p>The Hon'ble High Court of Hyderabad in WP No. 5634 filed by Anagati Bhavani and others Vs. State of Telangana & others directed the NCTE to clarify whether Telugu Pandit Training is equivalent to B.Ed. course as per NCTE Regulations or not.</p> <p>In order to reply to the Hon'ble Court the matter was placed before the SRC in its 380th meeting held on 18th and 19th September, 2019. The Regional Committee after through deliberations, decided to constitute a Sub-Committee with the following members as the matter is not just confined to the Telugu Pandit alone. The Sub-Committee met on 4.10.2019 and decided the following:-

A Sub-Committee constituted by the SRC, NCTE, New Delhi met on 4.10.2019 to respond to the matter before the Hon'ble High Court of Telangana with regard to an issue pertaining to Telugu Pandit Training programme. As this programme is offered in the combined State of the Andhra Pradesh and also continued in the separated states of Telangana and Andhra Pradesh. In order to present the stand of the NCTE to the Hon'ble High Court of Telangana, it is decided to obtain the following information pertaining to the Telegu Pandit Training Programme from the competent authority i.e. the Director, SCERT of Telangana and Andhra Pradesh.

- (i) ***Title of the Course***
- (ii) ***Duration of the Programme***
- (iii) ***Time allocated for teaching practice and internship***
- (iv) ***Eligibility for admission into the course.***
- (v) ***Examining body***
- (vi) ***Authority which will award the degree or certificate***
- (vii) ***Course structure and a copy of the syllabus***
- (viii) ***List of the institutions offering this progamme both Govt./University/Private Managements***
- (ix) ***Latest status of the programme***
- (x) ***For recruitment whether this course is considered as equivalent to B.Ed. or D.El.Ed.***
- (xi) ***The products of such a programme are appointed as Secondary Grade Teachers/Graduate Teachers or both***
- (xii) ***Whether the institutions offering this programme obtained recognition from the NCTE/Revised Provisional Order issued or not in compliance to NCTE Regulations, 2014 of the NCTE***

The next meeting may be scheduled immediately after obtaining the information from both the States. Meantime the Legal Counsel may be advised to inform the Hon'ble

High Court that the NCTE is actively considering the matter and will submit its view point at the earliest may be within 2 weeks.

The Sub Committee again met on 22.10.2019 and the Regional Director, SRC apprised the Members about the information received from the Director, SCERT, Telangna and whereas, the Director, SCERT, Andhra Pradesh even with a letter and reminder not furnished the information sought for.

The Committee Members are aware that the State of Telangna is not continuing with Telegu Panidt Training Programme after promulgation of NCTE 2014 Regulations. However, it is reliably learnt that the Govt. of A.P. is continuing the progarmme without reference to NCTE 2014 Regulations (with 1-year duration etc).

In view of the insufficient information from both the States, it is directed to write a detailed letter again to the Director, SCERT, of Telangna/Andhra Pradesh asking for the details mentioned above. The Sub-Committee is also of the view that the Language Teacher Training Progarmmes are existing since independence and spread to many States in the country. In addition to the regional languages, there are few National Institutions offering teacher education programmes for preparation of teachers in Hindi, Urdu and Sanskrit languages. Hence, this issue though pertaining to Telugu Pandit, the matter require thorough scrutiny.

As such the Sub-Committee is of the view that the matter may be forwarded to the NCTE Hqrs. for appropriate action.
