

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Neumand Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on

ND WHEREAS, the institution i.e. Ladwa College of Education, Indri Road, Kurukshetra, Haryana - 136 01.12.154 131 as been recognized for B.Ed course by NRC vide order No. F.NRC/NCTE/HR-1119/2008/58074 dated 22nd August TOW with an additional intake of 100, thereby making the total annual intake of the institution to 200 seats.

AND WHEREAS, the institutionhas by affidavit consented to come under New Regulations and has sought for mar basic units in B.Ed., which require additional facilities.

AND WHEREAS, it has been decided to permit the institution to have four basic units of 50 students each, to the institution fulfilling the following conditions, namely:-

- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional intrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Northern Regional Committee, with required documents by October 31, 2015.
- The institution for additional unit will be required to submit the required documents such as, land documents, non-encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents, if available, otherwise it can also be given to the Visiting Team at the time of
- The Regional Committee shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institution shall not be permitted to admit
- In caseany existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court 1111 order/reply to SCN/complaint/already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases

Now therefore, in light of the above, the Northern Regional Committee, NCTE hereby issues the revised Reseptation Order to Ladwa College of Education, Indri Road, Kurukshetra, Haryana - 136 132, for conducting B.Ed. regramme of two years duration with an annual intake of 200 students, for four basic units of 50 students each, from the Phic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other Latery bodies like UGC, affiliating University/ Body, State Government etc. as applicable.
