ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- AND WHEREAS, the institution Vivekananda B.Ed College, KGT Road, Kandukur-523105, Prakasam District, Andhra Pradesh has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.
- AND WHEREAS, on scrutiny it is found that the institution has not maintained/revalidated the Fixed Deposited Receipts towards Endowment and Reserve Funds.
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 failing which the recognition will be withdrawn.

The institution shall create additional facilities that include (a) additional built-up area, (b) additional (ii). infrastructure, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.

The applicant-institution for additional unit will be required to submit the required documents such as (iii). land documents, Encumbrance Certificate(EC), Land Use Certificate(LUC) and the Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.

The Regional Committees shall arrange for verification of documents, inspection of these premises (iv). and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to

admit students for the academic year 2016-2017.

- NOW THEREFORE, in the light of the above and in terms of Section 14(3) (a) of NCTEAct and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Vivekananda B.Ed College, KGT Road, Kandukur-523105, Prakasam District, Andhra Pradesh for conducting B.Ed programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 subject to submission of revalidated FDRs of the enhanced value in joint account with the SRC before 30 June, 2015 and fulfilment of the conditions mentioned at II & III herein before 31.10.2015.
- Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain & update its web-site as per provisions of NCTE Regulations and alway display following as mandatory disclosure;-

a. Sanctioned programmes along with annual intake in the institution:

b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

d. Names of Students admitted during the current session along with qualification, Percentage o marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e. Fee charged from students;

f. Available infrastructural facilities;

g. Facilities added during the last quarter:

h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;

The affidavit with enclosure submitted along with application.

j. The institution shall be free to post additional relevant information. if it so desires.

k. Any false or incomplete information on website shall render the institution liable for without of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
