As per records available the SRC, NCTE vide its Order No. F.AP/B.Ed-New/58/SRO/NCTE/2001-2002/8465 dated 5 th November, 2001 refused recognition to Sri Sai Sirisha College of Education, Gandhi Nagar, Kasibugga-532222, Srikakulam District, Andhra Pradesh for conducting B.Ed. Course on the ground that the institution has appointed only 1 qualified teaching staff as against 10 for an intake of 120 as per NCTE norms and UGC Regulations.
	The SRC records also reveals that the Appellate Authority vide order No. F.No.42-135/2001 Appeal/16787 dated 6.2.2002 reserve the order of the Council hereby reverses the Order of the SRC, NCTE, Bangalore and grants recognition to Sri Sai Sirisha College of Education, Ganghi Nagar, Kasibugga, Srikakulam, A.P. for conducting B.Ed. course with an intake of 100 students subject to the condition mentioned in the order.
	The MIS records also reveals that the recognition of the institution was withdrawn. However relevant records are not available in the SRC, NCTE.
