I. GROUNDS OF WITHDRAWAL

The appeal of K.J. Somaiya School of Education, 103 a/1(PT), 14(pt) CTS no 499/4c/3, 503a/2,503b, 6th Floor Bhaskar, 7th Road Rajawadi, Kirol, Kurla, Mumbai, Maharashtra-400077 dated 05.06.2025 filed under Section 18 of NCTE Act, 1993 is against the Order No. File No. NCTE / 2025 / WRC / PAR / ORDER / APW03364 / 125041 / dated 21.05.2025 of the Western Regional Committee, withdrawing recognition for conducting M.Ed. Course on the grounds that "The institution has not submitted any reply to the show cause notice."

II. SUBMISSIONS MADE BY APPELLANT: -

Dr. Pooja Birwatkar, I/c Principal of K.J. Somaiya School of Education, 103 a/1(PT), 14(pt) CTS no 499/4c/3, 503a/2,503b, 6th Floor Bhaskar, 7th Road Rajawadi, Kirol, Kurla, Mumbai, Maharashtra-400077 appeared online to present the case of the appellant institution on 03.07.2025. In the appeal report, it is submitted that "This has reference to the mail received on 24/5/2025 regarding Withdrawal Order of Recognition of M.Ed program of K J Somaiya Comprehensive College of Education, Training and Research for M.Ed programs. In the Withdrawal letter the following was mentioned- For M.Ed - The institution has not submitted any reply to the show cause notice Please note that the reply to the show cause notice for M.Ed program was along with the submission of reply to show cause notice reply of B.Ed program. As the institution is same which is offering both B.Ed and M.Ed a single login was created. In the same reply justification regarding non filling of PAR for M.Ed was also there. Please note the following K. J. Somaiya Comprehensive College of Education, Training & Research (renamed as K J Somaiya School of Education) started in 1990 and has been recognized as quality teacher Education Institution (3 times NAAC accreditations with A grade) since last 35 plus years. The institute has always complied with all rules and regulations of NCTE and

has submitted all Performance Appraisal Reports (PAR) regularly under the old name. -The non-submission of PAR for 2021- and 2022-23 was solely due to technical limitations caused by the outdated listing of our institution on the NCTE portal. -In 2019 the college became a constituent college of Somaiya Vidyavihar University (UGC recognized) and the name was changed from K J Somaiya Comprehensive College of Education, Training and Research to K J Somaiya College of Education. The premises were also changed although in the same campus. -The institution is listed on the NCTE website under its previous name (K J Somaiya Comprehensive College of Education, Training and Research) with the following details: M.Ed. File No: WRC/APW03364/125041/2015/152496 (Dated: 09/09/2015) . However the PAR for B.Ed. for 2021-22 and 2022-23 could not be submitted due to the name change of the institution along with change in affiliation. -K J Somaiya Comprehensive College of Education, Training and Research de-affiliation from University of Mumbai is process. The College Affiliation and Development Department of University of Mumbai via its letter Aff./ICM/2025-26/403 dated 30th May 2025 has informed that the de-affiliation matter of the college will be placed before the Management Council of University of Mumbai and the required letter of de-affiliation will be issued on its approval. K J Somaiya Comprehensive College of Education, Training and Research had been following up with University of Mumbai since 20th Feb 2020 for de-affiliation, which is mentioned in the letter issued by University of Mumbai (Aff./ICM/2025-26/403) -K. J. Somaiya Comprehensive College of Education, Training & Research has been renamed as K J Somaiya School of Education and is now a constituent of Somaiya Vidyavihar University, Mumbai (a UGC-recognized university) awarded an 'A' grade (Cycle 1) by NAAC. -The Performance Appraisal Reports (PAR) for the years 2021-22, 2022-23. 2023-24 and 2024-25 have been prepared and submitted to NCTE on 2nd June 2025 in physical mode and acknowledgement of the same has been received. These documents have also been dispatched to the NCTE office via speed post on 30th May 2025, along with covering letter and relevant enclosures. -On

both 2nd and 3rd June, 2025 respectively, representatives from K. J. Somaiya Comprehensive College of Education, Training & Research (now K J Somaiya School of Education) interacted with NCTE-WRC Regional Director in a physical mode at NCTE -New Delhi premises regarding the withdrawal order as well as Officials of NCTE. The Regional Director of WRC NCTE asked to submit application along with a list of documents. Following this, on 3rd June, 2025 the following was submitted as hard copy to despatch section at NCTE addressed to Regional Director of WRC-NCTE and was also handed personally as hard copy to Regional Director of WRC-NCTE 1. a covering letter debriefing the issue 2. An appeal regarding the matter debriefing all communication made to WRC-NCTE since 2020. 3. Documents(as requested by WRC-NCTE)- -UGC notification regarding establishment of Private University -Somaiya Vidyavihar University Resolution -Gazette Notification from Govt of Maharashtra -2f Recognition by UGC -Copy of the letter from the University of Mumbai regarding de-affiliation -Correspondences done with NCTE since 2020 -Recognition letters for NCTE for B.Ed and M.Ed programs An acknowledgement regarding the submission of this application along with documents was received from NCTE on 3rd June, 2025. -We respectfully submit that no action for withdrawal of recognition be initiated, as the institution has made continuous efforts to communicate these changes to NCTE and has fulfilled all its obligations. The School has been diligent and time and again notified WRC-NCTE and requested WRC-NCTE to guide. Chronology of Communication to NCTE and Developments In 2019 the college became a constituent college of Somaiya Vidyavihar University (UGC recognized) and the name was changed from K J Somaiya Comprehensive College of Education, Training and Research to K J Somaiya College of Education. The premises were also changed although in the same campus. Regarding this transition there were umpteen correspondences made to NCTE Following are the references regarding the correspondences done to NCTE 1. An email was sent to NCTE (cp@ncte-india.org, NCTE WRC -wrc@ncte-india.org) on 3rd July 2020. This email informed to NCTE that K. J. Somaiya Comprehensive College of Education, Training & Research is now renamed and is constituent of Somaiya Vidyavihar University, Mumbai. The following documents related to the constitution of Somaiya Vidyavihar University were attached with this mail. 1. Gazette of Maharashtra State about constitution of Somaiya Vidyavihar University 2.

UGC Approval Letter for Somaiya Vidyavihar University, 3. Resolution of Somaiya Vidyavihar Management to include K J Somaiya College of Education in the newly constituted University This email had requested for a change the name of our institution in all the future correspondence and relevant documents. 2. UGC Team Visit-Sept 2021 The UGC team visited the Somaiya Vidyavihar University on 23rd and 24th September 2021. In this team there was also a member from NCTE. Post the UGC visit, Somaiya Vidyavihar University was given the 2f recognition certificate. 3. Visit to NCTE (Delhi)-2nd March 2022 On 2nd March 2022, Registrar of Somaiya Vidyavihar University. - Prof. N R Gilke had personally visited NCTE (Delhi). A letter was given to Regional Director WRC -NCTE (Ref No-KJSCED/2022/038, dated 02-03-2022). Along with this letter an affidavit for name change of the college (dated 28th Feb, 2022) was given to NCTE requesting name change. 4. Email and Hard copies of relevant documents sent to WRC-NCTE on 15th Feb, 2024 An email was send by the Registrar of Somaiya Vidyvihar University to wrc@ncte-india.org on 15th Feb, 2024 with subject:- Change of name of K. J. Somaiya Comprehensive College of Education, Training and Research. The hard copies of the relevant documents were also send by speed post 5. Email to WRC-NCTE sent on 26th Dec, 2024 An email was send to wrc@ncte-india.org on 26th Dec, 2024 with subject:- Change of name of K. J. Somaiya Comprehensive College of Education, Training and Research. 6. Email to WRC-NCTE sent on 7th March, 2025 along with Hard copies of all relevant Documentations send via post An email was send to wrc@ncteindia.org on 7th March, 2025 with subject:- Change of name of K. J. Somaiya Comprehensive College of Education, Training and Research. We also send the letter and all relevant documents to WRC- NCTE letter send to Delhi on 06-03-2025 by blue dart courier. The letter was received by NCTE on 10-03-2025 time -10:30 am. Final Submission We reiterate that the non-submission of PAR was solely due to technical limitations caused by the out-dated listing of our institution on the NCTE portal. We in good faith request WRC-NCTE to consider our longstanding compliance, proactive communication, and accredited status, and accept our appeal regarding withdrawal of recognition of M.Ed program We have already submitted the hard copies of filled PAR of 2021-22 and 2022-23 to NCTE and also for 2023-24 and 2024-25 as advance copies."

III. OUTCOME OF THE CASE: -

The Appeal Committee in its 8th Meeting, 2025 held online on 3rd July 2025 took up this Appeal and perused the Appeal Report, documents available on the records and heard oral arguments advanced during the Meeting.

The Appeal Committee noted that the appellant institution had been granted recognition for M.Ed. course. Subsequently, the recognition was withdrawn by the Western Regional Committee (WRC) on the ground of non-submission of reply to the Show Cause Notice and/or non-filing of the Performance Appraisal Report (PAR) for the academic years 2021–2022 and/or 2022–2023 vide order dated 21.05.2025. It was further noted that, as per the Public Notice issued, the last date for submission of the PAR was initially fixed as 10.11.2024, which was later extended up to 31.12.2024.

The Committee observed that, in terms of Section 12(k) of the NCTE Act, 1993, the decision of the General Body of the Council in its 61st Meeting held on 05.08.2024, and subsequent Public Notices, the submission of the Performance Appraisal Report (PAR) is a mandatory and time-bound compliance obligation for all recognized Teacher Education Institutions (TEIs). The PAR process necessarily includes not only the online submission of institutional information but also the successful payment of the prescribed fee, which forms an integral part of the process. In order to make all the TEI's aware regarding submission of PAR widespread publicity was given by various methods.

The Committee further noted the deliberations and resolution adopted by the General Body of NCTE in its 67th (Emergent) Meeting held on 28th July 2025, which is reproduced below in extenso:

"Decision of the Council:

In view of the above, the Council discussed and deliberated the agenda in detail and decided as under:

- 1. The council was informed that the Hon'ble Delhi High Court, in W.P. (C) No. 8569/2025 titled Seth Moti Lal Teachers Education College & Anr. And other connected matters, had posed a query to the NCTE regarding whether the re-opening of the portal for submission of PAR was possible. In response, the proposal was placed before the council for deliberations and discussions.
- 2. In view of the observations of the Hon'ble High Court of Delhi, the General Body of the Council resolved to adopt, for its consideration and final approval, a strictly one-time, non-precedent-setting, and time-bound resolution, without leaving any scope for future reliance.
- In view of the commencement of the academic session from 01.08.2025, the TEIs that have not pursued any remedial measures against the withdrawal order passed by the respective Regional Committees under Section 17 of the NCTE Act, 1993 are deemed to be non-serious and/or fence-sitters. Accordingly, a cut-off date of 28.07.2025 has been rationally determined by the Council as a necessary administrative threshold to maintain academic discipline and institutional accountability. In the light of the same, only the following categories of TEIs will be eligible to avail the benefit of reopening of the PAR portal:
 - a) Those who have filed a Writ Petition before the Hob'ble Delhi High Court prior to the cut-off date of 28.07.2025; and
 - b) Those who have filed an appeal before the NCTE, Appeal Committee prior to the cut-off date of 28.07.2025.
- 4. The concerned TEIs shall be allowed to submit the PAR upon the reopening of the PAR Portal, subject to the payment of a processing fee of Rs. 25,000/- along with applicable GST and other statutory charges, per academic session.
- 5. In view of the foregoing discussion, all derecognition orders issued by the respective Regional Committee (s) shall stand withdrawn, subject to the condition that the concerned TEIs submit an undertaking to apply afresh and resubmit a duly filled PAR upon the reopening of the PAR Portal.
- 6. The PAR Portal shall be re-opened for a period of approximately three (3) weeks. A standard operating procedure (SOP) for the same shall be formulated.
- 7. To ensure smooth and effective implementation of the proposed mechanism, a dedicated Nodal Officer shall be appointed. The Nodal Officer shall be responsible to:

- 1. Oversee and supervise the re-opening of the PAR portal;
- 2. Serve as the single point of contact for all communications with the eligible TEIs; and
- 3. Address any queries, grievances, and technical or logistical issues that may arise during the implementation process.

The name and official contact details of the Nodal Officer shall be notified separately through a Public Notice issued on the NCTE website."

In view of the above resolution, the Committee observed that the appellant institution, having not filed the PAR within the stipulated timelines, was deficient on this ground. However, in light of the decision of the General Body taken in its 67th (Emergent) Meeting on 28.07.2025 which permits reopening of the PAR portal for those institutions that had filed appeal before the Appeal Committee prior to the cut-off date of 28.07.2025, and the undertaking submitted by the appellant institution to apply afresh and resubmit a duly filled PAR upon the re-opening of the PAR Portal, as well as the confirmation that no court case has been filed by the institution, the Committee concluded that the appellant institution falls within the eligible category.

The Committee also took note of the judicial pronouncements of the Hon'ble Delhi High Court, including Rambha College of Education v. NCTE [W.P. (C) 3231/2016, judgment dated 23.02.2017], as well as orders dated 08.04.2021 in W.P. (C) 4382/2021 and 30.07.2021 in W.P. (C) 7260/2021, which mandate that subsequent documents submitted in the appeal must be considered.

Appeal Committee further noted that the Hon'ble High Court of Delhi vide order dated 08.04.2021, passed in W.P. (C) 4382/2021 has observed as follows: -

"Appellate Committee of NCTE, is directed to ensure that, whenever an order of remand is passed, the status of the impugned is clearly spelt out so that the institution is not compelled to approach the Court in this manner."

Appeal Committee noted that the Hon'ble High Court of Delhi vide order dated 30.07.2021, passed in W.P. (C) 7260/2021 has observed as follows: -

"Although the Appellate Committee of the NCTE would be well advised to expressly quash the original order of the concerned Regional Committee while remanding the matter, the position in law is that the order automatically stands quashed. The institution is, therefore, entitled to the benefits of recognition until a fresh withdrawal order is passed."

Noting the submission and verbal arguments advanced during the hearing, and in view of the above observations and guided by the resolution of the General Body of NCTE in its 67th (Emergent) Meeting held on 28.07.2025, the Appeal Committee has decided to remand the case to the Western Regional Committee (WRC) with a direction to ensure compliance as mandated therein. The appellant institution shall be permitted to apply afresh and resubmit a duly filled PAR upon reopening of the PAR Portal in accordance with the prescribed Standard Operating Procedure, and the Regional Committee shall thereafter take a reasoned decision in conformity with the provisions of the NCTE Act, 1993, the NCTE Regulations, 2014, and guidelines issued from time to time. The appellant institution is further directed to forward to the Regional Committee, within fifteen (15) days of receipt of this order, the documents submitted along with the appeal, whereupon the Regional Committee shall take further necessary action strictly in accordance with law and in light of the directions contained herein.

IV. DECISION: -

After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to set aside the impugned order dated 21.05.2025 and remand back the case to Western Regional Committee (WRC) for fresh consideration in accordance with the directions specified hereinabove. The appellant institution is also directed to forward the documents submitted in appeal to the WRC within 15 days of receipt of this order for necessary action.

Final Submission We reiterate that the non-submission of PAR was solely due to technical limitations caused by the out-dated listing of our institution on the NCTE portal. We in good faith request WRC-NCTE to consider our longstanding compliance, proactive communication, and accredited status, and accept our appeal regarding withdrawal of recognition of B.Ed program We have already submitted the hard copies of filled PAR of 2021-22 and 2022-23 to NCTE and also for 2023-24 and 2024-25 as advance copies."

III. OUTCOME OF THE CASE: -

The Appeal Committee in its 8th Meeting, 2025 held online on 3rd July 2025 took up this Appeal and perused the Appeal Report, documents available on the records and heard oral arguments advanced during the Meeting.

The Appeal Committee noted that the appellant institution had been granted recognition for B.Ed. course. Subsequently, the recognition was withdrawn by the Western Regional Committee (WRC) on the ground of non-submission of reply to the Show Cause Notice and/or non-filing of the Performance Appraisal Report (PAR) for the academic years 2021–2022 and/or 2022–2023 vide order dated 21.05.2025. It was further noted that, as per the Public Notice issued, the last date for submission of the PAR was initially fixed as 10.11.2024, which was later extended up to 31.12.2024.

The Committee observed that, in terms of Section 12(k) of the NCTE Act, 1993, the decision of the General Body of the Council in its 61st Meeting held on 05.08.2024, and subsequent Public Notices, the submission of the Performance Appraisal Report (PAR) is a mandatory and time-bound compliance obligation for all recognized Teacher Education Institutions (TEIs). The PAR process necessarily includes not only the online submission of institutional information but also the successful payment of the prescribed fee, which forms an integral part of the process. In order to make all the TEI's aware regarding submission of PAR widespread publicity was given by various methods.

The Committee further noted the deliberations and resolution adopted by the General Body of NCTE in its 67th (Emergent) Meeting held on 28th July 2025, which is reproduced below in extenso:

"Decision of the Council:

In view of the above, the Council discussed and deliberated the agenda in detail and decided as under:

- 1. The council was informed that the Hon'ble Delhi High Court, in W.P. (C) No. 8569/2025 titled Seth Moti Lal Teachers Education College & Anr. And other connected matters, had posed a query to the NCTE regarding whether the re-opening of the portal for submission of PAR was possible. In response, the proposal was placed before the council for deliberations and discussions.
- 2. In view of the observations of the Hon'ble High Court of Delhi, the General Body of the Council resolved to adopt, for its consideration and final approval, a strictly one-time, non-precedent-setting, and time-bound resolution, without leaving any scope for future reliance.
- 3. In view of the commencement of the academic session from 01.08.2025, the TEIs that have not pursued any remedial measures against the withdrawal order passed by the respective Regional Committees under Section 17 of the NCTE Act, 1993 are deemed to be non-serious and/or fence-sitters. Accordingly, a cut-off date of 28.07.2025 has been rationally determined by the Council as a necessary administrative threshold to maintain academic discipline and institutional accountability. In the light of the same, only the following categories of TEIs will be eligible to avail the benefit of reopening of the PAR portal:
 - a) Those who have filed a Writ Petition before the Hob'ble Delhi High Court prior to the cut-off date of 28.07.2025; and
 - b) Those who have filed an appeal before the NCTE, Appeal Committee prior to the cut-off date of 28.07.2025.
- 4. The concerned TEIs shall be allowed to submit the PAR upon the reopening of the PAR Portal, subject to the payment of a processing fee of Rs. 25,000/- along with applicable GST and other statutory charges, per academic session.
- 5. In view of the foregoing discussion, all derecognition orders issued by the respective Regional Committee (s) shall stand withdrawn, subject to the condition that the concerned TEIs submit an undertaking to apply afresh and resubmit a duly filled PAR upon the reopening of the PAR Portal.
- 6. The PAR Portal shall be re-opened for a period of approximately three (3) weeks. A standard operating procedure (SOP) for the same shall be formulated.
- 7. To ensure smooth and effective implementation of the proposed mechanism, a dedicated Nodal Officer shall be appointed. The Nodal Officer shall be responsible to:

- 1. Oversee and supervise the re-opening of the PAR portal;
- 2. Serve as the single point of contact for all communications with the eligible TEIs; and
- 3. Address any queries, grievances, and technical or logistical issues that may arise during the implementation process.

The name and official contact details of the Nodal Officer shall be notified separately through a Public Notice issued on the NCTE website."

In view of the above resolution, the Committee observed that the appellant institution, having not filed the PAR within the stipulated timelines, was deficient on this ground. However, in light of the decision of the General Body taken in its 67th (Emergent) Meeting on 28.07.2025 which permits reopening of the PAR portal for those institutions that had filed appeal before the Appeal Committee prior to the cut-off date of 28.07.2025, and the undertaking submitted by the appellant institution to apply afresh and resubmit a duly filled PAR upon the re-opening of the PAR Portal, as well as the confirmation that no court case has been filed by the institution, the Committee concluded that the appellant institution falls within the eligible category.

The Committee also took note of the judicial pronouncements of the Hon'ble Delhi High Court, including Rambha College of Education v. NCTE [W.P. (C) 3231/2016, judgment dated 23.02.2017], as well as orders dated 08.04.2021 in W.P. (C) 4382/2021 and 30.07.2021 in W.P. (C) 7260/2021, which mandate that subsequent documents submitted in the appeal must be considered.

Appeal Committee further noted that the Hon'ble High Court of Delhi vide order dated 08.04.2021, passed in W.P. (C) 4382/2021 has observed as follows: -

"Appellate Committee of NCTE, is directed to ensure that, whenever an order of remand is passed, the status of the impugned is clearly spelt out so that the institution is not compelled to approach the Court in this manner."

Appeal Committee noted that the Hon'ble High Court of Delhi vide order dated 30.07.2021, passed in W.P. (C) 7260/2021 has observed as follows: -

"Although the Appellate Committee of the NCTE would be well advised to expressly quash the original order of the concerned Regional Committee while remanding the matter, the position in law is that the order automatically stands quashed. The institution is, therefore, entitled to the benefits of recognition until a fresh withdrawal order is passed."

Noting the submission and verbal arguments advanced during the hearing, and in view of the above observations and guided by the resolution of the General Body of NCTE in its 67th (Emergent) Meeting held on 28.07.2025, the Appeal Committee has decided to remand the case to the Western Regional Committee (WRC) with a direction to ensure compliance as mandated therein. The appellant institution shall be permitted to apply afresh and resubmit a duly filled PAR upon reopening of the PAR Portal in accordance with the prescribed Standard Operating Procedure, and the Regional Committee shall thereafter take a reasoned decision in conformity with the provisions of the NCTE Act, 1993, the NCTE Regulations, 2014, and guidelines issued from time to time. The appellant institution is further directed to forward to the Regional Committee, within fifteen (15) days of receipt of this order, the documents submitted along with the appeal, whereupon the Regional Committee shall take further necessary action strictly in accordance with law and in light of the directions contained herein.

IV. <u>DECISION</u>: -

After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to set aside the impugned order dated 21.05.2025 and remand back the case to Western Regional Committee (WRC) for fresh consideration in accordance with the directions specified hereinabove. The appellant institution is also directed to forward the documents submitted in appeal to the WRC within 15 days of receipt of this order for necessary action.
