## PUBLIC NOTICE

The National Council for Teacher Education (NCTE) is a statutory body established under Section 3 of the NCTE Act, 1993, with the mandate to achieve planned and coordinated development of the teacher education system across the country and to determine and maintain standards for teacher education.

- 2. In exercise of its statutory functions under Sections 12(j) and 12(k) of the NCTE Act, 1993, the NCTE issued a Public Notice dated 09.09.2024 directing all recognized Teacher Education Institutions (TEIs) to submit their Performance Appraisal Reports (PARs) for the academic sessions 2021-2022 and 2022-2023. The last date for submission was initially notified as 10.11.2024 (11:59 PM) which was subsequently extended on two occasions vide Public Notice(s) dated 07.11.2024 and 10.12.2024 with the final timeline being 31.12.2024 (11:59 PM).
- 3. Despite extensive awareness and outreach initiatives undertaken by the NCTE, several TEIs did not participate effectively in the PAR exercise. Consequently, Show Cause Notices were also issued to such institutions by the respective Regional Committee(s) of NCTE.
- 4. Thereafter, the respective Regional Committee(s), in exercise of their powers under Section 17 of the NCTE Act, 1993, proceeded to withdraw the recognition of various TEIs *vide* orders citing non-compliance with the requirement concerning submission of PAR.
- 5. These withdrawal orders have been challenged by various TEIs before the Hon'ble High Court of Andhra Pradesh and the Hon'ble Court *vide* an interim order dated 30.07.2025 in W.P.(C) No. 19578/2025 titled H.M.K.S & M.G.S.M College of Education (M.Ed) Vs National Council for Teacher Education & Anr. has directed the respondents to permit the Petitioner institution to take up the admission for the academic session 2025-2026.

"Having regard to the facts and circumstances of the case, 4th respondent is directed to permit the Petitioner-Institution to participate in the online counselling for admission into Master of Education (M.Ed) Course for the Academic Year 2025-26, without reference to the Order 'impugned withdrawal order....."

Further in W.P.(C) No. 21184/2025 titled Sri Sudha College of Education Vs National Council for Teacher Education & Anr., the Hon'ble Court Andhra Pradesh held as follow:

"Having regard to the facts and circumstances of the case, 4th respondent is directed to permit the Petitioner-Institution to participate in the APEDCET-2025 counselling for the academic year 2025-26 without reference to the impugned withdrawal order vide File No. NCTE/2025/SRC/PAR/ORDER/SRCAPP-14108, dated 22.05.2025"
