PUBLIC NOTICE

The National Council for Teacher Education (NCTE) is a statutory body established under Section 3 of the NCTE Act, 1993, with the mandate to achieve planned and coordinated development of the teacher education system across the country and to determine and maintain standards for teacher education.

2. In exercise of its statutory functions under Sections 12(j) and 12(k) of the NCTE Act, 1993, the NCTE issued a Public Notice dated 09.09.2024 directing all recognized Teacher Education Institutions (TEIs) to submit their Performance Appraisal Reports (PARs) for the academic sessions 2021-2022 and 2022-2023. The last date for submission was initially notified as 10.11.2024 (11:59 PM) which was subsequently extended on two occasions vide Public Notice(s) dated 07.11.2024 and 10.12.2024 with the final timeline being 31.12.2024 (11:59 PM).

3. Despite extensive awareness and outreach initiatives undertaken by the NCTE, several TEIs did not participate effectively in the PAR exercise. Consequently, Show Cause Notices were also issued to such institutions by the respective Regional Committee(s) of NCTE.

4. Thereafter, the respective Regional Committee(s), in exercise of their powers under Section 17 of the NCTE Act, 1993, proceeded to withdraw the recognition of various TEIs *vide* orders citing non-compliance with the requirement concerning submission of PAR.

5. Some of these withdrawal orders have been challenged by various TEI's before the Hon'ble High Court of Andhra Pradesh and the Hon'ble Court *vide* an interim order dated 21.07.2025 and 19.08.2025 in W.P.(C) No. 18500/2025, **Dr. CSN College of Education (D.El.Ed) v. National Council of Teacher Education & ors.**; W.P.(C) No. 14718/2025, **DRK Reddy College of Physical Education (D.P.Ed) v. National Council of Teacher Education & ors.**; W.P.(C) No. 14719/2025; **DRK Reddy College of Physical Education (B.P.Ed) v. National Council of Teacher Education & ors.** passed an interim suspension of impugned Withdrawal Order.

6. Pursuant to the above matters, the Hon'ble High Court of Andhra Pradesh, while staying the operation of the impugned withdrawal orders, till the next date of hearing, has also

permitted the Petitioner institutions to participate in counselling and admit students for the academic session 2025-2026.

7. Further, in W.P.(C) No. 18500/2025 titled **Dr. CSN College of Education (D.El.Ed) v. National Council of Teacher Education & ors.**; the Hon'ble High Court on 19.08.2025, the Court further passed an interim order, directing the NCTE as under:

"Having perused the aforesaid decision and in view of the fact that Writ Petitioner was permitted to participate in the APDEECET-2025 counseling for the Academic Year 2025-26, there shall be interim suspension of impugned Withdrawal Order File No.NCTE/2025/SRC/PAR/ ORDER/SRCAPP3374/150672, dated 19.05.2025 for the Academic Year 2025-2026."

8. Further, in W.P.(C) No. 14718/2025, **DRK Reddy College of Physical Education (D.P.Ed) v. National Council of Teacher Education & ors.**; the Hon'ble High Court on 19.08.2025, the Court further passed an interim order, directing the NCTE as under:

"Having perused the aforesaid decision and in view of the fact that Writ Petitioner was permitted to participate in the counseling for admission into Diploma in Physical Education Courses for the Academic Year 2025-26, there shall be interim suspension of impugned Withdrawal Order File No. NCTE/2025/ SRC/PAR/ ORDER/SRCAPP-2430, dated 19.05.2025 for the Academic Year 2025-2026."

9. Further, in W.P.(C) No. 14719/2025; **DRK Reddy College of Physical Education (B.P.Ed) v. National Council of Teacher Education & ors.**; the Hon'ble High Court on 19.08.2025, the Court further passed an interim order, directing the NCTE as under:

"Having perused the aforesaid decision and in view of the fact that Writ Petitioner-institution was permitted to participate in the counseling for admission into Bachelor of Physical Education course for the Academic Year 2025-26, there shall be interim suspension of impugned Withdrawal Order File No.NCTE/2025/SRC/PAR/ORDER/SRCAPP-544, dated 19.05.2025 for the Academic Year 2025-2026."

10. In compliance with the aforesaid directions of the Hon'ble High Court of Andhra Pradesh, a list of the following TEIs whose withdrawal orders have been suspended by the Hon'ble High Court of Andhra Pradesh, till the next date of hearing, and who have been permitted to participate in the counselling process and admit students for the academic session 2025-2026 is hereby uploaded on the website of the Regional Committee for information of all concerned:
