## PUBLIC NOTICE

The National Council for Teacher Education (NCTE) is a statutory body established under Section 3 of the NCTE Act, 1993, with the mandate to achieve planned and coordinated development of the teacher education system across the country and to determine and maintain standards for teacher education.

- 2. In exercise of its statutory functions under Sections 12(j) and 12(k) of the NCTE Act, 1993, the NCTE issued a Public Notice dated 09.09.2024 directing all recognized Teacher Education Institutions (TEIs) to submit their Performance Appraisal Reports (PARs) for the academic sessions 2021-2022 and 2022-2023. The last date for submission was initially notified as 10.11.2024 (11:59 PM) which was subsequently extended on two occasions vide Public Notice(s) dated 07.11.2024 and 10.12.2024 with the final timeline being 31.12.2024 (11:59 PM).
- 3. Despite extensive awareness and outreach initiatives undertaken by the NCTE, several TEIs did not participate effectively in the PAR exercise. Consequently, Show Cause Notices were also issued to such institutions by the respective Regional Committee(s) of NCTE.
- 4. Thereafter, the respective Regional Committee(s), in exercise of their powers under Section 17 of the NCTE Act, 1993, proceeded to withdraw the recognition of various TEIs *vide* orders citing non-compliance with the requirement concerning submission of PAR.
- 5. These withdrawal orders have been challenged by various TEIs before the Hon'ble High Court of Karnataka and the Hon'ble Court vide an interim order dated 16.07.2025 in W.P.(C) No. 17488/2025, titled Global Institute of Advanced Study in Education v. National Council for Teacher Education & ors.; in W.P.(C) No. 17711/2025 titled Sri Bharthi B.Ed College v. National Council for Teacher Education & ors. held as:

In W.P.(C) No. 17488/2025, titled Global Institute of Advanced Study in Education v. National Council for Teacher Education & ors. the Hon'ble Court of Andhra Pradesh held as follows:

Further in W.P.(C) No. 17711/2025 titled Sri Bharthi B.Ed College v. National Council for Teacher Education & ors. the Hon'ble Court of Andhra Pradesh held as follows:

"Having regard to the facts and circumstances of the case, 4th respondent is directed to permit the petitioner-institution to participate in the APEDCET-2025 counselling for the academic year 2025-26, without reference to the impugned Withdrawal Order vide File No.NCTE/2025/SRC/PAR/ORDER/SRCAPP3314, dated 19.05.2025."
