- All land related documents were not verified either they were not available with them or they were in Assamese language
- 2. In the library, no books were available related to pedagogy.
- 3. Only ICT laboratories were shown in the application form.
- 4. Authorized person was from Department of English and not from Department of Education.
- 5. Ramp facility was available till ground floor only. Classes, laboratories, library halls etc. were also on first and second floor and there were no provision for physically challenged to approach to those floors as ramp or lift facility were not available till those floors.
- 6. They had demanded for 24 units of ITEP but the computer labs has maximum accommodability of 30 students at a time. in all they said they are having 116 working computers in their whole college against 1200 students of ITEP which they have asked for.
- 7. Multipurpose hall has less area only 700 sqft and sitting capacity of only 90 students in the multipurpose hall which they have shown in the application. although one more multipurpose hall they have also shown which was under renovation

- 8. Psychology lab was not having aby paper pencil test, psychological tools and tests
- 9. The library was having sufficient number of books in the library but no Educational Encylopedia, Educational Research Journal of any Pedagogy books were available.

- 3. The authorized person differed from the application.
- 4. No language lab was available.
- 5. No Art and craft room available
- 6. Common rooms were there with lack of facilities.
- 7. The constructed building of the institute is completely different from the map provided by the institute.
- 8. The institute has only 06 classrooms available for the proposed course which is not as per the standard
- 9. Toilet for physically challenged is not available.
- 10. Construction is not complete on the site.
- 11. As per the institution's application, both the posts of college principal and committee secretary are held by the same person (PAUKHENTHANG TOMBING), which does not seem to be right as per the rules. 12. The submitted drawing and the structure on the site do not match.
- 13. Construction is not complete on the site.
- 14. Required infrastructure for the course is not available.
- 15. The building is not barrier free.
- 16. Toilet for physically challenged is not available.
- 17. The fire safety certificate is not up to date.
