After carefully observing the online application form, VT report along with other related documents, the ERC found the following deficiencies:


1. Education encyclopedia and electronic publication are not available.
2. Humanities stream laboratories (Geographical lab) is not available.
3. Activity cum resource center is not available.
4. Common room is not available.
5. There is no availability of adequate furniture.
6. There is no availability of developed kitchen garden.
7. Rain Water Harvesting System is not available.
8. ICT lab and language lab are not separated.
9. The psychology lab must be equipped with test and instruments accordingly, that were not available.
10. Toilet facilities must be improved.
11. Physically challenged people's facilities are required. Ramp need to be established to get access for the first, second, and third floor..

Hence, the committee decided that the show cause notice be issued to the institution to submit the reply on the deficiencies mentioned above within 07 days from the date of issue of the show cause notice.

After carefully observing the online application form, VT report along with other related documents, the ERC found the following deficiencies:

1. The total built up area and land area are lesser than what is required under NCTE Regulations.
2. The total built up area as mentioned in the Building Completion Certificate is only 1214.12 Sqm. which is lesser than the requirement as per NCTE Regulations.
3. The institution has only four classrooms for the proposed 8 units of ITEP programme.
4. The institution has applied for 8 units of all categories. The institution did not present the demarcation for each category.

Hence, the committee decided that the show cause notice be issued to the institution to submit the reply on the deficiencies mentioned above within 07 days from the date of issue of the show cause notice.
