

1. As per decision of ERC, Inspection was made.

**After carefully observing the online application form, VT report along with other related documents, the ERC found the following:**

1. The institution has failed to produce valid and original documents related to the land title at the time of inspection.
2. Registrar of the institute SHAUVIK ROY CHOWDHURY was not present at the time of inspection therefore it was not possible to verify the information.
3. The address mentioned in the document of the trust running the institution and the address given by the institution in the online application are different.
4. At the time of the inspection, the institution did not have any educational encyclopedias or educational journals available.
5. The Non-Encumbrance Certificate of the institution is dated 06/06/2012 which is very old and hence cannot be accepted.
6. The building plan of the institute and the constructed building are completely different and are not as per the NCTE standards.
7. During the inspection, the institution presented the Education Building for inspection. The following room numbers were designated for the existing B.Ed. course and the proposed

ITEP program: rooms 101, 102, 107, 106, and 104 on the first floor; rooms 208 and 210 on the second floor; and rooms 303, 302, 301, 312, 311, 310, 308, and 309 on the third floor. Room number 002 was shown on the ground floor. It was found that only rooms 101, 102, 107, 208, and 002 had an area of approximately 500 square feet. The area of all other rooms was found to be approximately 300 to 350 square feet.

8. The institute's Fire Safety Certificate Issuing date is 23/02/2018 and the institute does not have the latest Fire Safety Certificate and adequate resources.
9. The institution could only present bills for the purchase of 515 books, which is significantly less than the standard set by the NCTE.
10. The psychology laboratory has only 13 paper-pencil tests and 40 pieces of apparatus, which is significantly below the prescribed standards.

**Hence, the committee decided that the show cause notice be issued to the institution to submit the reply on the deficiencies mentioned above within 07 days from the date of issue of the show cause notice.**

**Decision of ERC:**

The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, SOP, representation dated 12.08.2025 and guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following:


1. The recognition of the institution for offering B.Ed course was granted on **28.02.2008** and at the time of applying of the application, Shri Chittaranjan Mahato was the President of the Society.
2. On request of the Shri *Dharani Dhar Pati*, the record of the details were altered vide NCTE letter dated 29.07.2024.

3. A letter dated nil received in the ERC on 09.04.2025 submitted by the Sri Chittaranjan Mahato, had requested that he was the Bonafide president of the society till today and that to this effect he had submitted an affidavit of Rs. 100/- countersigned by Judicial Magistrate First class, First Court Raghunathpur Court Purlia , West Bengal alongwith with copy of the FIRs against the person namely; Dharinder Pati and others.

4. The above mentioned matter was placed before 364<sup>th</sup> meeting of ERC held on 30<sup>th</sup> April, 2025 and the committee decided to forward the documents submitted by Sri Chittaranjan Mahato to the affiliating body for verification of the documents and to submit the report. Accordingly, a letter dated 08.05.2025 was issued to the affiliating body for verification of the documents and to submit the report.

5. A mail dated 17.06.2025 has been received from the Assistant Registrar, Baba Saheb Ambedkar Education University, West Bengal wherein the university has stated that

*"Sir, this has reference to letter No. NC TE-Regl011/560/2024-Regulation Section-APE00787/6981, dated 23/07/2024 by NCTE. As per this letter, the mail ID was changed to Dharanidharpatri@dnsrc.org. The Contact No. was also changed accordingly. In their application for renewal of affiliation in 2024, it was found that one Dharani Dhar Pati has been named as the Contact Person of the College by a Governing Body where Chittaranjan Mahato was the President. So, Chittaranjan Mahato is the President of Deben Mahato Teacher Training Institute. The application for renewal of affiliation for 2025 (which is kept on hold because of two cases in the High Court at Calcutta being Nos. W.P.A. No. 27485 of 2024 & W.P.A. No.22624 of 2022). The name of this Dharani Dhar Pati comes up as President supported by a resolution passed by a new set of members, none of whom were in the Governing Body of 2024. In view of the cases pending before the Hon'ble High Court at Calcutta, the University is not in a position to make any comment or change in this matter whatsoever without direction of the Hon'ble High Court."*

6. In view of the above, a self contained representation along with the status of the court cases in connection with W.P.A. No. 27485 of 2024, W.P.A. No.22624 of 2022 and other cases, was sought from the institution.

7. The institution has submitted a self-contained representation dated 12.08.2025.

In view of the above, the Committee concluded the following:

8. The details of website address, E-mail address, contact no. are crucial/sensitive for any institution as NCTE make correspondences on the email in case of Show Cause Notices. Inspection of the institution under NCTE Act-1993, complaints, direction received from the Ministry of Education, etc.

9. The University from which the institution is affiliated with is not in a position to make any comment or change in this matter whatsoever without direction of the Hon'ble High Court.

**In view of the above and the fact that the matter is sub-judice, the Committee decided to maintain *status quo* till the outcome of the court case(s).**

- Joygopalpur Gram Vikash Kendra, Plot No. 925, Vill.- Joygopalpur Natunhat, Tehsil/Taluka-Joygopalpur, Town/City-Basanti, Dist.- South 24 Parganas, West Bengal-743312 had applied for grant of recognition/permission to South Sundarban Institute of Higher Education, Plot No.- 925, Land Title-Bastu College,Village-Joygopalpur, Post Office-Joygopalpur Natun Hat, Tehsil/Taluka-Joygopalpur, Town/City-Basanti, District-South 24 Parganas, State-West Bengal, Pin Code- 743312 for conducting B.Ed. Course.
- The recognition was granted to the institution on 23.02.2021 and a copy of the order was also endorsed to the Secretary, Joygopalpur Gram Vikash Kendra, Plot No. 925, Vill.- Joygopalpur Natunhat, Tehsil/Taluka-Joygopalpur, Town/City-Basanti, Dist.- South 24 Parganas, West Bengal-743312.

Biswajait Mahakur, Secretary, Joygopalpur Gram Vikash Kendra, Plot No. 925, Vill.- Joygopalpur Natunhat, Tehsil/Taluka-Joygopalpur, Town/City-Basanti, Dist.- South 24 Parganas, West Bengal-743312. Further, the shifting of the premises was also allowed on request of Sh. Biswajait Mahakur from old address to village- Narayanpur, P.O. Nilganj Hat, Distt. North 24 PGS, W.B – 700121. The copy of the shifting was also endorsed to the Joygopalpur Gram Vikash Kendra.
- Now, O/o ERC is in receipt of an application dated 23.05.2025 from Ms. Maria Adhikary, President of South Sundarban Institute of Higher Education, Shri Saurav Mondol, Secretary, South Sundarban Institute of Higher Education and others regarding changing and /or correcting the existing email ID, mobile number and the website of the institution.
- Perusal of the application dated 23.05.2025 reveal that Ms. Maria Adhikary and Shri Saurav Mondol are President and Secretary respectively of the trust namely 'South Sundarban Institute of Higher Education', whereas the original application requesting for recognition was made by the trust namely 'Joygopalpur Gram Vikash Kendra'. Moreover, there is no mention about Joygopalpur Gram Vikash Kendra in the application dated 23.05.2025.


**In view of the above, the Committee decided not to alter the details of the institution in respect of the existing email ID, mobile number and the website of the institution.**
