Decision of ERC


The online file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, Appeal Order passed by the NCTE-HQ, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- The recognition was granted to the institution for B.A.B.Ed. (two units) and B.Sc.B.Ed. (two units) subject to condition that the institution shall appoint faculty as per ITEP Regulations, 2021 before completion of the time limit given for compliance of LoI.
- Show cause Notice was issued to the institution under section 17 of NCTE Act, 1993. The recognition of the institution was withdrawn on 10.04.2024 as reply of the institution was found not satisfactory.
- The institution had preferred an appeal before the Appeal Authority wherein the Appellate Authority has passed an order dated 18.07.2024 with a direction to verify the faculty list etc. submitted in appeal from the concerned affiliating University. The appellant institution has also been directed by the Appeal Committee to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the appeal and after receipt of the same the ERC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above. - 1 Rajiv Gandhi Central University applied for M.P.Ed. for one unit as per the information furnished by the institution during the inspection, but they have not shown proper documents related to the infrastructural facilities, the institution is advised to collect all the necessary documents, required for approval of the course. in instructional facilities.
- 2 They have limited Resources i.e. Library, ICT Lab, Psychology lab and language lab, they need to establish these facilities in the demarcated building, while the Labs related to Physical Education are well equipped, they are advised to establish and facilitate all the instructional facilities exclusively for the concerned course, i.e. BPED and MPED.
- 3 Classroom seating capacity they need to improve in the same building they are running B.P.Ed. course, the size of the said building need to get more space to open the PG course.
- 4 The Institution needs to establish Toilet facilities.
- 5 The institution is required to establish a departmental library. The institution is having only 3500 Books. More books i.e encyclopaedia and manual journals as per norms is required.
- 6 The institution is required to establish ICT lab.

Hence, the committee decided that the show cause notice be issued to the institution to submit the reply through the portal on the deficiencies mentioned above within 07 days from the date of issue of the show cause notice.
