

### **Decision of ERC**

The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, Court order, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- SCN was issued on 28.09.2020 to the institution as per direction of the NCTE Hq vide letter No. NCTE-CDN016(13)/18/2028-CDN-HQ dated 02.08.2018 due to the reason that the institution had not appointed teaching faculty as per Regulations 2014 amended from time to time. The institution did not submit reply to SCN dated 28.09.2020 and subsequently final show Cause notice was issued to the institution on 09.04.2022.
- Apart from above two complaints dated 09.08.2021 & 06.07.2021 against the institution, were received on 26.08.2021 & 15.07.2021 from Ms. Punam Kumari & Sh. Naresh Bhagat respectively.
- One of the complainants, namely; Ms. Punam Kumari further approached Hon'ble High Court of Patna in C.W.J.C No.10905/2023 wherein Hon'ble High Court has passed an order dated 28.03.2025 by directing :-

***3. Having heard learned counsel for the parties and after going through the prayer made in this application, this Court deems it fit, proper and in the interest of justice, to relegate the case of the petitioner before the Regional Director, Eastern Regional Committee, NCTC, New Delhi (respondent no.7) to consider the case of the petitioner in accordance with law.***

***4. In that view of the matter, the petitioner is directed to file a detailed representation along with all supporting documents before the Regional Director, Eastern Regional Committee, NCTC, New Delhi (respondent no.7) within a period of four weeks and the respondent no.7 shall dispose it in accordance with law after hearing all the concerned parties within a period of three months from the date of receipt of such representation.***

***5. With the direction aforesaid, this writ application stands disposed of."***

- *Representation dated 09.04.2025 was received in the office of ERC-NCTE from Punam Kumari.*
- In compliance of direction of Hon'ble High Court and in pursuance of decision of 363<sup>th</sup> meeting of Eastern Regional Committee held on 21.04.2025, a letter was issued on 07.05.2025 to the Tehsildar/Revenue Officer, Collectorate Building, Madhepura, Post-Madhepura, District-Madhepura, Bihar with a request to forward certified copy of land and building records i.e. Certified copy of land documents, non-encumbrance certificate, land use conversion certificate, building plan, Building Completion Certificate(BCC), Mutation Certificate and Building safety certificate to this office. It was also mentioned in the letter that if the institution does not have the said certificate, the same may be communicated to this office for appropriate decision to avoid the legal complication in the matter. However, the office of ERC-NCTE has not received any such information/communication from the concerned revenue office of the Bihar till date.
- Now contempt writ petition has been filed by the complainant namely, Ms. Punam Kumari which has been received in the office of ERC-NCTE on 23.09.2025.

**In view of the above and the fact that without the true facts regarding land and building certificates, the representation of the complainant cannot be decided by the Committee, the Committee decided that a letter be issued to the District Magistrate concerned with a copy to Sub Divisional Officer (land) and Circle Officer with a request to inform the status of the land and building records of the institution to this office so as to avoid any further legal complications in the matter. Counter affidavit against the Contempt Petition may also be filed stating *interalia* the above facts.**

**The remaining 26 agenda items were not taken up for consideration by the Committee due to some urgency.**

The meeting ended with vote of thanks to the Chair.
