Decision of WRC:

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- (i) The institution vide letter No. B.ED./2017-18/94 dated 05.10.2017 has requested to reduce its intake for B.Ed. course from existing 2 units (100 Students) to 1 unit (50 Students) as mentioned in WRC revised recognition order No.WRC/OAPW00555/113092/2015/140287-294 dated 31.05.2015.
- (ii) Further, the institution vide letter No.B.Ed.2023-24/131 dated 23.08.2023, 24.11.2023, 09.04.2025 and 04.06.2025 has requested for correction of name from Sharda Bhawan Society's College of Education to Shri Sharda Bhawan Education Society's, College of Education, Nanded.

In view of the above, the Committee decided that the request for change of name of institution and reduction of B.Ed. intake from two units to one unit is permitted.

Decision of WRC:

- (i) The institution filed an Appeal against the Withdrawal Order dated 13.08.2024 and Appeal Division has passed an Order vide No. /86-69/E-347926/2024 Appeal/13th Meeting, 2024/APPLWRC202414820/128217 dated 16.12.2024. Decision taken by Appeal Committee of the Council is as under:-
 - "... After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to set aside the implunged order dated 13.08.2024 and remand back the case to WRC with a direction to revisit the case in totality and also to check that the institution fulfil all the criteria of norms & standards for the land & building where the recognition was granted by the WRC as per applicable rules & regulations and decision shall be taken accordingly. The Appellant institution is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the WRC to take further necessary action as per the NCTE

- Regulation, 2014 guidelines and amendments issued from time to time as per direction given herein above."
- (ii) The institution has submitted lease deed registered on 21.12.2021 for a period of 33 years from Aditya Educational Foundation i.e. Private Party for Survey no.42, for which institution has submitted Building Plan and Building Completion Certificate. These land documents are not in accordance with the NCTE Regulation 2014.
- (iii) The institution has submitted a Building Plan approved by Sarpanch, Gram Panchayat, Tal. Haveli, Pune however, the same is NOT approved by the Govt. Competent Authority of State Govt. The address mentioned in the Building Plan does not match as per Revised Recognition Order dated 31.05.2015. Total land area and Built-up area in the Building Plan is less than required size as per NCTE Norms and Standards.
- (iv) The institution has submitted Building Plan and Building Completion Certificate for Survey no.42 whereas the initial recognition was granted by NCTE at Survey no.64. The institution has shifted to new premises/ building without prior approval of NCTE. It is observed that the institution has run B.Ed. course from the date of recognition dated 16.05.2008 on rented building mentioning survey no. 46 not 42 (As per lease agreement and required to apply for shifting of premises from rented building to own building within 3 years as per NCTE rules.
- (v) The institution submitted regional language and translated copy of Building Safety Certificate dated 10.01.2013 for Aditya Education Foundation, S.No. 42/1A/1 to 19/1 approved by Village Development Officer and Deputy Sarpach, Gram Panchayat Narhe. The address in the BSC doesn't match with address mentioned in Revised Recognition Order.
- (vi) The institution has submitted Building Completion Certificate in the name of Aditya Education foundation, S.No 42/1A/1 to 19/1 in regional language and translated copy dated 10.01.2013 signed by Village Development Officer and Deputy Sarpanch, Gram Panchayat Narhe (Local Competent Authority only). It is also required to approve by Govt. Competent Authority of State Govt. Building Completion Certificate is not in the prescribed format of NCTE. The address in the BCC doesn't match with the address mentioned in Revised Recognition Order.
- (vii) The institution has submitted regional language and translated copy of Non-Encumbrance Certificate dated 10.01.2013 for S.No. 42/1A/1 to 19/1 issued by Village Development Officer and Deputy Sarpanch, Gram Panchayat Narhe. It is NOT issued by the Govt. Competent Authority.
- (viii) The institution has submitted certificate dated 20.05.2021 for having sewage disposal system, barrier free environment and toilets also for physically challenged issued by Architect instead of Govt. Competent authority. The institution has not submitted Building Disabled Friendly Certificate.
- (ix) The institution has submitted staff list approved by the affiliating body for B.Ed. course but not shown the academic session therein. One faculty of Science stream is required to be appointed as per NCTE norms. The approval date of approving authority is not mentioned in the staff list.
- (x) The institution has submitted salary statement prepared by the institution and submitted letter addressed to Bank for release of payment for the month of December, 2023 to May, 2024 but

Bank Statement NOT submitted. However, it cannot be ascertained from the uploaded documents whether the institution is paying salary to its staff as per Central/State Government pay scales in accordance with the norms and standards of NCTE.

Show Cause Notice u/s 17 (1) of NCTE Act 1993 be issued to the institution with direction to submit reply along with requisite documents certified by the management supported with an affidavit within 15 days from the date of issue of notice.

Decision of WRC:

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

The institution did not submit compliance report regarding fulfillment of laid down conditions mentioned in the Revised Recognition Order dated 21.05.2015 pertaining to its existing premises wherein recognition for B.Ed. course was initially granted by NCTE followed by additional intake and revised order.

The Committee noted that prior to processing of application for shifting of premises dated 09.04.2025 received on 25.04.2025, the institution is required to submit compliance report regarding fulfillment of following conditions within 15 days from the date of issuance of letter:

- (i) The institution is required to submit latest original certified copy Land Documents of existing premises issued by Competent Authority of State Government.
- (ii) The institution is required to submit Mutation Certificate issued by Competent Authority of State Government.
- (iii) The institution is required to submit latest Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government indicating that the land is free from all encumbrances issued by Competent Government Authority.
- (iv) The institution is required to submit Land Use Certificate (CLU) mentioning name of the institution/society, all Khasra Nos./Plot No./Survey No., land area after conversion to use the land from agriculture to educational purpose issued by the Competent Government Authority.
- (v) The institution is required to submit latest original certified Building Plan approved by the Competent Authority of State Government indicating name of institution/society, Khasra/Plot/Survey No. and mentioning the total land area and total built-up area earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes including multi-disciplinary programmes, if any.
- (vi) The institution is required to submit latest Building Completion Certificate (BCC) in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.
- (vii) The institution is required to submit Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by

- Competent Government Authority.
- (viii) The institution is required to upload latest Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx
- (ix) The institution is required to submit latest Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- (x) The institution is required to submit latest/ current faculty list approved & signed on each page by concerned affiliating body in original for all recognized courses separately with the details of their teaching subject, date of birth, date of selection/appointment, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GoI dated 09.06.2017), salary structure and related documents duly attested by authorized representative of management along with copy of approval letter of affiliating body.
- (xi) The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty member.
- (xii) The institution is required to submit copies of valid Fixed Deposit Receipts issued by Nationalized/ Scheduled Bank towards Endowment Fund (Rs.5.00 lakh) & Reserve Fund (Rs.7.00 lakh) in the joint operation mode with Regional Director, WRC, NCTE and the Management along with duly filled Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014 for each recognized teacher education course separately.
- (xiii) The institution is required to submit detailed information regarding institutional website in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.

Decision of WRC:

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time the Committee observed as under:

Recognition was granted for B.Ed. course of one year duration with annual intake of 100 from the academic session 2008-2009 vide order dated 26.08.2008 followed by revised order dated 29.04.2015 for B.Ed. course of two years duration with annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the condition mentioned in the revised order before 31.10.2015.

In response, compliance report submitted by the institution vide letter dated 31.10.2015 received on 05.11.2015.

The matter was considered by NRC and Show Cause Notice under Section 17(1) was issued dated 12.04.2018 to the institution with direction to comply the deficiencies mentioned therein.

The verified complaint against the institution received through Complaint Division, NCTE HQrs. was considered by WRC in its 402nd meeting held on 27th March, 2024 and matter was forwarded to the affiliating body vide letter dated 06.04.2024. Complaint against institution was again received vide Complaint Division, NCTE letter dated 30.05.2024 followed by reminder dated 24.09.2024.

Matter was considered in 408th (Part-1) meeting of WRC held on 12th-14th November, 2024. Accordingly, point-wise reply on the allegations made in the complaint was sought from the institution and reminder issued to affiliating body, letter to DM, Sri Ganganagar vide WRC letters dated 20.12.2024. Reply was not submitted by the institution. Reply vide letter dated 08.07.2024 was submitted by affiliating body (received in WRC on 29.01.2025). Second reminder dated 18.02.2025 was received from complaint division, NCTE seeking action taken report on complaint matter.

The Committee considered all documents available in institution file in its 417th meeting held on 07th-10th April, 2025. Accordingly, Show Cause Notice u/s 17 was issued dated 16.05.2025 to the institution with direction to submit compliance regarding fulfillment of following deficiencies within 21 days:

- 1. The institution did not submit any reply in response to WRC letter dated 20.12.2024 seeking point wise reply on the allegations made in the complaint along with following documents and clarification thereon:
 - i. Copy of Registered Land Documents of the institution.
 - ii. Copy of the Certificate of Land Mutation of the institution.
 - iii. Copy of the Certificate of Land Use (CLU) of the institution.
 - iv. Copy of the Building Safety Certificate of the institution.
 - v. Copy of the Approved Building Plan issued by the competent Govt. Engineer.
 - vi. Copy of the Approved Building Completion Certificate issued by the competent Govt. Engineer.
 - vii. Copy of the Fire Safety Certificate issued by the competent Govt. Authority.
 - viii. Copy of the Letter issued by the competent Govt. Authority for Disability Friendly Certificate.
 - ix. Updated approved faculty list issued by the concerned university together with approval letter issued by the University as well as details of salary disbursed to the faculties for last 6 months.
- 2. Reminder be issued to District, Magistrate, Sri Ganganagar enclosing the copy of previous letter along with copy of complaint to submit reply within 15 days from the date of issue of letter.

Accordingly, reminder was issued to DM, Sri Ganganagar vide letter dated 16.05.2025 in continuation of previous letter dated 20.12.2024 and reply not received. The reply submitted by the institution vide letters dated 15.05.2025 and 06.06.2025 in response to WRC letter dated 20.04.2024 and SCN dated 16.05.2025 respectively has been examined by Committee and it is observed that the institution is still deficient on the following grounds of show cause notice u/S 17:

(i) Photocopy of Building Plan approved by Sahayak Abhiyanta, PWD, Sub-Division, Padampur, Rajasthan submitted by the institution has not been approved by local govt.

- authority and date not reflected therein.
- (ii) Photocopy of faculty list for the year 2024-25 submitted by the institution comprising 01 Principal +15 Lecturers, which is not in NCTE prescribed format and same is not approved by Registrar of Affiliating University. Faculties in Perspectives in Education and Pedagogy subjects as required under NCTE norms-Appendix-4 is not reflected in the faculty list/ have not been appointed.
- (iii) Letter of approval regarding selected/appointed faculties issued by Affiliating University as per laid down procedure/policy of Affiliating Body is not submitted.
- (iv) Details of salary disbursed to the faculties for last 6 months is not submitted.
- (v) Duly filled in Form 'A' in original issued by authorised signatory of concerned bank towards maintaining of Joint FDRs towards Endowment and Reserve Fund as per provision of NCTE Regulations is not submitted.
- (vi) Submitted copy of Building Completion Certificate is not approved by competent Govt. Authority and date of approval of BCC is not reflected therein.
- (vii) Fire Safety Certificate issued by designated Fire Safety Department of Government of Rajasthan is not submitted.
- (viii) The institution has not submitted Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- (ix) Downloaded copies of documents from the institutional website with hyperlink of the same in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time is not submitted.

In view of the above, the Committee decided that recognition granted to B.Ed. course be withdrawn u/S-17 of NCTE Act, 1993 from the academic session next following the date of issue of withdrawal order with a copy to State Government, Affiliating Body and all concerned.
