Decision of WRC:

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- (i) Decision was taken by WRC in its 420th meeting held on 28th 29th April 2025 for rejection of application for change of name of institution from "Sanskar Girls College" to "Sanskar College" together with change of category from women to Co-Ed was decided by WRC with direction not to take fresh admission of students from academic session 2025-2026 unless permission granted for transition of B.A.B.Ed./B.Sc.B.Ed to ITEP programme. Accordingly, decision of WRC was communicated to the institution vide letter dated 12.07.2025.
- (ii) The institution filed petition before the Hon'ble High Court of Delhi at New Delhi W.P.(C) 8212/2025 and CM APPL. 35915/2025 and Hon'ble Court passed order dated 30.05.2025 with direction as under:
 - "...8. In the meanwhile, regard being had to the submission made by learned counsel for the parties, it is directed that the petitioner institution be allowed to participate in the counselling session for admitting students for the academic session 2025-26 in B.A.B.Ed./B.Sc.B.Ed. four years integrated course in terms of the public notice dated 06.05.2025.
 - 9. List on 23.09.2025."
- (iii) NCTE vide Public Notice dated F.No.NCTE-Regl012/18/2024-Reg. Sec-HQ dated 06.05.2025 has extended the timeline for transition of 4-Year B.A.B.Ed./B.Sc.B.Ed. into ITEP before the start of the academic session 2026-2027 instead of academic session 2025-2026.

In view of the above, the Committee decided that the above mentioned institution has been covered under extension of timeline for transition of 4-Year B.A.B.Ed./B.Sc.B.Ed. into ITEP vide NCTE's Public Notice F.No.NCTE-Regl012/18/2024-Reg. Sec-HQ dated 06.05.2025.

Decision of WRC:

- (i) Recognition was granted for B.Ed. Course with annual intake of 100 vide order dated 09.09.2008 followed by Revised order dated 23.05.2015 for compliance of conditions mentioned therein.
- (ii) The institution requested shifting of premises vide letter dated 16.01.2012 along with DD of Rs. 41,000/-
- (iii) Proposal for change of name of institution/ reminder for shifting of premises was submitted vide letters dated 07.02.2024, 28.03.2024, 24.04.2024, 21.05.2024, 10.06.2024, 20.08.2024 and 14.11.2024, 23.04.2025 without compliance regarding fulfilment of conditions mentioned in revised recognition order dated 23.05.2015.
- (iv) The institution has been granted recognition for B.Ed. course in the address "Ravindra Path, Near Bara Mandir, Dist. Sri Ganganagar 335001, Rajasthan" whereas the institution prior to grant of permission of shifting by WRC, NCTE has been making all correspondence in its letter head vide letter dated 07.02.2024 onwards mentioning the proposed address for shifting: Chak 7Z, Mirzewala Road, Sri Ganganagar 335001, Rajasthan, which is in violation of NCTE Act, Rules and Regulations.
- (v) Matter was considered by WRC in its 426th Meeting held on 03rd 05th June, 2025 and found certain deficiencies in its applications for change of premises and change of name of institution, hence the Committee decided to reject the proposal of the institution for change of premises as well as change of name on the following grounds by communicating decision of WRC to institution vide WRC letter dated 10.07.2025:
 - a) The institution has not submitted any compliance of Revised Recognition Order till date.
 - b) The institution has not submitted any fee for Shifting of Premises of Rs.1,77,000/-
 - c) The institution has not submitted Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well as other infrastructural facilities such as class rooms etc.
 - d) The institution has not submitted Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose.
 - e) The institution has not submitted latest Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government indicating that the land is free from all encumbrances.
 - f) The institution has not submitted Certified copy of site plan with demarcated

- land area for running different courses.
- g) The institution has not submitted Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.
- h) The institution has not submitted Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan at URL https://lsgonline.rajasthan.gov.in/track_application.aspx
- i) The institution has not submitted Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- j) The institution has not submitted latest Building Completion Certificate (BCC) in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.
- k) The institution has not submitted latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GoI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.
- 1) The institution has not submitted details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty members.
- m) The institution has not submitted copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with Regional Director, WRC, NCTE & Management along with duly filled Bank Form "A" in original, verified/ signed by the Manager of the Bank as per NCTE Regulations, 2014.
- (vi) The institution submitted representation vide letter dated 29.05.2025 received in WRC office on 10.06.2025 enclosing a copy of order dated 23.05.2025 in S.B. Civil Writ Petition No. 14495/2021 passed by Hon'ble High Court of Judicature of Rajasthan at Jodhpur with direction "...5. In view of the aforesaid, the present Writ Petition is also disposed of in the same terms of the order dated 21.02.2025 passed in the case of Mata Gujari Khalsa (supra) with a direction to the respondents to take necessary steps for updating the address of the petitioners institution at the earliest, preferably within a period of eight weeks from the date of the receipt of the certified copy of this order, strictly in accordance with law.

 6. Since the representation has been filed by the petitioners way back in the year 2012, therefore, it will be in the fitness of things that the petitioners shall submit a fresh
 - representation along with the certified copy of this order.
 7. The stay application as well as application (I.A. No. 01/2025) stand disposed of, accordingly."
- (vii) In pursuance of court order dated 23.05.2025, the institution has made a fresh representation vide letters dated 04.07.2025 and 12.07.2025 along with enclosures/documents and original DD of Rs.1,77,000/-.

- (viii) The matter was considered by WRC in its 431st Meeting and found that the institution is still deficient on following grounds. The institution shall be required to submit compliance regarding fulfilment of deficiencies within 21 days from the issue of the letter:
 - a) The copy of Govt. lease deed (Patta) dated 15.02.2024 with total land area 6616.48 sq. mtr. submitted in the name of "Shri Sanatan Dharam Mahila Shikshan Prashikshan Mahavidyalaya, Sri Ganganagar" whereas name of institution granted recognition for B.Ed. course is "Sanatan Dharam Mahila B.Ed. College".
 - b) As mentioned vide letter dated 07.02.2024, proposal submitted for change of name of institution as "Seth Jagdish Prasad Leela Sanatan Dharam Mahila B.Ed. College" and change of address as "Chak 7Z, Mirzewala Road, Sri Ganganagar 335001, Rajasthan".
 - c) Supporting document i.e. copy of Resolution passed by the Managing Body/Society/Trust along with affidavit regarding change of name of institution and change of address of institution is not submitted.
 - d) Copy NOC issued by State Govt. of Rajasthan regarding proposed change of name of institution is not submitted.
 - e) The institution has not submitted Blueprint of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multipurpose Hall as well as other infrastructural facilities such as classrooms etc.
 - f) The institution has not submitted latest Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government indicating that the land is free from all encumbrances.
 - g) The institution has not submitted Certified copy of site plan with demarcated land area for running different courses.
 - h) The institution has not submitted Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
 - i) The institution has not submitted latest Building Completion Certificate (BCC) in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.
 - j) The institution has not submitted latest/current approved faculty list in original in NCTE prescribed proforma signed on each page by the Registrar of Affiliating University with date.
 - k) The institution has not submitted six months bank statement in respect of each faculty member showing bank account no. duly attested by concerned Bank.
 - 1) The institution has not submitted renewal copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with Regional Director, WRC, NCTE & Management along with duly filled Bank Form "A" in original, verified/ signed by the Manager of the Bank as per NCTE Regulations, 2014.
 - m) Information related to creation and maintaining of institutional website is not submitted/available in the institution file. The website of institution has NOT been created, updated and maintained in compliance to provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.

In view of the above, the Committee decided that after submission of requisite documents certified by the management supported with an affidavit and fulfillment of all laid down conditions in accordance with provisions under Clause 8(9) of NCTE Regulations, 2014 within the stipulated time period, proposal for change of name of institution and proposal for shifting of premises shall be processed as per extant procedure of NCTE.

Further, the Committee observed the following:

This office is in receipt of a letter no. 5761-63 dated 19.07.2025 addressed to RD WRC and Higher Education Department, Government of Rajasthan on the captioned subject "change of address of institution regarding" from Deputy Registrar (Academic I), Maharaja Ganga Singh University, Bikaner, Rajasthan wherein mentioned that permission granted by the concerned University for shifting in its new building in respect of the institution viz. Sanatan Dharam Mahila B.Ed. College, Sri Ganganagar vide University letter no. 11319 dated 29.07.2013 which is against the NCTE Act, Rules and Regulations.

The Committee decided that Affiliating University (Maharaja Ganga Singh University, Bikaner, Rajasthan) is required to explain under which circumstances the Affiliating University had permitted the institution for shifting to its new premises without prior approval of NCTE. The reply be submitted within 21 days from the date of issuance of the letter for further appropriate decision.

Decision of WRC:

- (i) Recognition was granted for B.Ed. Course with annual intake of 60 vide order dated 29.09.2000 followed by order dated 10.10.2008 with total intake 100.
- (ii) Inspection u/S 13 was conducted on 19.02.2015.
- (iii) Revised order in consonance of NCTE Regulations, 2014 was issued dated 31.05.2015 for B.Ed. course of two year duration with annual intake of 100 (2 Basic Units of 50 student each) for compliance of conditions mentioned therein.
- (iv) Compliance of conditions regarding revised recognition order has not been submitted.
- (v) After considering VT Report, SCN u/s 17(1) issued dated 05.01.2016. Reply of institution was considered in 246th WRC Meeting, clarification letter dated 21.03.2016 was issued.
- (vi) Reply of clarification letter was considered by WRC and decided to withdraw recognition for B.Ed. course from the academic session 2016-17 which was issued vide order dated 17.12.2020.
- (vii) Show cause Notice u/S 17(1) was issued to the institution dated 05.07.2025 and reply is awaited.
- (viii) Institution filed a writ petition before Hon'ble High Court of Delhi at New Delhi W.P.(C)

10343/2025 and the Hon'ble Court passed the order on 21.07.2025, operative part of the court order is as under:

- "...3. Against the said order of withdrawal of recognition. Petitioner preferred an appeal before the appellate authority, and the appellate authority vide its order dated 31.01.2025 has remanded the case of the institute to the WRC-NCTE, setting aside the withdrawal order and for necessary action.
- 4. However, while setting aside the withdrawal order, the appellate authority did not specifically direct that the petitioner institution is entitled to the benefit of recognition until fresh order is passed.
- 5. He submits that after the matter was remanded by the appellate authority, WRC has not issued an order restoring the recognition of the petitioner institution with all other consequential benefits.
- 6. He further contends that in view of the order dated 31.01.2025 passed by the appellate authority, respondents were obliged to restore the recognition of petitioner institution and update the same on website.
- 7. In view of the above, issue notice. Mr. Renu Gupta, learned counsel appearing on behalf of respondent/NCTE accepts notice. She, on instructions, submits that necessary action will be taken by the respondent/NCTE. The statement is taken on record and the respondent NCTE shall remain bound by the same.
- 8. It is further directed that necessary action be taken by the NCTE within a period of one week.
- 9. In view of the statement of the learned counsel for the respondent/NCTE, Mr. Mayank Manish submits that no further orders are called for in the present petition. 10. The petition is disposed of in the above terms."

In view of the above, the Committee decided that in pursuance of above directions issued vide order dated 21.07.2025 of Hon'ble High Court of Delhi, recognition for B.Ed. course is restored with a copy endorsed to institution and all concerned and status of institution as recognized be reflected on the NCTE website.

The reply of the show cause notice dated 05.07.2025 pointing out deficiencies mentioned therein issued to the institution has not been received. Therefore, Committee decided that this matter shall be taken up again in the next meeting.

Decision of WRC:

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

(i) Recognition was granted for B.Ed. Course with annual intake of 100 vide order dated

- 07.11.2008 followed by Revised order dated 31.05.2015 for compliance of conditions mentioned therein.
- (ii) Show Cause Notice dated 26.08.2016 was issued in pursuance of compliance of Revised order, which was not submitted by the institution.
- (iii) Second Show Cause Notice dated 12.02.2020 was issued of which institution submitted reply vide letter dated 27.02.2020.
- (iv) Matter was considered in 414th (Part-1) WRC Meeting and as decided by the Committee, institution has been informed vide clarification letter dated 01.04.2025.
- (v) Matter was considered in 417th WRC Meeting and found deficiencies on the Show Cause Notice and clarification letter issued by WRC as decided by the Committee, Recognition for B.Ed. Course was withdrawn vide order dated 14.05.2025 on the grounds of deficiencies related to Land, Building and Faculty as per NCTE norms.
- (vi) Appeal preferred by institution against withdrawal order was remanded back vide Appellate Authority Order dated 24.06.2025 with a direction to verify the status of affiliation and functioning of the institution from affiliating university and conduct necessary verification, including inspection, if required as per provisions of the NCTE Regulations, 2014, guidelines and amendments issued from time to time. The Appellant institution is directed to forward documents as submitted in Appeal to WRC within 15 days from the receipt of order of the Appeal and after receipt of the same the WRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given in the appeal order.
- (vii) Being aggrieved, institution filed W.P.(C) 10395/2025 and the Hon'ble High Court of Delhi passed order dated 21.07.2025 wherein recorded statement of learned counsel on behalf of petitioner in the order "...8. He further contends that in view of the order dated 24.06.2025 passed by the appellate authority, respondents were obliged to restore the recognition of petitioner institution and update the same on website." and after accepting the notice of the Hon'ble Court, submission made by learned counsel on behalf of respondent NCTE recorded in the order "...10. She, on instructions, submits that necessary action will be taken by the respondent NCTE. The statements is taken on record and the respondent NCTE shall remain bound by the same." Subsequently the Hon'ble Court directed in the order that "...11. It is further directed that necessary action be taken by the NCTE within a period of one week."

In view of the above, the Committee decided that in pursuance of above directions issued vide order dated 21.07.2025 of Hon'ble High Court of Delhi, recognition for B.Ed. course is restored with a copy endorsed to institution and all concerned and status of institution as recognized be reflected on the NCTE website.

Further, the Committee observed the following:

The institution did not submit compliance report regarding fulfillment of conditions mentioned in the Revised Recognition Order dated 31.05.2015 pertaining to its existing premises wherein recognition for B.Ed. course was initially granted by NCTE.

On going through the case in details, the Committee noted that the institution is required to submit compliance report regarding fulfillment of conditions mentioned in the Revised Recognition Order.

- (i) The institution is required to submit latest original certified copy Land Documents issued by Competent Authority of State Government.
- (ii) The institution is required to submit Mutation Certificate issued by Competent Authority of State Government.
- (iii) The institution is required to submit latest Non-Encumbrance Certificate (NEC) issued by Competent Authority of State Government indicating that the land is free from all encumbrances issued by Competent Government Authority.
- (iv) The institution is required to submit Land Use Certificate (CLU) mentioning name of the institution/society, all Khasra Nos./Plot No./Survey No., land area after conversion to use the land from agriculture to educational purpose issued by the Competent Government Authority.
- (v) The institution is required to submit latest original certified Building Plan approved by the Competent Authority of State Government indicating name of institution/society, Khasra/Plot/Survey No. and mentioning the total land area and total built-up area earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes including multi-disciplinary programmes, if any.
- (vi) The institution is required to submit latest Building Completion Certificate (BCC) in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.
- (vii) The institution is required to submit Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.
- (viii) The institution is required to submit latest Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan.
- (ix) The institution is required to submit latest Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- (x) The institution is required to submit latest/ current faculty list approved & signed on each page by concerned affiliating body in original for all recognized courses separately with the details of their teaching subject, date of birth, date of selection/appointment, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GoI dated 09.06.2017), salary structure and related documents duly attested by authorized representative of management along with copy of approval letter of affiliating body.
- (xi) Notarized original affidavit on Rs.100/- on non-judicial stamp paper by the management and Rs.10/- non-judicial stamp paper by individual selected/appointed faculty in the NCTE prescribed proforma.
- (xii) The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty member.
- (xiii) The institution is required to submit copies of valid Fixed Deposit Receipts issued by Nationalized/ Scheduled Bank towards Endowment Fund (Rs.5.00 lakh) & Reserve Fund (Rs.7.00 lakh) in the joint operation mode with Regional Director, WRC, NCTE and the Management along with duly filled Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014 for each recognized teacher education course separately.
- (xiv) The institution is required to submit compliance regarding all laid down conditions in light

of Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.

In view of the above, the Committee decided that institution shall be required to submit reply and documents supported with an affidavit within 21 days from the date of issue of notice. After submission of all requisite documents certified by the management supported with an affidavit and fulfillment of laid down conditions in accordance with provisions under Clause 8(9) of NCTE Regulations, 2014 within the stipulated time period, the matter be placed before WRC for further necessary action in light of NCTE Act, Rules, Regulation, instructions and Guidelines issued by NCTE from time to time.

The Committee further decided that in pursuance of decision taken by Appellate Authority, NCTE vide Remand Back Order dated 24.06.2025, the Affiliating University in respect of institution be requested to verify the status of affiliation and functioning of the institution at their end and conduct necessary verification, including inspection, if required as per provisions of the NCTE Regulations, 2014, guidelines and amendments issued from time to time and submit verification report to WRC, NCTE within 21 days from the date of issue of the letter for taking further necessary action.

Decision of WRC:

- (i) Recognition was granted for B.Ed. Course with annual intake of 100 vide order dated 26.10.2002 followed by Revised order dated 31.05.2015 for compliance of conditions mentioned therein.
- (ii) Show Cause Notice dated 28.03.2017 was issued to the institution.
- (iii) Reduction of B.Ed. intake from 100 to 50 permitted by WRC in 387th meeting was issued vide order dated 07.07.2023 alongwith Show Cause Notice dated 07.07.2023 for compliance of deficiencies mentioned therein.
- (iv) Permission granted by WRC in its 399th meeting for change of name of institution was issued vide order dated 16.01.2024.
- (v) Final Show Cause Notice was issued dated 12.04.2024 to the institution of which the institution submitted reply vide letter dated 02.05.2024 received on 13.05.2024.
- (vi) Matter was considered by WRC in its 408th meeting and committee found that the institution is deficient on the grounds of Final Show Cause Notice. And Committee decided to withdraw recognition for B.Ed. Course on the deficiencies mentioned therein vide order dated 17.12.2024,

- (vii) Appeal preferred by the institution against withdrawal order and Appellate Authority issued order dated 12.03.2025 and concluded to set aside the impunged order dated 17.12.2024 of WRC NCTE with the direction to revisit the case in totality and also to check that the institution fulfil all the criteria of norms & standards for the land & building and if needed the WRC may also conduct the inspection of the institution to verify the infrastructural & instructional facilities as per provisions of the NCTE Regulations, 2014, guidelines and amendments issued from time to time, and decision taken accordingly. The Appellant institution is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the WRC to take further necessary action as per direction given in appeal order."
- (viii) WRC in its 428th meeting decided that Visiting Team be constituted in order to ascertain and scrutinize all the essential documents and at the time of verification, VT shall also check/verify list year-wise, website and Fire Safety Certificate so as to assess institution's preparedness for running the course as per provision of the NCTE Regulations, 2014 as amended from time to time.
- (ix) Before implementation of decision of 428th meeting of WRC, the institution being aggrieved filed case W.P.(C) 9962/2025 & CM APPL. 41429/2025 in Hon'ble High Court of Delhi and Hon'ble Court passed order dated 17.07.2025 with a direction to "respondent no.2/WRC to issue order of restoration of recognition of B.Ed. Course for 100 seats (Two Basic Units) of the petitioner's institute and to update the status of the petitioner's institute as a recognized institution on its website and necessary communication be also sent to the affiliating university as well as concerned department of the State Government. These directions be complied with within a period of 10 days from today."

In view of the above, the Committee decided that in pursuance of directions issued vide order dated 17.07.2025 of Hon'ble High Court of Delhi, recognition for B.Ed. course is restored with a copy endorsed to institution and all concerned, and status of institution as recognized be reflected on the NCTE website.

Further the Committee decided that as per decision taken by Appellate Authority vide order dated 12.03.2025 and subsequent decision of 428th WRC meeting, Visiting Team be constituted in respect of institution for verification of infrastructural and instructional facilities as per NCTE norms and regulations. After receipt of Visiting Team Report, the same shall be considered by WRC.

Further, the Committee observed the following:

The institution did not submit compliance report regarding fulfillment of conditions mentioned in the Revised Recognition Order dated 31.05.2015 wherein recognition for B.Ed. course was granted by NCTE.

- (i) The institution is required to submit latest original certified copy Land Documents issued by Competent Authority of State Government.
- (ii) The institution is required to submit Mutation Certificate issued by Competent Authority of State Government.
- (iii) The institution is required to submit latest Non-Encumbrance Certificate (NEC) issued by

- Competent Authority of State Government indicating that the land is free from all encumbrances issued by Competent Government Authority.
- (iv) The institution is required to submit Land Use Certificate (CLU) mentioning name of the institution/society, all Khasra Nos./Plot No./Survey No., land area after conversion to use the land from agriculture to educational purpose issued by the Competent Government Authority.
- (v) The institution is required to submit latest original certified Building Plan approved by the Competent Authority of State Government indicating name of institution/society, Khasra/Plot/Survey No. and mentioning the total land area and total built-up area earmarked for each course being run in the premises and the demarcated land area and built-up area for the teacher education programmes including multi-disciplinary programmes, if any.
- (vi) The institution is required to submit latest Building Completion Certificate (BCC) in the prescribed format of NCTE (17 points) issued by the Competent Government Authority for all the courses being conducted in the premises.
- (vii) The institution is required to submit Building Safety Certificate in adherence of safety guidelines as prescribed by National/State Disaster Management Authority issued by Competent Government Authority.
- (viii) The institution is required to submit latest Fire Safety Certificate issued by Fire Safety Department, Government of Rajasthan verifiable on the official portal of the Fire Department, Government of Rajasthan.
- (ix) The institution is required to submit latest Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- (x) The institution is required to submit latest/ current faculty list approved & signed on each page by concerned affiliating body in original for all recognized courses separately with the details of their teaching subject, date of birth, date of selection/appointment, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GoI dated 09.06.2017), salary structure and related documents duly attested by authorized representative of management along with copy of approval letter of affiliating body.
- (xi) Notarized original affidavit on Rs.100/- on non-judicial stamp paper by the management and Rs.10/- non-judicial stamp paper by individual selected/appointed faculty in the NCTE prescribed proforma.
- (xii) The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty member.
- (xiii) The institution is required to submit copies of valid Fixed Deposit Receipts issued by Nationalized/ Scheduled Bank towards Endowment Fund (Rs.5.00 lakh) & Reserve Fund (Rs.7.00 lakh) in the joint operation mode with Regional Director, WRC, NCTE and the Management along with duly filled Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014 for each recognized teacher education course separately.
- (xiv) The institution is required to submit compliance regarding all laid down conditions in light of Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.

In view of the above, the Committee decided that Show Cause Notice u/s 17 (1) of NCTE Act 1993 be issued to the institution with direction to submit reply along with requisite documents certified

by the ma	by the management supported with an affidavit within 21 days from the date of issue of notice.

Decision of WRC:

- (i) Recognition was granted for D.El.Ed. Course with annual intake of 50 vide order dated 29.01.2008. Show Cause Notice dated 10.04.2025 was issued for non filling of PAR (2022-2023) for D.El.Ed. course. Recognition for D.El.Ed. course is withdrawn vide order dated 24.05.2025.
- (ii) Recognition was granted for B.Ed. Course with annual intake of 100 vide order dated 28.12.2006 followed by revised order dated 28.05.2015. Show Cause Notice dated 03.04.2025 was issued for non filling of PAR (2022-2023) for B.Ed. course. Recognition for B.Ed. course is withdrawn vide order dated 26.05.2025.
- (iii) Application submitted by institution for correction of name in the recognition order for B.Ed. course stating that they are running B.Ed. College in the name of Shri Shivajirao Shikshanshastra Mahavidhyalaya, Red-shirala But NCTE has given recognition order to Ninaidevi Shikshan Prasarak Mandal Plot 85 & 88/93 state Highway 111, Village Red-Shirala P.O. & Tehsil Shirala Dist. Sangli-415408.
- (iv) As per application for B.Ed. course the name of institution mentioned as Ninaidevi Shikshan Prasarak Mandal Kokrud.
- (v) The Hon'ble High Court of Judicature at Bombay in Writ Petition (ST.) No. 21640 of 2025 in the matter of application dated 23.12.2023 submitted seeking correction of name of institution in the recognition order for B.Ed. course has passed order dated 07.07.2025 with direction "...3. In the facts and circumstances of the present case, we are satisfied that the National Council for Teacher Education should decide the application made for rectification as early as possible and in any case within a period of two weeks from the date of receipt of this order."
- (vi) The present status of recognition of this institution for B.Ed. course and D.El.Ed. course is withdrawn as stated above. Once recognition for B.Ed. course and D.El.Ed. of an institution is withdrawn by WRC NCTE, the institution is treated as 'Not Recognized' on the part of NCTE. Hence, this office is unable to process the proposal for correction of the name of institution.

In view of the above, the Committee decided that in pursuance of order dated 07.07.2025 passed by Hon'ble High Court of Judicature at Bombay, the application for correction of name of institution in the recognition order cannot be considered at this stage. The decision of Committee be communicated to the institution as well as standing counsel of NCTE dealing with the case to appraise the Hon'ble Court.

Decision of WRC:

- (i) Recognition was granted for B.Ed. course with annual intake of 100 vide Order dated 09.08.2007.
- (ii) Recognition for B.Ed. course was withdrawn vide Order dated 18.12.2008 on the grounds that institution is being run in the commercial building, land and built-up area is inadequate, Building is not owned by the institution.
- (iii) Appeal preferred by the institution against the withdrawal order was rejected vide Order dated 11.06.2009.
- (iv) Being aggrieved, the institution has filed a SCA No. 5738/2009 and SCA No. 3205 of 2009 and Hon'ble Court passed Order dated 14.05.2010 which was placed in its 145th WRC meeting held on 17th to 18th February 2011 and the Committee decided to conduct inspection of the institution and inspection was carried out on 01.07.2011.
- (v) SCN u/s 17 was issued to the institution dated 04.11.2011 on the grounds that the building is on 30 years lease in three phases which is not permissible, land is not in the name of institution/trust, size of the multipurpose hall and rooms not as per the NCTE Norms, Building Plan is not approved.
- (vi) WRC in its 159th Meeting held on 07th 09th February, 2012 considered the matter and as decided by the Committee, recognition for B.Ed. course was withdrawn vide Order dated 20.03.2012 on the following grounds:
 - a) As per NCTE norms (2005), any institution seeking recognition should be in possession of required land on the date of application either on ownership basis or on lease for a period of 30 years. There is no question of any advice from NCTE, WRC on this issue. As such the contention on the part of the institution that they are at liberty to execute lease agreements in part is not acceptable and definitely not tenable in terms of the prescribed norms.
 - b) The Visiting Team Report (1/1/11) clearly points out that the college is running in the premises meant for commercial purposes. The classrooms do not have adequate seating capacity, multipurpose hall is not as per NCTE norms, library is ill-equipped etc.
 - c) The WRC relies on the report of the VT. On verifying the records and comparing the same with the reply to Show Cause Notice given by the management of RJ Patel

- College of Education, the WRC is fully convinced that the institution does not have adequate facilities as required by NCTE norms.
- d) On perusal of the files right from initial recognition of the college, examining of the appeal orders from NCTE, New Delhi, High Court Judgements delivered from time to time, it is concluded beyond doubt that the institution has failed to make up the deficiencies, so recognition be withdrawn.
- (vii) Being aggrieved, the institution again filed an appeal, which was rejected vide Appellate Authority order dated 05.09.2012.
- (viii) Revised Order for 2-Year B.Ed. course in consonance of NCTE Regulations, 2014 has not been issued to the institution.
- (ix) The institution has filed SCA No. 22144/2019 2009 and Hon'ble Court passed order dated 24.02.2022 wherein directed to consider the representation dated 09.04.2019 of the institution within a period of eight weeks from the receipt of the order.
- (x) Matter was considered by WRC in its 415th Meeting held on 10th 12th March, 2025 wherein Committee decided that as per Hon'ble High Court of Gujarat at Ahmedabad vide No. SCA No. 22144/2019 dated 24.02.2022, the institution is directed to furnish their earlier representation dated 09.04.2019 within 21 days after the issue of the communication to the institution for further consideration by the Committee.
- (xi) On the basis of uploaded Minutes of 415th WRC Meeting on the website, institution submitted representation vide letter dated 20.04.2025 enclosing the copies of its previous letter dated 09.04.2019, enclosing copy of oral order dated 01.04.2019 and its connected court documents passed in R/Special civil application No. 6392 of 2019 by Hon'ble High Court of Gujarat at Ahmedabad wherein, the Hon'ble Court has dismissed the special civil application with direction to the petitioner to file an application as decided by the concerned competent authority in accordance to law and as expeditiously as possible, A copy of oral order dated 13.12.2019 passed in R/Special civil application No. 22144 of 2019 by Hon'ble High Court of Gujarat at Ahmedabad wherein mentioned "Notice returnable on 10.01.2020. Direct service is permitted today."
- (xii) Copies of its previous letters dated 14.12.2023, 03.01.2024 submitted by institution requesting to issue restoration order in reference to court order dated 24.02.2022.

The Committee noted that the institution is still deficient on the grounds of Withdrawal Order issued dated 20.03.2012 related to land and building as per provisions of NCTE Act, Norms and Regulations and Guidelines issued by NCTE from time to time. Therefore, the Committee decided that withdrawal order dated 20.03.2012 shall remain unchanged, which shall be communicated to institution and all concerned.

Decision of WRC:

Committee observed as under:

- (i) Recognition was granted for B.Ed. course with annual intake of 100 vide Order dated 01.03.2007 followed by Revised Order dated 31.05.2015.
- (ii) Show Cause Notice u/s 17(1) dated 25.09.2017 was issued for compliance of Revised Recognition Order.
- (iii) WRC in its 293rd Meeting held on 12th 14th June, 2018 considered the reply of SCN and accordingly, institution was informed vide letter dated 22.06.2018 to appoint qualified Principal and faculties as per Norms together with original staff profile approved by Registrar of Affiliating Body as per Appendix-4 of NCTE Regulations, 2014 and subsequent NCTE GOI Notification No. 237 Published on 09.06.2017.
- (iv) Reply received from institution on 06.09.2018 was considered by WRC in its 301st Meeting held on 17th 18th January, 2019. Accordingly, letter dated 05.02.2019 was issued to the institution with direction to submit original list of one Principal and two faculty members duly approved by competent authority within one month of issue of the letter.
- (v) Reply received dated 07.02.2019 was considered by WRC in its 336th Meeting held on 24th 25th March, 2021 and accordingly SCN u/s 17(1) was issued to the institution dated 07.04.2021 of which reply was not submitted by the institution.
- (vi) Letter dated 24.12.2024 received on 01.01.2025 from Affiliating Body enclosing original approval of staff profile for the academic year 2024-25 in respect of institution.
- (vii) Matter was considered by WRC in its 415th Meeting held on 10th 12th March, 2025 and the Committee decided that recognition for B.Ed. course be withdrawn on the following grounds:
 - a) All faculties are appointed on 28.05.2024 and faculties of Pedagogy/ies are without NET & Ph.D. qualification as prescribed by NCTE.
 - b) Principal is not appointed.
 - c) Faculties are appointed with conditionally approval of the countersigned by the Registrar of Hemchandracharya North Gujarat University, Patan, Gujarat, which is not as per Clause-5 of Appendix-4 of NCTE Regulations, 2014, together with provisions of Point No. 8 of GOI No. 237 dated 09.06.2017 and submitted staff list is not in the prescribed format of NCTE.
- (viii) Being aggrieved with the decision recorded in the uploaded Minutes of 415th WRC Meeting, the institution filed a petition W.P. (C) 10043/2025 & CM APPL. 41764/2025 and Hon'ble High Court of Delhi passed order dated 17.07.2025 with the direction to WRC that operation of the impugned decision taken by WRC in its 415th meeting whereby recognition of petitioner's institution was withdrawn, shall remain stayed during the pendency of petitioner's appeal before the Appellate Committee. Consequently, the respondent no.2/WRC is also directed to update its website reflecting that status of petitioner's institution as recognized institution. All concerned authorities including affiliating University will take cognizance of updation of petitioner's status on the website of the NCTE pursuant to the instant order.

In view of the above, the Committee decided that in pursuance of order dated 17.07.2025 passed by Hon'ble High Court of Delhi in W.P. (C) 10043/2025 & CM APPL. 41764/2025, status of institution is recognized till disposal of appeal preferred by the institution in NCTE and the same shall be updated on NCTE website.

Further, the Committee decided that the institution shall be required to comply all conditions in

pursuance of revised recognition order communicated in the Final Show Cause Notice dated 07.04.2021 including grounds on which decision for withdrawal was taken which shall be considered by WRC after receipt of decision of the Appeal Committee.

(Dr. Shailesh Naranbhai Zala) Chairperson, WRC
