Decision of WRC:

The online application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- (i) The institution has not submitted the list of faculties having required qualification as per Appendix-15 (After Omission of Appendix-13) of NCTE Regulations 2014, as amended from time to time for the proposed course duly approved by the concerned affiliating body as on date on the basis of Advertisement Nos. 01/2023 dated 20.02.2023, 01/2023 (Amendment No.1) dated 24.02.2023 and 2/2023 dated 20.02.2023 (Rolling Advertisement) followed by Advertisement No. 02/2023 (Amendment No. 1) dated 24.02.2023 uploaded by the institution through online ITEP application portal.
- (ii) The institution has not launched its own website with hyperlink to the NCTE website uploading the required information / documents as per clause 7(14) of NCTE Regulations 2014 as amended from time to time and its connected latest downloaded documents.
- (iii) The Committee noted that the institution has not complied with the above conditions.
