- (xi) Repair and replacement of furniture and other equipment is not available.
- (xii) Availability of developed Kitchen Garden is not available.
- (xiii) Rain Water Harvesting System is not available.
- (xiv) Principal has personally issued the non-encumbrance certificate. It was not accepted.
- (xv) The building plan was not accepted because it had been altered in many places.
- (xvi) The BCC (Building Completion Certificate) has no date or reference number.
- (xvii) Institution was unable to provide any documentation for the list of internship school.
- (xviii) The faculty list has not been approved by the affiliating university.
- (xix) Institution could not show the last three years' audit reports.
- (xx) Institution could not show the last three months' salary statements.
- (xxi) The institution has not shown the documents related to land, building, physical infrastructure and appointment of teachers to the Visiting Team during the time of virtual inspection. The Visiting Team has not accepted the claims of the institution in this regard.
