## **Decision of WRC:**

The file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

A complaint has been received from the Additional Director Rajya Shiksha Kendra Govt. of MP vide letter No. क्रमांक/राशिके/शि.शि./2025/1757 dated 11.08.2025 a/w Order No.549/आऊशि/संबद्धता dated 09.06.2025 of कार्यालय आयुक्त उच्च शिक्षा, मध्य प्रदेश, the details as under:-

*“In the context of the above-mentioned letter from Honorable Former MLA Shri Dhruv Narayan Singh, a request has been made to immediately terminate the affiliation of the D.EL.Ed. course offered by Indira Priyadarshini Mahavidyalaya, Bhopal, in compliance with order number 09.06.25 from the Higher Education Department.*

*Along with the Honorable MLA's letter, an order from the Commissioner, Higher Education Department of Madhya Pradesh, Satpura Bhawan, Bhopal, bearing letter no. 549/Aadish/Sambaddhta, dated June 9, 2025, has also been received and is attached.*

*It is worth noting that colleges offering D.EL.Ed. courses are granted recognition by the National Council for Teacher Education (NCTE), New Delhi. Based on this recognition, admissions to the D.EL.Ed. course are conducted through M.P. Online for colleges listed in the affiliation list issued by the Board of Secondary Education and the State Education Center.*

*Therefore, it is a request to take appropriate action in compliance with the letter from Honorable MLA, Shri Dhruv Narayan Singh.”*

**The Committee noted that the State Government has directed the affiliation of the institution and requested NCTE to withdraw its recognition. The Committee decided that the Show Cause Notice u/S 17(1) be issued to the institution with direction to submit reply along with requisite documents certified by the management supported with an affidavit within 15 days from the date of issue of notice.**

- The comments of the institution in respect of the complaint made by the Hon'ble M.L.A. and direction of the State Government.
- The institution is required to submit Certified registered land documents issued by the Registering Authority
- The institution is required to submit Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as class rooms etc.
- The institution is required to submit Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose.

- (iii) The institution has uploaded a lease deed executed on 10.02.2025 between Shri Sushil Shukla (lessor) and Pt.
