III. With the permission of the Chair, Smt. Rashmi Shukla, Regional Director, WRC & Convener presented the Table Agenda before the Committee. Decision taken by WRC is as under: -

NCTE Public Notice vide F.No. NCTE-Regl012/7/2025-Reg.Sec-HQ dated 12<sup>th</sup> September, 2025 in the matter of opening of portal giving final opportunity to recgonised TEIs offering 4-year B.A. B.Ed./B.Sc. B.Ed. (prior to the omission of Appendix 13) to apply afresh for transition to ITEP.

#### **Decision of WRC:**

The WRC noted that, in pursuance of the decision taken in the 67th General Body meeting, NCTE-Hqrs issued a Public Notice dated 12th September 2025 directing all Recognised TEIs offering 4-year B.A. B.Ed./B.Sc. B.Ed. (prior to the omission of Appendix 13) to apply afresh for Transition between 15th September 2025 and 5th October 2025, except those institutions which have either already been transited into ITEP or have been issued a Letter of Intent (LoI) by the concerned Regional Committee.

After detailed consideration of Public Notice, the WRC decided as under:

- 1) All applications for Transition to ITEP received in WRC, which are pending at any stage prior to issuance of Letter of Intent (LoI), need not be placed before the Western Regional Committee.
- 2) The Office of WRC shall send an e.mail to all such TEIs, including those whose applications have already been rejected/refused, directing them to apply afresh in accordance with the NCTE Public Notice dated 12th September 2025. Copy of Public Notice be enclosed with e.mail.
