Decision of WRC:

The online application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with reply of SCN post inspection and the Committee observed as under:

- (i) Regarding Barrier free accessibility and facilities for disabled, institution uploaded a certificate which is issued by Executive Engineer, PWD City Division-I, Jaipur vide No. EE-III/BSC/D-634 dated 01.08.2025 (without affixing official seal of issuing authority). Institution uploaded a lay out & site plan in respect of Khasra No. 655 as well as building plan pertaining to Block 'A' and 'B' showing (ground, first, second and third floor plan), in which mentioned that the total area is 7124SQMT and Built up area is 10004.20SQMT which is approved by Assistant Engineer, Architect and the management of the institution (without reflecting date of approval). The institution has not uploaded Blueprint of approved building plan showing plot no. khasra no. total land area, total built up area, name of course, name of institution earmarked for teacher education programme and demarcated land area and built up area for multidisciplinary programme(s) have not been reflected therein.
- (ii) Regarding physical measurements of the rooms, Institution uploaded new building plan of First, Second and Third floor (Block A and Block B), approved by the Assistant Engineer, Architect and the management of the institution (without reflecting date of approval).
- (iii) Copy of latest BCC dated 25.07.2025 by Sahayak Abhiyanta, Nagar Nigam, Jaipur uploaded. Total land area and total land area for TE course are same. Name of course not mentioned in latest BCC. Additional third floor construction area was included Building Completion certificate, earlier not shown.
- (iv) With regard to deficient point "Additional third floor as seen in front and rear view are not part of approved plans and the safety certificates presented by Institute. Most Labs were found to be poorly equipped, furniture was not adequate in class rooms, labs, library and multipurpose hall. Most parts of buildings were found to be under repair and renovation", in its reply the institution uploaded photographs (without geotagged). Hence, new approved building plan and safety certificate including the third floor and class rooms, labs, library and multipurpose hall, building photos are not acceptable.
- (v) With regard to deficient point regarding "There is seating capacity for 50 persons so inadequate seating capacity", in its reply, the institution stated that "There is seating capacity more than 50 persons, so adequate seating capacity, photo has been uploaded." Photos uploaded in this regard have not been geotagged, hence not acceptable.
- (vi) In its reply to query regarding professional research journals, cover page photos of research journals with bill of purchase uploaded on the portal are not acceptable and its GST tax invoice

not uploaded. However, the entry of these professional research journals in the library accession register is not uploaded/shown by the institution.

- (vii) With regard to deficient point "Seating capacity of Multipurpose Hall for 200 persons is not accepted and adequate seating not present", the institution uploaded photo (without geotagged) of multipurpose hall, hence not acceptable.
- (viii) Cover pages of different subject categories education encyclopedia uploaded and its GST tax invoice not uploaded. However, the entry of these Education Encyclopedia in the library accession register is not uploaded/shown by the institution.
- (ix) Copy of Bill dated 31.07.2025 uploaded and in its reply, institution stated that electronic publications has been purchased and its GST tax invoice not uploaded. However the entry of these Electronic Publication in the library accession register is not uploaded/shown by the institution.
- (x) In its reply regarding non-availability of digital or online resources, institution has uploaded copy of same invoice dated 31.07.2025 and in its reply that "Digital or Online Resources has been purchased, GST tax invoice not uploaded.
- (xi) With regard to the deficient point "Science Stream Laboratories available but not fully equipped" institution uploaded the laboratories photos (without geotagged), hence not acceptable.
- (xii) In its reply regarding deficient point "Humanities Stream Laboratories available but not fully equipped" institution upload photographs of laboratories (not geotagged), hence not acceptable.
- (xiii) With regard to the point regarding non-availability of Activity cum resource center, the institution uploaded the photographs (without geotagged), hence not acceptable.
- (xiv) In its reply of deficient point "Common Room available but not well-equipped." the institution uploaded a common room photograph (not geotagged), hence not acceptable.
- (xv) With regard to deficient point "Availability of adequate Furniture not available." the institution uploaded the photograph(without geotagged) in respect of the classrooms and halls, hence not acceptable.
- (xvi) In its reply of the deficient point "Repair and replacement of furniture and other equipment not available", the institution uploaded photograph (without geotagged) in respect of the classrooms and halls, hence not acceptable.
- (xvii) With regard to deficient point "Availability of developed Kitchen Garden not available" institution uploaded the photograph of the garden (without geotagged), hence not acceptable.
- (xviii) With regard to deficient point "Facilities for co-curricular activities not available, limited facilities and activity area is available." institution uploaded photographs (without geotagged), hence not acceptable.
- (xix) With regard to deficient point "The institution needs to improve infrastructural facilities accordingly, as labs, i.e., language, ICT, and psychology, need improvement accordingly", in its reply, the institution uploaded the photograph of the laboratories (without geotagged), hence not acceptable.
- (xx) In reply of the deficient point "Students were not present and no interaction could take place" institution uploaded a photographs showing a teacher is teaching to the students", however no proof of the same uploaded taken during period of virtual inspection as raised by VT members, hence not acceptable.

- (xxi) With regard to deficient point "Institute is not having facilities for divaangjan and also lack good teaching learning infrastructure", in its reply, the institution uploaded photographs (without geotagged) showing ramp and toilet facilities for disabled, hence not acceptable.

In view of the above, the application for transition to ITEP is rejected.

- (ii) Institution has uploaded an invoice of books purchased as listed therein. However, the entry of these books in the library accession register is not uploaded/shown by the institution.
- (iii) Institution has uploaded an invoice of books purchased as listed therein. However, the entry of these books in the library accession register is not uploaded/shown by the institution. The institution has claimed it has 5000 books however it cannot be ascertained from the uploaded documents.
- (iv) Institution has uploaded an invoice of journals/Magazines purchased as listed therein. However, the entry of these books in the library accession register is not uploaded/shown by the institution.
- (v) Institution has uploaded geotag Photographs, However, no other supporting document is uploaded to suffice the claim of institution.
- (vi) Institution has uploaded an invoice of Education Encyclopedia purchased as listed therein. However, the entry of these Education Encyclopedia in the library accession register is not uploaded/shown by the institution.
- (vii) Institution has uploaded an invoice of Electronic Publication purchased as listed therein. However, the entry of these Electronic Publication in the library accession register is not uploaded/shown by the institution.
- (viii) Institution has uploaded an invoice of Digital or Online Resources purchased as listed therein. However, the entry of these Digital or Online Resources in the library accession register is not uploaded/shown by the institution.
- (ix) Institution has uploaded all Activity Cum Resource Centre geotag Photographs. However, the institution has not uploaded any other supporting document issued by the Competent Government Authority.
- (x) Institution has uploaded all Health and Physical Education geotag Photographs. However, the institution has not uploaded any other supporting document issued by the Competent Government Authority.
- (xi) Institution has uploaded all Common room geotag Photographs. However, the institution has not uploaded any other supporting document issued by the Competent Government Authority.

- (xii) Institution has uploaded all store room geotag Photographs. However, the institution has not uploaded any other supporting document issued by the Competent Government Authority.
- (xiii) Institution has uploaded an invoice regarding availability of adequate Furniture purchased as listed therein. However, the entry regarding availability of adequate Furniture in the library accession register is not uploaded/shown by the institution.
- (xiv) Institution has uploaded an invoice regarding availability of Repair and replacement of furniture and other equipment purchased as listed therein. However, the entry regarding availability of repair and replacement of furniture and other equipment in the library accession register is not uploaded/shown by the institution.
- (xv) Institution has uploaded availability of developed Kitchen Garden geotag Photographs. However, the institution has not uploaded any other supporting document issued by the Competent Government Authority.
- (xvi) Institution has uploaded all Availability of Rain Water Harvesting System geotag Photographs. However, the institution has not uploaded any other supporting document issued by the Competent Government Authority.
- (xvii) Institution has uploaded all building infrastructure which is fully equipped and fully furnished geotag Photographs. However, the institution has not uploaded any other supporting document issued by the Competent Government Authority.

In view of the above, the application for transition to ITEP is rejected.

Decision of WRC:

The online application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with reply of SCN post inspection and the Committee observed as under:

- (i) With regard point regarding library books not up to the mark, the institution has uploaded a copy of accession register (02 pages) showing purchase of books in the year 2012, 2013 and 2025 signed by Principal of the institution (without date) and without proof of Voucher No. attested by the management, hence not acceptable.
- (ii) In reply of Sitting Capacity not up to the mark, institution uploaded a photographs of classrooms (Not Geotagged), hence not acceptable.
- (iii) With regard to query regarding library books mentioned is very less in number, the institution has uploaded a copy of accession register (02 pages) showing purchase of books in the year 2012, 2013 and 2025 signed by Principal of the institution (without date) without proof of Voucher No. attested by the management, hence not acceptable. The entry of these library books in the library accession register is not uploaded/shown by the institution.
- (iv) In support of proof regarding availability of Education Encyclopedia, copy of two vouchers dated 25.06.2025 without attested by the Principal/management, without sign with seal of book seller company are uploaded. Order No. of books is not indicated on the vouchers. The entry of these Education Encyclopedia in the library accession register is not uploaded/shown by the institution.
- (v) With regard to Electronic Publications, only photograph are uploaded (not geotagged), hence not acceptable. The entry of these Electronic Publication in the library accession register is not

uploaded/shown by the institution.

- (vi) Regarding Online Resources, institution uploaded a photograph (not geotagged), hence not acceptable. The entry of these Digital or Online Resources in the library accession register is not uploaded/shown by the institution.
- (vii) Regarding effective arrangement of clearing of campus, water and toilet institution, photographs (not geotagged) uploaded, hence not acceptable.
- (viii) Regarding toilet facilities, institution uploaded photographs showing the toilet facilities (without geotagged). Deficiency regarding Library and number of books not replied by the institution. No relevant document uploaded.
- (ix) Compliance of all conditions on institutional website as per provisions under Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time have not been fulfilled by the institution.

In view of the above, the application for transition to ITEP is rejected.
