4. In addition to the public notices, multiple attempts through press releases, regular reminders and video messages of both the Chairperson and Member Secretary of NCTE, uploaded across all major social media platforms with complete guide/tutorial for filling PAR were made to spread awareness and sensitize all the recognized teacher education institutions to for timely submission of their PAR.

5. The aforesaid matter was considered by the SRC in its 456th meeting held on 26th March 2025 and accordingly, total 2219 Show Cause Notice(s) was issued to the TEIs through mail by the online module developed by the NCTE (HQ) for this purpose, to reply with 15 days. The said SCNs were also sent to the TEIs through Speed Post as well.
