The Appellate Authority vide order 89-91/ E-352163/ 2024/Appeal/3<sup>rd</sup> Meeting, 2025 No.APPLSRC202414812 dt. 16<sup>th</sup> April 2025 set aside the withdrawal order of SRC dated 14.08.2024 and Appeal Committee of the Council concluded to remand back the case to SRC with a direction to verify the faculty list etc submitted in appeal from the concerned affiliating University / authority. The appellant institution was also directed to forward to the SRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the</i></li> </ul>

Course with an annual intake of 100 (two units) until fresh withdrawal order is passed.</p> <p>SRC also decided that the staff list and approval letter submitted by the institution be forwarded to Registrar, Telangana University, Nizamabad with a request to confirm whether the same has been issued by them or not, so as to enable SRC to take further action in the matter.</p>



- The matter was considered by SRC in its 463<sup>rd</sup> Meeting held on 16<sup>th</sup> June, 2025 wherein the SRC decided to give an opportunity to hear the petitioner as well as the respondent in the ensuing meeting of SRC after 02.00 PM and put up the representation dated 18-07-2023 given by petitioner with specific remarks.
- The institution vide receipt no.372013/2025 has requested to give a later date as the letter was received by them on 4th July, 2025.
- Accordingly, a letter was addressed to both the parties to be present before SRC on 23<sup>rd</sup> July 2025.
- Sh. Satyanarayan Yadav, Chairman of the institution attended personally before SRC, explained the matter in detail and submitted the judgement of Hon'ble High Court of Madras in W.P. No. 692/2014 dated 08.05.2025 and stated that the Hon'ble Court has given verdict in favor of the Trust and hence, Mr. Peter's representation against the trust is not maintainable in the eyes of law.

Keeping the entire facts in view the SRC decided that since the Hon'ble court has decided in favour of the institution, the complaint submitted by Sh. S. Peter may be closed and no action be taken henceforth.
