आदेश/ ORDER

I. GROUNDS OF REFUSAL

The appeal of Ashoka Education Foundation's Ashoka College of Education, Plot No. 4, Village – Nasik, Ashoka Marg, Maharashtra – 422006 dated 11.07.2024 filed under Section 18 of NCTE Act, 1993 is against the Order No. F.No.NCTE/WRC/2526202402231663/Maharashtra/2024/Rejc/1613 dated 14.05.2024 of the Western Regional Committee, refusing recognition for conducting ITEP Course on the grounds that "As per the details provided by the institution on the transition portal, the name of the institution mentioned in the recognition order for 4-year integrated B.A. B.Ed./B.Sc. B.Ed. course (as applicable) by NCTE does not match with the name mentioned in the transition application."

II. SUBMISSIONS MADE BY APPELLANT: -

Dr. Asha Thokey, Principal (I/c) of Ashoka Education Foundation's Ashoka College of Education, Plot No. 4, Village - Nasik, Ashoka Marg, Maharashtra -**422006** appeared online to present the case of the appellant institution on 14.08.2024. In the appeal report, it is submitted that "Ashoka Education Foundation was recognized for B.A. B.Sc. B.Ed. programme in the year 2008 as per the NCTE Regulations 2007 by NCTE. Ashoka Education Foundation approached Savitribai Phule Pune University (Formerly known as 'Pune University') & State Government of Maharashtra for affiliation and got affiliated for B.A./B.Sc. B.Ed. programme since 2008. The institute has started B.A./B.Sc. B.Ed. courses at the registered address located at Ashoka Marg, Ashoka Nagar, Wadala, Nashik. Recently we had applied for Transition of the course under ITEP, but the application got rejected by the WRC-NCTE and conveyed us via e-mail dated 14 May2024 with the reason mentioned that the name in application is not matched with the name in application is not matched with the recognition order issued. We hereby state that the said course is running under the same institution since recognition at the same place & under the same trust. After NCTE's recognition university has issued affiliation letter which was with the same name as mentioned in the transition application i.e., Ashoka Education Foundation's Ashoka College of Education. We further state that we



used the same name of the institute since then. We are the pioneering institute offering this course since 2008. So far institute had secured many Gold Medals of Savitribai Phule Pune University, Pune. In -spite of less no of admissions, we are running this course with the same zeal, enthusiasm and with enhanced quality year by year for betterment of the student fraternity. Considering all above, kindly requested to grant our application of transition in the larger interest of the students and the society."

III. OUTCOME OF THE CASE

The Appeal Committee in its 10th Meeting, 2024 held online on 14th August 2024 perused the relevant records and the documents submitted by appellant institution in the Appeal Report, documents on record and oral arguments advanced during the meeting.

The Appeal Committee noted that the appellant institution had submitted an application to the Western Regional Committee for grant of recognition for seeking permission for running the ITEP Course on 04.03.2024. The recognition of the institution for ITEP programme was refused by the WRC vide order dated 14.05.2024.

The instant matter placed in its 10th Meeting, 2024 held on 14.08.2024. The Appeal Committee noted that the institution had applied for ITEP Programme, and the application of the institution was refused vide order dated 14.05.2024. The Appeal Committee noted that the Appellant institution vide letter dated 12.07.2024 has submitted the following documents: -

- (i) A copy of recognition order dt. 17.05.2008 for conducting BA/B.Sc. B.Ed. (Integrated) course of SEC with an annual intake of 80 (SEC).
- (ii) A copy of revised order dt. 31.05.2015 for conducting BA/B.Sc. B.Ed. (Integrated) programme of four years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 alongwith a copy of affiliation order granted by the Pune Vidyapeeth, Maharashtra.

Noting the submission and verbal arguments advanced during the hearing, Appeal Committee decided to remand back the case to WRC with a direction to verify the issue and revisit the case in totality, if a recognition order has been issued by the WRC, NCTE for running B.A. B.Ed./B.Sc. B.Ed. programme then appropriate action shall be taken by the WRC in order to rectify the mistake which



through online portal after verifying the documents submitted before the Appeal Committee. The Appellant institution is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the WRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

IV. DECISION: -

After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to WRC with a direction to verify the issue and revisit the case in totality, if a recognition order has been issued by the WRC, NCTE for running B.A. B.Ed./B.Sc. B.Ed. programme then appropriate action shall be taken by the WRC in order to rectify the mistake which is inadvertently made by the institution while applying for ITEP programme through online portal after verifying the documents submitted before the Appeal Committee. The Appellant institution is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the WRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

I. GROUNDS OF REFUSAL

The appeal of Maharashtra Cosmopolitan Education Society's H.G.M. Azam College of Education, Survey no. 522, K.B. Hidayatullah Road, Poolgate, Pune, Maharashtra – 411001 dated 01.07.2024 filed under Section 18 of NCTE Act, 1993 is against the Order No. F. No. NCTE/WRC/2526202403122111/Maharashtra/2024 /Rejc/2061 dated 14.05.2024 of the Western Regional Committee, refusing recognition for conducting ITEP Course on the grounds that "As per the details provided by the institution on the transition portal, the name of the institution mentioned in the recognition order for 4-year integrated B.A. B.Ed./B.Sc. B.Ed. course (as applicable) by NCTE does not match with the name mentioned in the transition application."

II. SUBMISSIONS MADE BY APPELLANT: -

Dr. Anita M. Belapurkar, Dean and Principal of Maharashtra Cosmopolitan Education Society's H.G.M. Azam College of Education, Survey no. 522, K.B. Hidayatullah Road, Poolgate, Pune, Maharashtra – 411001 appeared online to present the case of the appellant institution on 14.08.2024. In the appeal report, it is submitted that "Appeal by Maharashtra Cosmopolitan Education Society's H.G.M Azam College of Education, Pune, Maharashtra Cosmopolitan Education Society, Pune, Maharashtra was established in the year 1948. It is an Educational Society registered under the Society's Registration Act of 1860 and also a Public Trust registered under the Bombay Public Trust Act 1950. Maharashtra Cosmopolitan Education Society's H.G.M. Azam College of Education was established in 1993 with a programme B.Ed. affiliated to Savitribai Phule Pune University. (Copy enclosed) M.C.E. Society's H.G.M. Azam College of Education received NCTE recognition order for strength of 80 in 2004-2005 where the name of college is mentioned only with the parent society's name i.e., Maharashtra Cosmopolitan Education Society and thereafter it continues with the name of Society and thereafter it continues with the name of Society. (Copy of documents is enclosed) College introduced M.Ed. in 2006 which is also recognized by NCTE. (Copy attached) NCTE has given recognition to B.A. B.Ed. 4 years integrated programme in the year 2006 with intake 50.



(Order WRC/5-6/89/2006 dated 03.10.2006 corrigendum 06.08.2019). After the procedure of affiliation from Savitribai Phule Pune University, College has started actual admissions to B.A. B.Ed. programme from the academic year 2012. Since then, we are successfully running this programme. (Copy enclosed). As we continued to receive all the orders of NCTE with the parent institution name only, (Maharashtra Cosmopolitan Education Society). On 10th December 2015, College has applied for change in name of the college as follows: Maharashtra Cosmopolitan Society's College of Education to Maharashtra Cosmopolitan Society's H.G.M. Azam College of Education. College completed the procedure with paying the amount of one lakh fifty thousand fees. Name of the college was reflected on the NCTE website as Maharashtra Cosmopolitan Education Society's H.G.M. Azam College of Education, Pune. (All the documentary evidence are enclosed with the appeal). College has also applied for B.Sc. B.Ed. 4 years Integrated programme in 2017 and received permission from NCTE with the intake 50. (Order WRC/APP201660156/BSc. B.Ed./278th/MH/2017/188359 dated 14.08.2017, corrigendum dated 31.05.2019). (Copy enclosed). In our B.Sc. B.Ed. NCTE order, the name of college is mentioned as, Maharashtra Cosmopolitan Education Society's H.G.M. Azam College of Education. The name of the college mentioned in the Affiliation of all our programmes from the University is Maharashtra Cosmopolitan Society's H.G.M. Azam College of Education. In PAR (Performance Appraisal Report to NCTE), on AISHE Portal and in MIS also the name of college is mentioned as Maharashtra Cosmopolitan Society's H.G.M. Azam College of Education. Our college is one of the well-established colleges in the state of Maharashtra with throughout excellent academic results and very good placement. College become a constituent college of Dr. P.A. Inamdar University. The matter is in progress and very soon we shall receive the NOC from NCTE. NCTE in its 387th Meeting held on 9th & 10th June, NCTE Committee had given permission to the same. (Transfer of college from Savitribai Phule University to Dr. P.A. Inamdar University). In 392nd Meeting of NCTE WRC Committee issued a Show Cause Notice saying that MCE Society can merge the Azam College of Education to Department of Education of Dr. P.A. Inamdar University. University has replied and accepted to make the changes issued a public notice about registration for transition of B.A. B.Ed. and B.Sc. B.Ed. programs to ITEP and College has applied for the same. Though the change of name was



acknowledged by NCTE at the relevant time, unfortunately the same is not reflecting on the website at present. The present organization has been working to produce the best teachers in Maharashtra for about 32 years. Therefore, people who are outstanding performers in various fields are being prepared, which is contributing to the progress of the country. Our institute is one of the very few teacher education institutes in Maharashtra which is running these programs (B.A. B.Ed.& B.Sc. B.Ed.) for many years. If the said appeal is rejected, the entire society will lose a good institution which will be a great loss to the society. Under the above circumstances, appellant humbly requests that the appeal may please be allowed, and order may please be passed granting the transition of our B.A. B.Ed. and B.Sc. B.Ed. 4 years integrated program to ITEP programs. Enclosures: -(i). Affiliation of B.Ed. by Savitribai Phule Pune University. (ii). NCTE Recognition orders of B.Ed. (iii). NCTE Recognition order of 2004-05. (iv). M.Ed. Recognition order. (v). NCTE Recognition order of B.A. B.Ed. with corrigendum. (vi). Savitribai Phule Pune University affiliation orders of B.A. B.Ed. (vii). Name change application with DD. (viii). Changed name reflected on the NCTE college list at that time. (ix). B.Sc. B.Ed. NCTE Recognition order with Change in name. (x). Savitribai Phule Pune University affiliation orders of B.Sc. B.Ed. (xi). Application to NCTE for NOC to transfer as Department of Education Dr. P.A. Inamdar University. (xii). Minutes of 387th meeting of NCTE WRC. (xiii). Minutes of 392nd Meeting NCTE, WRC."

III. OUTCOME OF THE CASE

The Appeal Committee in its 10th Meeting, 2024 held online on 14th August 2024 perused the relevant records and the documents submitted by appellant institution in the Appeal Report, documents on record and oral arguments advanced during the meeting.

The Appeal Committee noted that the appellant institution had submitted an application to the Western Regional Committee for grant of recognition for seeking permission for running the ITEP Course on 18.03.2024. The recognition of the institution for ITEP programme was refused by the WRC vide order dated 14.05.2024.

The instant matter placed in its 10th Meeting, 2024 held on 14.08.2024. The Appeal Committee noted that the institution had applied for ITEP Programme, and the application of the institution was refused vide order dated 14.05.2024. The Appeal Committee perused the documents submitted by the appellant institution vide letter dt. 04.07.2024 and the Committee observed that the institution vide Appeal report informed that:-

"On 10th December 2015, College has applied for change in name of the college as follows: Maharashtra Cosmopolitan Society's College of Education to Maharashtra Cosmopolitan Society's H.G.M. Azam College of Education. College completed the procedure with paying the amount of one lakh fifty thousand fees. Name of the college was reflected on the NCTE website as Maharashtra Cosmopolitan Education Society's H.G.M. Azam College of Education, Pune. (All the documentary evidence are enclosed with the appeal). College has also applied for B.Sc. B.Ed. 4 years Integrated programme in 2017 and received permission from NCTE with the intake 50. (Order WRC/APP201660156/BSc. B.Ed./278th/MH/2017/188359 dated 14.08.2017, corrigendum dated 31.05.2019). In our B.Sc. B.Ed. NCTE order, the name of college is mentioned as, Maharashtra Cosmopolitan Education Society's H.G.M. Azam College of Education. आदेश/ ORDER

I. GROUNDS OF WITHDRAWAL

The appeal of Himachal Institute of Education, Khasra No. 81, Village - Mauja Kotho, Street/Road – Jatoli Temple, Taluka/Mandal – Solan, Post Office – Shamti, Himachal Pradesh-173212 dated 12.07.2024 filed under Section 18 of NCTE Act, 1993 is against the Order No. F.No.NCTE-RegI015(14)/607/2022-Regulation Section (HP)-NRC/ (223890-223897) dated 19.10.2023 of the Northern Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "(i). The institution is not a multi-disciplinary institution as per clause 2 (b) of NCTE Regulations 2014. (ii). The institution has shifted to the new building without prior approval from NCTE, which is a serious violation of clause 8 (9) of NCTE Regulations 2014. (iii). As per records of NRC the institution has not submitted any application to NRC for shifting of premises. (iv). The land documents and other documents related to land viz Building Plan, BCC, CLU, NEC, Building Safety Certificate etc are not acceptable as the same has been submitted for the new building for which the approval has not been granted by NRC. (v). The total built up area in the institution is 1374.60 which is less than the required 1500 sq. mt. as per NCTE Regulations 2014. (vi). The lecturer for Physical Education, Fine Arts and Performing Arts are appointed on part time basis whereas as per NCTE Regulations they are to be appointed on full time basis."

II. SUBMISSIONS MADE BY APPELLANT: -

Mr. Ajay Sood, Secretary of Himachal Institute of Education, Khasra No. 81, Village - Mauja Kotho, Street/Road - Jatoli Temple, Taluka/Mandal - Solan, Post Office - Shamti, Himachal Pradesh-173212 appeared online to present the case of the appellant institution on 14.08.2024. In the appeal report, it is submitted that "Permission was obtained from NCTE vide their letter no. F. No. NCTE-ins 011/178/2018 dt. 27.06.2018 and shifting charges of 1.5 Lakhs was sent."

III. OUTCOME OF THE CASE

The Appeal Committee in its 10th Meeting, 2024 held online on 14th August 2024 perused the relevant records and the documents submitted by appellant institution in the Appeal Report, documents on record and oral arguments advanced during the meeting.

The Appeal Committee noted that the appellant institution was granted recognition for B.Ed. Course vide order dated 05.12.2002 with an annual intake of 40 students and vide order dated 18.10.2002 with additional intake of 60 students thus making total annual intake of 100 students. Thereafter, a revised provisional recognition order was issued to the institution on dt. 11.09.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 (one basic unit) from the academic session 2015-16. The recognition of the institution for B.Ed. programme was withdrawn by the NRC vide order dated 19.10.2023.

The instant matter placed before the Appeal Committee in its 10th Meeting, 2024 held on 14.08.2024 and during the online hearing the Committee noted that the Appellant Institution in addition to the explanation mentioned in appeal report submitted the following documents with a claim to have rectified the shortcomings pointed out in the impugned order dated 19.10.2023: -

(i) A copy of faculty list (1+8) members dt. 10.07.2024 approved by the Registrar, Himachal Pradesh University, Shimla as per provisions of NCTE Regulation, 2014 alongwith copies of Affidavit regarding land & building.

The Appeal Committee noted that there is delay of 7 months in filing of appeal, and during the hearing of appeal, the institution has explained the delay. Institution has prayed to condone the delay on the basis of submission made by institution, the Appeal Committee decided to condone the delay, as such delay in filing of appeal is hereby condoned.

The Appeal Committee observed that the NRC in its withdrawal of recognition order dated 19/10/2023 had pointed out that the institution has not taken prior approval before shifting to the new premises. However, the institution vide its Appeal Memorandum



informed that "On 29.06.2018, Society made an application to shift the Himachal Institute of Education from Old Campus to New Campus, which was received by at office of National Council for Teacher Education at 1, Bahadur Shah Zafar Marg, New Delhi — 23 on 02.07.2018. In addition, a Demand Draft No. 793276 for a sum of Rs. 1,50,000/- in favour of Member Secretary, NCTE was also received along with application."

The Appeal further noted that clause 8 of NCTE regulations 2014 dealing with "conditions for grant recognition" provided as under in respect of stand-alone institutions converting to composite institutions: -

"8 Conditions for grant of recognition -(1) New Teacher Education institutions shall be located in composite institutions and the existing teacher education institutions shall continue to function as stand-alone institutions and gradually move towards becoming composite institutions."

In view of the above, the Committee noted that the condition for the existing teacher education institutions to gradually move towards becoming composite institutions. Also, as per NEP 2020 the existing institutions have been given time to convert as multidisciplinary institution by 2030 as per para 15.3, 15.4 and 15.5 of NEP 2020.

The Appeal Committee noted that the institution has submitted detailed explanation alongwith documents with respect to points mentioned in the impugned order dated 19.10.2023. Hence, the Committee decided to remand back the matter to NRC, NCTE with the direction to revisit the case in totality and if needed to conduct an inspection of the institution to verify the shifting of the premises as per provisions of the NCTE Regulations, 2014 and keeping in view, the Hon'ble High Court of Delhi Judgment dated 23.02.2017 passed in W.P(C). no. 3231/2016 titled "Rambha College of Education V/s NCTE" wherein the Hon'ble Court has directed the Appeal Committee to take into consideration the subsequent documents of the Appellant while disposing of the Appeal has to be taken on record.

The Appeal Committee noted that the document submitted in appeal *viz a viz* the grounds mentioned in the impugned order dated 19.10.2023, required to be verified by the Visiting Team for shifting of premises of the institution. **The NRC is required to revisit**



the case in totality and if needed the NRC may also conduct the inspection of the institution for shifting of premises as per provisions of the NCTE Regulations, 2014, guidelines and amendments issued from time to time, and decision taken accordingly.

Appeal Committee noted that the Hon'ble High Court of Delhi vide order dated 08.04.2021, passed in W.P. (C) 4382/2021 has observed as follows: -

"Appellate Committee of NCTE, is directed to ensure that, whenever an order of remand is passed, the status of the impugned is clearly spelt out so that the institution is not compelled to approach the Court in this manner."

Appeal Committee noted that the Hon'ble High Court of Delhi vide order dated 30.07.2021, passed in W.P. (C) 7260/2021 has observed as follows: -

"Although the Appellate Committee of the NCTE would be well advised to expressly quash the original order of the concerned Regional Committee while remanding the matter, the position in law is that the order automatically stands quashed. The institution is, therefore, entitled to the benefits of recognition until a fresh withdrawal order is passed."

In view of the afore-mentioned extracts of the court orders, the impugned order dated 19.10.2023 is set-aside as the Appellate Committee has decided to remand back the case to NRC for revisiting the matter.

Noting the submission and verbal arguments advanced during the hearing, Appeal Committee decided to set aside the implunged order dated 19.10.2023 and remand back the case to NRC with a direction to revisit the case in totality and if needed the NRC may also conduct the inspection of the institution for shifting of premises as per provisions of the NCTE Regulations, 2014, guidelines and amendments issued from time to time and decision taken accordingly.



The Appellant institution is directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the NRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

IV. DECISION: -

After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to set aside the implunged order dated 19.10.2023 and remand back the case to NRC with a direction to revisit the case in totality and if needed the NRC may also conduct the inspection of the institution for shifting of premises as per provisions of the NCTE Regulations, 2014, guidelines and amendments issued from time to time and decision taken accordingly. The Appellant institution is directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the NRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

I. GROUNDS OF REFUSAL

The appeal of Shri Shyam Shikshak Prashikshan Sansthan, Plot No. 7, Village – Bhadra, Street/Road-Nohar Road, District-Hanumangarh, Rajasthan-335501 dated 24.07.2024 filed under Section 18 of NCTE Act, 1993 is against the Order No. F.No.NCTE/WRC/2526202402261765/Rajasthan/2024/Rejc/1715 dated 19.07.2024 of the Western Regional Committee, refusing recognition for conducting ITEP Course on the grounds that "As per the details provided by the institution on the transition portal, the institution is not recognized for 4-year Integrated B.A. B.Ed./B.Sc. B.Ed. course by NCTE. As per the details provided by the institution on the transition portal, the name of the institution mentioned in the recognition order for 4-year Integrated B.A. B.Ed./B.Sc. B.Ed. course (as applicable) by NCTE does not match with the name mentioned in the name mentioned in the transition application."

II. SUBMISSIONS MADE BY APPELLANT: -

Mr. Virendra Koushik, Secretary of Shri Shyam Shikshak Prashikshan Sansthan, Plot No. 7, Village – Bhadra, Street/Road-Nohar Road, District-Hanumangarh, Rajasthan-335501 appeared online to present the case of the appellant institution on 14.08.2024. In the appeal report, it is submitted that "The humble appellant respectfully submits as under: - 1. That vide application no. NRCAPP-11061 (Annexure - 1), Shri Shyam Seva Samiti, Bhadra (hereinafter referred to as the Samiti) had applied before the National Council for Teacher Education, New Delhi (NCTE) for recognition of 4-year B.A. B.Ed./B.Sc. B.Ed. course for the institute namely "Shri Shyam Shikshak Prashikshan Sansthan" having address: 7, BHD, Nohar Road, Bhadra, District Hanumangarh, Rajasthan (for short – hereinafter referred to as SSSPS). 2. That, as the affiliating body, the Registrar, Maharaja Ganga Singh University, Bikaner, vide its communication No. F-07()/MGSUB/Acad./2016/4347 dated 03.03.2016, had issued No Objection Certificate for affiliation of the appellant institution (SSSPS) for the session 2016-17. (Annexure -2) 3. That in compliance to the order of NCTE, the Commissioner, College Education, Rajasthan, Bikaner, vide its order dated 30.09.2016, had issued No

Objection Certificate in favour of SSSPS for conducting 4 years integrated course B.A. B.Ed./B.Sc. B.Ed. for the session 2016-17. (Annexure -3) 4. That the Regional Director, NCTE, vide its recognition order no. NRC/NCTE/Recognition/2016/152548-60 dated 04.07.2016, at Sr. no. 4, had granted recognition/permission to the appellant institution (SSSPS) for conducting Teacher Education programme for the session 2016-17 with an annual intake of 100 (2 units). (Annexure -4) 5. That in the aforesaid order dated 04.07.2016 of NCTE, due to some typing mistake, the name of the appellant institution (SSSPS) was wrongly/mistakenly mentioned as "Shri Shyam Shikshak Prashikshan Mahavidyalaya" instead of "Shri Shyam Shikshak Prashikshan Sansthan", whereas all order particulars i.e., application no., address of the institution, course details etc. were correctly mentioned therein, as these were. 6. That thereafter, the appellant institution is continuously conducting the prescribed course (s) as per recognition, guidelines and directives of NCTE. 7. That, NCTE has recently directed the appellant institution (SSSPS) to apply online and provide requisite information/details on the transition portal for grant of recognition for Integrated Teacher Education Programme (ITEP) course/programme online in the Western Regional Committee, NCTE, for the session 2025-26. 8. Accordingly, and as per directions of NCTE, while applying on the transition portal, it came to notice of the appellant institution (SSSPS) that in the said recognition order dated 04.07.2016 of NCTE, due to some typing mistake, the name of the appellant institution has wrongly/mistake been mentioned as "Shri Shyam Shikshak Prashikshan Mahavidyalaya" instead of "Shri Shyam Shikshak Prashikshan Sansthan". 9. In the meanwhile, NCTE, vide its refusal order F. No. NCTE/WRC/2526202402261765/ Rajasthan/2024/Rejc/1715 dt. 19.07.2024 (Annexure-5) informed the appellant that – "As pe the details provided by the institution on the transition portal, the institution is not recognized for 4-year integrated B.A. B.Ed./B.Sc. B.Ed. course by NCTE. As per the details provided by the institution on the transition portal, the name of the institution mentioned in the recognition order for 4 years integrated B.A. B.Ed./B.Sc. B.Ed. course (as applicable) by NCTE does not match with the name mentioned in the transition application." 10. That the correct name of the applicant/appellant institution is "Shri Shyam" Shikshak Prashikshan Sansthan", having address: 7, BHD, Nohar Road, Bhadra, District Hanumangarh, which is clearly evident from all the aforementioned documents,



applications, Correspondence, NOC etc., viz. (1) application no. NRCAPP-11061(2) No. Objection Certificate issued by the Registrar, maharaja Ganga Singh University, Bikaner (3) No Objection Certificate issued by the Commissioner, College Education, Rajasthan, Bikaner, vide its order dated 30.09.2016, besides all supporting documents thereto. 11. That the above typing error in the name of the applicant/appellant institution, as mentioned in NCTEs recognition order dated 04.07.2016, cannot be attributed to the applicant/appellant, but NCTE. This error was at best bonfide by the statutory authority. for which, penalizing the applicant/appellant, is not justifiable. 12. That the applicant/appellant institution is in substance conducting courses as B.A. B.Ed./B.Sc. B.Ed. programme in the name of "Shri Shyam Shikshak Prashikshan Sansthan". Mere wrong nomenclature indicated by NCTE could not convert the applicant/appellant institute as a "Mahavidyalala". Therefore, the authority itself may consider the substance over technicality and impart justice to the applicant/appellant by withdrawing/revoking the order dated 19.07.2024. 13. That file number NRCAPP11061 is related to "Shri Shyam Shikshak Prashikshan Sansthan, 7, BHD, Nohar Road, Bhadra, District Hanumangarh" and file number NRCAPP-11061 has absolutely no relation with "Shri Shyam Shikshak Prashikshan Mahavidyalaya". 14. That, for rectification of above typing error/mistake in the name of the institution, as mentioned in order dated 04.07.2016, a resolution has duly been passed by the Samiti on 20.02.2024, vide which the undersigned is authorized to do needful. (Annexure - 6) 15. In view of above facts, circumstances and grounds, the humble appellant prays as under: (i) that in the recognition order dated 04.07.2016, the name of the applicant/appellant institution may kindly be corrected as "Shri Shyam Shikshak Prashikshan Sansthan" in place wrongly mentioned "Shri Shyam Shikshak Prashikshan Mahavidyalaya". (ii) Consequently and/or alternatively, the refusal order no. 1715 dated 19.07.2024 passed by NCTE may kindly be withdrawn/revoked and recognition may be granted by the NCTE to the applicant/appellant institution (Shri Shyam Shikshak Prashikshan Sansthan) for conducting 4-year integrated B.A.B. Ed./B.Sc. B.Ed. course by NCTE, as per application and details provided by the applicant/appellant institution on the transition portal."

III. OUTCOME OF THE CASE

The Appeal Committee in its 10th Meeting, 2024 held online on 14th August 2024 perused the relevant records and the documents submitted by appellant institution in the Appeal Report, documents on record and oral arguments advanced during the meeting.

The Appeal Committee noted that the appellant institution had submitted an application to the Western Regional Committee for grant of recognition for seeking permission for running the ITEP Course on 04.03.2024. The recognition of the institution for ITEP programme was refused by the WRC vide order dated 19.07.2024.

The instant matter placed in its 10th Meeting, 2024 held on 14.08.2024. After perusing the documents submitted by the appellant institution vide letter dt. 24.07.2024, the Committee observed that the institution during the Appeal hearing informed the Committee that the institution inadvertently instead of Shri Shyam Shikshak Prashikshan Sansthan had applied for ITEP course in the name of Shikshak Parshikshan Mahavidyalaya. The institution has also submitted an affidavit stating the detailed reasons thereof and requested that the institution be granted to the NCTE in the name of Shri Shyam Shikshak Prashikshan Sansthan.

Noting the submission and verbal arguments advanced during the hearing, Appeal Committee decided to remand back the case to WRC with a direction to verify the issue and if a recognition order has been issued by the WRC, NCTE to the Shri Shyam Shikshak Parshikshan for running B.A. B.Ed./B.Sc. B.Ed. programme then appropriate action shall be taken by the WRC in order to rectify the mistake which is inadvertently made by the institution while applying for ITEP programme through online portal after verifying the documents submitted before the Appeal Committee. The Appellant institution is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the WRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

IV. DECISION: -

After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to WRC with a direction to verify the issue and if a recognition order has been issued by the WRC, NCTE Shri Shyam Shikshak Prashikshan Sansthan for running B.A. B.Ed./B.Sc. I. GROUNDS OF REFUSAL

The appeal of The Ankur B.Ed. College, Khata no. - 691-694, Telion ka Talab, Kanwa Basti, Nathdwara Village, Rajasmand District Rajasthan-313301 dated 02.06.2024 filed under Section 18 of NCTE Act, 1993 is against the Order No. F.No.NCTE/WRC/2526202403011940/RAJASTHAN/REJC/1890 dated 14.05.2024 of the Western Regional Committee, refusing recognition for conducting ITEP Course on the grounds that "As per the details provide the institution on the transition portal, the institution is not recognized for four years integrated B.A. B.Ed./B.Sc. B.Ed. course by NCTE."

II. SUBMISSIONS MADE BY APPELLANT: -

Mr. Vipul Kaushik, Director of The Ankur B.Ed. College, Khata no. - 691-694, Telion ka Talab, Kanwa Basti, Nathdwara Village, Rajasmand District Rajasthan-313301 appeared online to present the case of the appellant institution on 14.08.2024. In the appeal report, it is submitted that "With due respect it is submitted concerning the above cited subject that (1) In connection to our application submitted or the four years integrated programme (B.A. B.Ed./B.Sc. B.Ed.) for the transition to Integrated teacher Programme (ITEP) as per NCTE Regulations 2526202403011940. (2) In view of the above, we have received refusal order dated 14.05.2024 after preliminary screening of our application submitted. (3) In connection to refusal order received, we wish to submit that, it has come to our knowledge that the application submitted, we while filling details in online portal for B.A.B.Ed./B.Sc.B.Ed. course but mistakenly uploaded the NOC of Mohan Lal Shukhandiya University (Examination and affiliation body) in place of Recognition order for B.A.B.Ed./B.Sc.B.Ed. which is a bonified mistake. (4) It is requested condoned in interest to justice as well as future of the institution. (5) Therefore, it is requested to grant us the permission to conducted four years integrated programme(s) (B.A.B.Ed./B.Sc.B.Ed) for transition to Integrated Teacher Education Programme (ITEP) as per NCTE ITEP Regulations. In this regards the institution attached Recognition order for B.A.B.Ed./B.Sc.B.Ed."



III. OUTCOME OF THE CASE

The Appeal Committee in its 10th Meeting, 2024 held online on 14th August 2024 perused the relevant records and the documents submitted by appellant institution in the Appeal Report, documents on record and oral arguments advanced during the meeting.

The Appeal Committee noted that the appellant institution had submitted an application to the Western Regional Committee for grant of recognition for seeking permission for running the ITEP Course on 04.03.2024. The recognition of the institution for ITEP programme was refused by the WRC vide order dated 14.05.2024.

The instant matter was placed in its 9th Meeting, 2024 held on 15.07.2024. The appellant institution along with its appeal report has submitted a copy of Recognition Order dt. 27.05.2019 for B.A. B.Ed. course with an annual intake of 2 units of 50 students each from the academic session 2020-2021. The Appeal Committee in order to consider the case of the appellant institution on merit, decided to ask the WRC and the institution to submit their report/reply.

The instant matter again placed in its 10th Meeting, 2024 held on 14.08.2024. The Appeal Committed noted that the institution vide letter dated 30.07.2024 submitted its reply. The Western Regional Committee has submitted its report vide letter no. F. No. NCTE-Reg1015/59/2024-Regulation Section (RJ)-WRC/225386 dt. 06.08.2024 stated as under: -

"In this connection, it is to inform you that the recognition was granted to the institution for conducting B.A. B.Ed. (Integrated) programme for 100 (two basic units of 50 students each) from the academic session 2020-21 vide order F. No. NRC/NCTE/NRCAPP-2016-16189 (ID No.-10281/301st Meeting/2019/203482-87 dated 27.05.2019."

The Appeal Committee after perusing the documents and oral argument advanced during the hearing the Committee noted that a recognition order vide order No. F. No. NRC/NCTE/NRCAPP-2016-16189(ID.No.10281/301st Meeting/2019/203482 dated 27.05.2019 was issued by the WRC, NCTE. The Mohanlal Sukhadia University, Udaipur has granted the affiliation to the institution.

I. GROUNDS OF REFUSAL

The appeal of Shri S.R. Tiwari College of Education, Khasara No. 1030/1, Newad Village, Neemuch Singoli Road, Neemuch-Taluka/Mandal, Madhya Pradesh-458441 dated 30.05.2024 filed under Section 18 of NCTE Act, 1993 is against the Order No. F. I. GROUNDS OF REFUSAL

The appeal of Suratgarh B.Ed. College, Khasara No. 318/4, Village - Suratgarh, N.H. No. 62, District- Sri Ganganagar, Rajasthan-335804 dated 26.06.2024 filed under Section 18 of NCTE Act, 1993 is against the Order No. F. No. NCTE/WRC /2526202402261764/RAJASTHAN/2024/REJC/1714 dated 14.05.2024 of the Western Regional Committee, refusing recognition for conducting ITEP Course on the grounds that "As per the details provided by the institution on the transition portal, the institution is not recognized for 4 years Integrated B.A. B.Ed./B.Sc. B.Ed. course by NCTE."

II. SUBMISSIONS MADE BY APPELLANT: -

Mr. Parveen Arora, President of Suratgarh B.Ed. College, Khasara No. 318/4, Village - Suratgarh, N.H. No. 62, District- Sri Ganganagar, Rajasthan-335804 appeared online to present the case of the appellant institution on 14.08.2024. In the appeal report, it is submitted that "Grounds for Appeal: It is submitted that the appellant institute namely Suratgarh B.Ed. College, Plot No. 318/4, Steet No. - NH-15, (Now renamed as NH-62) Village Suratgarh, Tehsil Suratgarh, Suratgarh, District-Ganganagar-335804, Rajasthan (Run by Suratgarh Educational and Social Welfare Trust, Suratgarh) was given recognition by the NCTE for B.A. B.Ed./B.Sc. B.Ed. Integrated Four Years course (100 Seats) vide recognition letter no. F. No. NRC/NCTE/NRCAPP-10176/301st Meeting/2019 dated 27.05.2019. Whereas, as required by the NCTE the said Institute Applied for transition to Integrated Teacher Education Programme (ITEP) vide online Application dated 05.03.2024. The said application was rejected by the Western Regional Committee of the NCTE vide Refusal Order dated 14.05.2024 on the ground that "As per the details provided by the institution on the transition portal, the institution is not recognised for 4 - years Integrated B.A. B.Ed./B.Sc. B.Ed. course by NCTE." The said refusal order is erroneous and unjustifiable and is liable to be set aside. The appellant is preferring the present appeal against the said Refusal order dated 14.05.2024 on the following grounds: - 1. That the appellant institute viz. Suratgarh B.Ed. College, Plot No.

318/4, Street No. NH-15, (Now renamed as NH-62) Village Suratgarh, Tehsil Suratgrarh, District-Ganganagar-335804, Rajasthan (Run by Suratgarh Educational and Social Welfare Trust, Suratgarh) was given recognition by the NCTE for B.A.B.Ed./B.Sc.B.Ed. Four Year Integrated course (100 seats) vide recognition F.No.NRC/NCTE/NRCAPP-10176/301st Meeting/2019 dated 27.05.2019 will clarify that the appellant institution is recognised for 4 years Integrated course B.A. B.Ed./B.Sc. B.Ed. course by NCTE and order passed by the WRC is erroneous. (A copy of Recognition Letter dated 27.05.2019 passed by the NCTE is annexed herewith) 2. That the said refusal order dated 14.05.2024 passed by the Western Regional Committee is passed with application of mind and with checking the data of the NCTE wherein the name of appellant institute is present in the list of recognised institutes for the course afore mentioned. (A copy of website of the NCTE In regard thereto is annexed herewith) 3. It is submitted that the appellant institute is affiliated to Maharaj Ganga Singh University, Bikaner, Rajasthan for the afore said course as it is examining authority. (A copy of affiliation letter issued by the Maharaja Ganga Singh University, Bikaner, Rajasthan for the session2021-22 is annexed herewith). A bare perusal of the aforesaid Affiliation letter will clarify that the appellant institution is not only recognised for 4 years integrated B.A. B.Ed./B.Sc. B.Ed. course by NCTE but also running the said course successfully. 4. It is submitted that the WRC has also not afforded any opportunity to hear the appellant institute by issuing any notice for clarification before passing the order dated 14.05.2024 is contrary to the records of the NCTE and WRC and is liable to be set aside. PRAYER: It is most respectfully prayed that this Hon'ble Authority may be pleased to: a. Set aside the impugned Refusal order dated 14.05.2024 passed by the Western Regional Committee of the NCTE regarding the appellant institute b. Any other further order which the Hon'ble Authority deem fit in the facts and circumstances of the present appeal may also be passed in favour of the appellant."

III. OUTCOME OF THE CASE

The Appeal Committee in its 10th Meeting, 2024 held online on 14th August, 2024 perused the relevant records and the documents submitted by appellant institution in the Appeal Report, documents on record and oral arguments advanced during the meeting.

The Appeal Committee noted that the appellant institution had submitted an application to the Western Regional Committee for grant of recognition for seeking permission for running the ITEP Course on 05.03.2024. The recognition of the institution for ITEP programme was refused by the WRC vide order dated 14.05.2024.

The instant matter was placed in its 9th Meeting, 2024 held on 15.07.2024. The appellant institution along with its appeal report has submitted a copy of Recognition Order dt. 27.05.2019 for B.A. B.Ed./B.Sc. B.Ed. (Integrated) course with an annual intake of 100 (50+50) two units from the academic session 2020-2021. The Appeal Committee in order to consider the case of the appellant institution on merit, decided to ask the WRC and the institution to submit their report/reply.

The instant matter again placed in its 10th Meeting, 2024 held on 14.08.2024. The Appeal Committed noted that the institution vide letter dated 24.07.2024 submitted its reply. The WRC vide letter no. F.No.NCTE-Reg1015/52/2024-Regulation Section(RJ)-WRC/225412 dated 14.08.2024 also submitted its clarification report as under: -

"In this connection, it is to inform you that the above said institution recognition was granted vide order F.No.NRC/NCTE/NRCAPP-10176/301st Meeting/2019/203436-41 dated 27.05.2019 for conducting B.A. B.Ed./ B.Sc. B.Ed. (Integrated) for 100 (50+50) (two units) from academic session 2020-21."

The Appeal Committee after perusing the documents and oral argument advanced during the hearing the Committee noted that a recognition order vide order No. F. No. NRC/NCTE/NRCAPP-10176/301st Meeting/2019 dt. 27.05.2019 was issued by the WRC, NCTE. The Maharaja Ganga Singh University has granted the affiliation to the institution.

Noting the submission and verbal arguments advanced during the hearing, Appeal Committee decided to remand back the case to WRC with a direction to revisit the matter and verify the authenticity of the recognition order from the records of WRC, Affiliating body, and if a recognition order has been issued by the WRC, NCTE to the Institution for running B.A. B.Ed./B.Sc. B.Ed. programme then appropriate action shall be taken by the WRC as per provisions of the NCTE



Regulations. The Appellant institution is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the WRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

IV. DECISION: -

After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to WRC with a direction to revisit the matter and verify the authenticity of the recognition order from the records of WRC, Affiliating body, and if a recognition order has been issued by the WRC, NCTE to the Institution for running B.A. B.Ed./B.Sc. B.Ed. programme then appropriate action shall be taken by the WRC as per provisions of the NCTE Regulations. The Appellant institution is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the WRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

I. GROUNDS OF WITHDRAWAL

The appeal of Dr. Sushila Tiwari B.Ed. College, Khasara No.-288/1, 335, 335B, Sitaragang, Chorgaliya Road, Udham Singh Nagar, Uttarakhand-262405 dated 13.03.2024 filed under Section 18 of NCTE Act, 1993 is against the Order No. F.No./NRC/NCTE/UR-38/B.Ed./418th Meeting/2024/224414 dated 06.02.2024 of the Northern Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "(i) The building plan submitted by the institution is neither approved nor is legible. Further earmarked build up area course wise is not mentioned the building plan. (ii) vide letter dated 12.10.2023, 14 faculty have been approved by the University whereas proforma of only 11 faculty signed by the Registrar Kumaun University has been submitted. The institution is required to submit again with bank statements of all 16 faculty. It is also pertinent to mention that the date of approval has not been mentioned by the Registrar of the University over the Registrar of the proforma. (iii) Administrative and professional staff have not been appointed as required under clause 5.3 of Appendix 4 of NCTE Regulations, 2014. (iv) The institution has not submitted the additional information as per Clause 7(14), 8(6), 10(3) of the NCTE Regulation 2014 and Clause 2(C) of the NCTE Regulations dated 28.04.2017."

II. SUBMISSIONS MADE BY APPELLANT: -

Mr. Hariom Singh, Director of Dr. Sushila Tiwari B.Ed. College, Khasara No.-288/1, 335, 335B, Sitaragang, Chorgaliya Road, Udham Singh Nagar, Uttarakhand-262405 appeared online to present the case of the appellant institution on 14.08.2024. In the appeal report, it is submitted that "(i) The building has been approved by Nagar Palika, and earmarked area for B.Ed. course has been clearly mentioned. Being a composite institution, some infrastructure is also shared. Documents are attached herewith. (ii) Details of all 16 members with bank statements is available with the institution and attached herewith and copy of the registrar Performa with approval date has been attached herewith and also all the documents are uploaded in the website. Administrative and professional staff has already been working in the college. List is



attached herewith additional information as per clause 7(14), 8(6), 10(3), of NCTE Regulation, 2014, and clause 2(C) of NCTE Regulation dt. 28.04.2017 has been uploaded on the website and attached herewith."

III. OUTCOME OF THE CASE

The Appeal Committee in its 10th Meeting, 2024 held online on 14th August, 2024 perused the relevant records and the documents submitted by appellant institution in the Appeal Report, documents on record and oral arguments advanced during the meeting.

The Appeal Committee noted that the appellant institution was granted recognition for conducting B.Ed. programme of one year duration with an annual intake of 100 students vide order dated 09.07.2003 from the academic session 2006-2007 and shifting the premises was permitted vide order dated 08.06.2013. After promulgation of NCTE Regulations, 2014 a Revised Provisional Recognition Order was issued to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units of 50 students each vide order dated 06.06.2015 from the academic session 2015-2016. The recognition of the institution for B.Ed. programme was withdrawn by the NRC vide order dated 06.02.2024.

The instant matter was placed before the Appeal Committee in its 5th Meeting, 2024 of the Appeal Committee held on 27.03.2024. The Appeal Committee observed that the appellant institution has not submitted the requisite documents with respect to the deficiencies pointed out in the Withdrawal Order. The Appeal Committee in order to consider the case of the appellant institution on merit, decided to grant another (Second) opportunity to the appellant institution and the institution was required to submit the documents mentioned therein.

The instant matter was again placed before the Appeal Committee in its 6th Meeting, 2024 held on 10.04.2024 and the appellant has been asked to submit the documents mentioned therein. The instant matter was placed before the Appeal Committee in its 7th Meeting, 2024 held on 14.05.2024. The Appeal Committee observed

that the appellant institution has not submitted the requisite documents. The Appeal Committee in order to consider the case of the appellant institution on merit, decided to grant another (last) final opportunity to the appellant institution and the institution was required to submit the documents mentioned therein.

The instant matter was again placed before the Appeal Committee in its 8th Meeting, 2024 held on 06.06.2024 and during the online hearing the Committee noted that the Appellant Institution in addition to the explanation mentioned in appeal report submitted the following documents with a claim to have rectified the shortcomings pointed out in the impugned order dated 06.02.2024: -

- (i) A copy of faculty list (1+15) members dt. 24.02.2024 duly approved by the Registrar, Kumaun University, Nainital, Uttarakhand as per provisions of NCTE Regulation, 2014 alongwith copy of details of Administrative and Professional staff of 08 members.
- (ii) A copy of an Affidavit on Rs. 100/- Non-Judicial Stamp paper clearly mentioning the name, designation, account number and salary paid of each of the faculty appointed for B.Ed. programme and also stating therein that the faculty are being paid salary through cheque/RTGS/NEFT.
- (iii) A copy of the proceedings regarding selection of faculty members by the selection committee duly constituted and approved by the competent authority of the affiliating University/body and Salary statements of faculty members from 30.01.2024 to 30.04.2024.
- (iv) A copy of screen shot of website showing uploading the requisite documents on the website of the institution alongwith Affidavit regarding status of land and building alongwith copy of building plan.

The Appeal Committee after perusing the documents submitted by the institution and decided to seek clarification from the NRC submit their report/reply regarding management issue of the institution. The instant matter placed in its 10th Meeting, 2024. The Northern Regional Committee has submitted its clarification report vide letter no. NCTE-Reg1019/14/2022-Regulation Section (UT)-NRC/UR-38/B.Ed./E-69945/225544 dt. 13.08.2024 stated as under: -

- 1. Institution vide letter dated 03.07.2024 issued by Shambhu Nath Singh informed that he is Manager of the Society namely Dr. Sushila Tiwari Balika Utthan Samiti, since 1996 which is sponsoring Society of the institution namely Dr. Sushila Tiwari B.Ed. College. His name is also mentioned in the list of members of the Society.
- 2. Therefore, is the capacity of the Manager of the sponsoring Society, he had authorized Shri Jagdish Singh Bisht, Manager of the College to represent the College in his



- absence during the online hearing of the Appeal filed by the College before NCTE, HQ. New Delhi. (Copy of appointment letter attached.)
- 3. Further, Dr. Daya Shankar Maurya, HoD of the College was also authorized to represent the College in absence of Dr. Bisht. The name of Dr. Daya Shankar Maurya, is shown as HoD in the staff profile approved by the Registrar, Kumaun University, Nainital submitted by institution along with reply of Final Show Cause Notice vide letter dt. 31.01.2023.

The Appeal Committee noted that the Appeal Division is in receipt of complaints regarding management issue and non-running of institution as per NCTE Regulations, 2014, however, the institution has submitted documents with respect to points mentioned in the impugned order dated 06.02.2024. The Appeal Committee in order to check and verify the infrastructural & instructional facilities of the institution is of the view that the office of NRC may take up the matter with the affiliating University concerned regarding its non-running status as mentioned in the complaint received by the Appeal Division and NRC may take further action as per report received from the affiliating University. The NRC is also at liberty to verify the documents submitted by the appellant institution from the affiliating university and to conduct inspection of the institution under Section 13 of the NCTE Act, if needed, keeping in view, the Hon'ble High Court of Delhi Judgment dated 23.02.2017 passed in W.P(C). no. 3231/2016 titled "Rambha College of Education V/s NCTE" wherein the Hon'ble Court has directed the Appeal Committee to take into consideration the subsequent documents of the Appellant while disposing of the Appeal has to be taken on record.

The Appeal Committee noted that the document submitted in appeal *viz a viz* the grounds mentioned in the impugned order dated 06.02.2024, required to be verified. The NRC may take up the matter with affiliating University and also conduct the inspection of the institution under Section 13 of the NCTE Act, 1993, if needed and take further action as per provisions of the NCTE Regulations, 2014, guidelines and amendments issued from time to time, and decision taken accordingly.

Appeal Committee noted that the Hon'ble High Court of Delhi vide order dated 08.04.2021, passed in W.P. (C) 4382/2021 has observed as follows: -

"Appellate Committee of NCTE, is directed to ensure that, whenever an order of remand is passed, the status of the impugned is clearly spelt out so that the institution is not compelled to approach the Court in this manner."

Appeal Committee noted that the Hon'ble High Court of Delhi vide order dated 30.07.2021, passed in W.P. (C) 7260/2021 has observed as follows: -

"Although the Appellate Committee of the NCTE would be well advised to expressly quash the original order of the concerned Regional Committee while remanding the matter, the position in law is that the order automatically stands quashed. The institution is, therefore, entitled to the benefits of recognition until a fresh withdrawal order is passed."

In view of the afore-mentioned extracts of the court orders, the impugned order dated 06.02.2024 is set-aside as the Appellate Committee has decided to remand back the case to NRC for revisiting the matter.

Noting the submission and verbal arguments advanced during the hearing, Appeal Committee decided to remand back the case to NRC with a direction to take up the matter with affiliating University and also to conduct the inspection of the institution under Section 13 of the NCTE Act, if needed. The Appellant institution is directed to forward to the NRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the NRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

The appeal of Thandrapaparaya College of Education, Village - Komatipalli, Near Railway Gate, JKR Building, Post Office - Bobbili, Vizianagaram, Andhra Pradesh-535558 dated 28.05.2024 filed under Section 18 of NCTE Act, 1993 is against the Order No. F.SRO/NCTE/APSO0569/B.Ed./{AP}/2020/122028-2034 dated 29.12.2020 of the Southern Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "(i) A letter regarding approval of faculty issued by the affiliating body has not submitted by the institution. (ii) The institution has not appointed Fine Arts & Performing Arts faculty. (iii) Seven Lecturers does not have NET/Ph.D as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017."

In the appeal report, it is submitted that "Respected Sir/Madam, Sub: Permission for Appeal for Reconsideration of Withdrawal of Recognition of Thandrapaparaya College of Education, Bobbili – Req-Reg. Ref. No. F.SRO/NCTE/APSO0569/B.Ed./(AP)/2020/122028 dated 29.12.2020 fully understand that the decision made by the Southern Regional Committee (SRC) to withdraw our recognition due to non-compliance with the faculty qualifications as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017, among other observations. However, we would like to bring to your kind attention the extraordinary circumstances we have faced, which hindered our ability to comply with the requirements and subsequently submit a timely appeal. The COVID-19 pandemic severely impacted our operations, causing significant disruptions in our academic and administrative activities. Additionally, our institution faced severe financial constraints during this period, which further delayed our compliance efforts and the submission of an appeal within the



stipulated timeframe. The pandemic led to unprecedented challenges, including lockdowns, restricted movement, and health-related issues among our staff and faculty. This made it difficult to recruit qualified faculty members, especially those meeting the NET/Ph.D. criteria. Many potential candidates were unwilling or unable to relocate or join due to health concerns and travel restrictions. We sincerely hope that our appeal will be considered favourably, taking into account the unprecedented circumstances of the pandemic and our subsequent corrective measures. We are keen to resume our educational activities and continue contributing to the development of competent and dedicated educators. Thank you for your understanding and consideration. Your faithfully."

III. OUTCOME OF THE CASE

The Appeal Committee in its 10th Meeting, 2024 held online on 14th August 2024 perused the relevant records and the documents submitted by appellant institution in the Appeal Report, documents on record and oral arguments advanced during the meeting.

The Appeal Committee noted that the appellant institution was granted recognition for B.Ed. Course with an annual intake of 100 students vide orders dated 07.09.2000. After promulgation of NCTE Regulations, 2014 vide notification dt. 28.11.2014, the "Thandrapaparaya College of Education, Village - Komatipalli, Near Railway Gate, JKR Building, Post Office - Bobbili, Vizianagaram, Andhra Pradesh-535558" offering B.Ed. course was informed vide email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution. After the receipt of affidavit dt. 12.01.2015 from the institution, a Revised Recognition Order dt. 12.05.2015 was issued to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students (Two basic units of 50 students each) from the academic session 2015-2016. The recognition of the institution for B.Ed. programme was withdrawn by the SRC vide order dated 29.12.2020.

The instant matter was placed before the Appeal Committee in its 9th Meeting, 2024 held on 15.07.2024. The Appeal Committee observed that the appellant institution has not submitted the requisite documents. The Appeal Committee in order to consider



the case of the appellant institution on merit, decided to grant another (Second) opportunity to the appellant institution and the institution was required to submit the documents mentioned therein.

The instant matter placed before the Appeal Committee in its 10th Meeting, 2024 held on 14.08.2024 and during the online hearing the Committee noted that the Appellant Institution in addition to the explanation mentioned in appeal report submitted the following documents with a claim to have rectified the shortcomings pointed out in the impugned order dated 29.12.2020: -

- (i) A copy faculty list (1+15) members dt. 29.07.2024 approved by Registrar, Andhra University, Visakhapatnam as per provisions of NCTE Regulation, 2014.
- (ii) A copy of salary statement of faculty members from 01.05.2024 to 25.07.2024.

The Appeal Committee noted that there is delay in filing of appeal, and during the hearing of appeal, the institution has explained the delay. Institution has prayed to condone the delay on the basis of submission made by institution. The institution vide letter dt. 28.05.2024 submitted that "the COVID-19 pandemic severely impacted our operations, causing significant disruptions in our academic and administrative activities. Additionally, our institution faced severe financial constraints during this period, which further delayed our compliance efforts and the submission of an appeal within the stipulated timeframe. The pandemic led to unprecedented challenges, including lockdown, restricted movement, and health-related issues among our staff and faculty. This made it difficulty to recruit qualified faculty members, especially those meeting the NET/Ph.D. criteria. Many potential candidates were unwilling or unable to relocate or join dur to health concerns and travel restrictions." The Appeal Committee decided to condone the delay, as such delay in filing of appeal is hereby condoned.

The Appeal Committee noted that the institution has submitted documents with respect to points mentioned in the impugned order dated 29.12.2020 and keeping in view, the Hon'ble High Court of Delhi Judgment dated 23.02.2017 passed in W.P(C). no. 3231/2016 titled "Rambha College of Education V/s NCTE" wherein the Hon'ble Court



has directed the Appeal Committee to take into consideration the subsequent documents of the Appellant while disposing of the Appeal has to be taken on record.

The Appeal Committee noted that the document submitted in appeal viz a viz the grounds mentioned in the impugned order dated 29.12.2020, required to be verified. The SRC is required to verify the faculty list etc. submitted in appeal from the concerned affiliating University/authority as per provisions of the NCTE Regulations, 2014, guidelines and amendments issued from time to time and decision taken accordingly.

Appeal Committee noted that the Hon'ble High Court of Delhi vide order dated 08.04.2021, passed in W.P. (C) 4382/2021 has observed as follows: -

"Appellate Committee of NCTE, is directed to ensure that, whenever an order of remand is passed, the status of the impugned is clearly spelt out so that the institution is not compelled to approach the Court in this manner."

Appeal Committee noted that the Hon'ble High Court of Delhi vide order dated 30.07.2021, passed in W.P. (C) 7260/2021 has observed as follows: -

"Although the Appellate Committee of the NCTE would be well advised to expressly quash the original order of the concerned Regional Committee while remanding the matter, the position in law is that the order automatically stands quashed. The institution is, therefore, entitled to the benefits of recognition until a fresh withdrawal order is passed."

In view of the afore-mentioned extracts of the court orders, the impugned order dated 29.12.2020 is set-aside as the Appellate Committee has decided to remand back the case to SRC for revisiting the matter.

Noting the submission and verbal arguments advanced during the hearing, Appeal Committee decided to remand back the case to SRC with a direction to verify the faculty list etc. submitted in Appeal from the concerned affiliating University/authority. The Appellant institution is directed to forward to the SRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the SRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

The Appellant institution is directed to forward to the SRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the SRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.

College, Khasara No. 339/1M, 339/2M, 344M, Village - Roorkee, Railway Road, Haridwar, Uttarakhand-247667 dated 19.06.2024 filed under Section 18 of NCTE Act, 1993 is against the Order No. F.No./NRC/NCTE/UR-186/B.Ed./420th Meeting/2024/224882-888 dated 11.03.2024 of the Northern Regional Committee, withdrawing recognition for conducting B.Ed. Course on the grounds that "1. The institute has submitted a copy of letter dated 17-10-2015 issued by the SDSU University vide which 16 faculty members were selected for the academic session 2015-16. The institution has submitted Performa of the faculty members singed by secretary of society in previous reply. It is seen that some of the faculty members are changed and is not duly approved by the affiliating body. 2. The unapproved faculty list dated 17-10-2015 for B.Ed. faculty submitted by the institution is not substantiated with a copy of the proceeding selection of the all the faculty members by the selection committee duly constituted and approved by the competent authority of the affiliating university/body alongwith copies of certificate of academic and professional educational qualification viz., B.Ed., M.Ed., NET, Ph.D. etc., and experience of certificate of the principal. 3. Librarian and Lab Assistant are not appointed by institution. 4. The institution has not submitted the proof of salary disbursement to the administrative and professional staff through bank account. 5. The institution has not submitted proof of the additional information as per clause 7(14), 8(6), 10(3) of the NCTE regulation 2014 and clause 2(c) of the NCTE Regulations dated 28.04.2017. 6. The institution has not submitted the latest NEC issued by competent authority. 7. The institution has not submitted a copy of the affiliation orders of the last three years with intake capacity issued by the concerned affiliating body for each course being run by the institution/society."

II. SUBMISSIONS MADE BY APPELLANT: -

As no change has been made in the list of names as approved by the University, no fresh approval was required for the same list of names. The letter of Registrar, Sri Dev Suman University bearing 901/SDSUV/2024-25 dated 27.05.2024 evidencing their continued employment has been enclosed as Annexure-01. 3. I solemnly swear on oath that B.S.M. Women B.Ed. College, Roorkee was already employing a Librarian, an Assistant librarian along with 02 Lab Assistants and their appointment letters are encloses as Annexure-04 containing 4 pages. Proof of disbursal of salary to them for the preceding 4 months has been attached as Annexure-05. 4. That the duly certified bank account statement of the College Account and Proof of disbursal of salary to all the individual staff of BSM Women's B.Ed. College for the preceding 4 Months has been attached as Annexure-02, and certified copies of bank statements for the same are enclosed as Annexure-03. 5. I solemnly swear on oath that B.S.M. Women B.Ed. College Roorkee is a recognized institute by NCTE under Regulation 7(14), 8(6) of 2014. An additional affidavit supporting that same has been enclosed as Annexure-06. Further, Audit Report of CA evidencing compliance of Regulation 10(3) has been enclosed as Annexure-07. Further, it is submitted that he all the mandatory disclosures have been complied with as required under amended Regulation 2(C) published vide Gazette Notification dated 28.04.2017 substituting new sub-regulation (14). Sir, the letter issued by you bearing F. No./NRC/NCTE/UR-186/B.Ed./420th Meeting/2024/224883 dated 11.05.2024, 07 deficiencies in compliance pointed out on page no. 4 were wrongly mentioned, they had been already complied with prior to the letter being issued. I wish to inform you that the decision to withdraw recognition of 100 seats of BSM Women B.Ed. College Roorkee is absolutely wrong and against the extant rules. It is humbly requested that considering this letter read with the affidavit, recognition to B.S.M women B.Ed. College, Roorkee be kindly reinstated keeping in view the interest and future of girl students. Further, it is requested that permission for admission to 100 seats in B.Ed. College Roorkee be granted. 9. I solemnly swear on oath that information provided along with supporting documents in points 1,2,3,4,5,6 and 7 is true and correct. May God help me in this Endeavour. College, Chandresal, Kota (Raj.)" and uploaded all the necessary orders issued by NRC, NCTE and WRC, NCTE in respect to recognition of this college and order for change the name of institution. The application code is 2526202402131284. Copy of online application for transition of 4 years Integrated B.A. B.Ed. /B.Sc. B.Ed. course to ITEP course is attached. 9. That WRC, NCTE has not considered the relevant documents submitted by this institution for transition of 4 years Integrated B.A. B.Ed./B.Sc. B.Ed. course to ITEP course and rejected the application of this institution on illegal, unlawful, unconstitutional basis vide order no. NCTE/WRC/2526202402131284/Rajasthan/2024/Rejc/284 dated 14.05.2014. Copy of order attached. That this institution has sent E-mail to Chairman and Member Secretary, NCTE on 19.05.2024 for re-considering the matter of this institution and also sent a letter to WRC, NCTE on 20.05.2024 for re-consideration of this matter. But no action has been taken till date. Copy of E-mail sent to Chairman and Member Secretary and copy of letter submitted to WRC, NCTE is attached. Sir, the refusal order issued by WRC, NCTE dated 14.05.2024 to this institution for ITEP course is totally illegal, unlawful and unconstitutional. It is totally against the provisions of NCTE Act and Regulations. Therefore, it is requested that refusal order dated 14.05.2024 issued by WRC, NCTE to this institution for ITEP course be set side and order be issued to WRC, NCTE for procession of the online application of this institution for ITEP course."

III. OUTCOME OF THE CASE

The Appeal Committee in its 10th Meeting, 2024 held online on 14th August, 2024 perused the relevant records and the documents submitted by appellant institution in the Appeal Report, documents on record and oral arguments advanced during the meeting.



The Appeal Committee noted that the appellant institution had submitted an application to the Western Regional Committee for grant of recognition for seeking permission for running the ITEP Course on 05.03.2024. The recognition of the institution for ITEP programme was refused by the WRC vide order dated 14.05.2024.

The instant matter was placed in its 9th Meeting, 2024 held on 15.07.2024. The appellant institution along with its appeal report has submitted a copy of Recognition Order dt. 02.05.2017 for B.A. B.Ed./B.Sc. B.Ed. course with an annual intake of 2 units of 50 students each from the academic session 2017-2018. The Appeal Committee in order to consider the case of the appellant institution on merit, decided to ask the institution to submit their report/reply.

The instant matter again placed in its 10th Meeting, 2024 held on 14.08.2024. The Appeal Committed noted that the institution vide letter dated 29.07.2024 submitted its reply along with copies of order dt. 17.09.2017, 12.05.2022 & 07.08.2023 stating therein the following: -

- (i) That on the request of the institution, NRC, NCTE had granted recognition order for change the name of institution from S.K.T.T. College, Chandresal, Kota (Raj.) to Arihant Shikshak Prashikshan Mahavidyalaya, Chandresal, Kota (Raj.) for running 4 years Integrated B.A. B.Ed./B.Sc. B.Ed. course with an intake of 2 units of 100 students vide order no. NRC/NCTE/ID. No. 9223/NRCAPP-2016-15424/274th Meeting/2017/181554 dated 17.09.2017.
- (ii) That on the request of this institution, WRC, NCTE had granted recognition order for change the name of the institution from S.K.T.T. College, Chandresal, Kota (Raj.) to Arihant Shikshak Prashikshan Mahavidyalaya, Chandresal, Kota (Raj.) for running 2 years B.Ed. course with an intake of 2 units of 100 students vide order no. WRC/RJ-2041/349th /2022/219582 dated 12.05.2022.
- (iii) That on the request of this institution, WRC, NCTE had granted recognition order for change the name of institution from Arihant Shikshak Prashikshan Mahavidyalaya, Chandresal, Kota, (Raj.) to Arihant T.T. College, Chandresal, for running 4-year integrated B.A. B.Ed./B.Sc. B.Ed. course with an intake of 2 units of 100 students vide order no. NCTE/WRC/NRCAPP-2016-15424/B.A. B.Ed./B.Sc. B.Ed. /391st /2023/223858 to 223865 dated 07.08.2023.
- (iv) That at present the name of this college is Arihant T.T. College, Chandresal, Kota, (Raj.)

आदेश / ORDER

I. GROUNDS OF REFUSAL

The appeal of B R College of Education, Gata No. 303, 304, 790/255, Vill-Sarkankhera Post-Dubra, Dholpur Rajasthan-328001 dated 26.05.2024 filed under Section 18 of NCTE Act, 1993 is against the Order No. F. No. NCTE/WRC/2526202402181429/RAJASTHAN/2024/REJC/429 dated 14.05.2024 of the Western Regional Committee, refusing recognition for conducting ITEP Course on the grounds that "As per the details provided by the institution on the transition portal, the institution is not recognized for 4-year Integrated B.A. B.Ed./B.Sc. B.Ed. course by NCTE."

II. SUBMISSIONS MADE BY APPELLANT: -

Mr. Mahavir Prasad Tyagi, Secretary of B R College of Education, Gata No. 303, 304, 790/255, Vill-Sarkankhera Post-Dubra, Dholpur Rajasthan-328001 appeared online to present the case of the appellant institution on 14.08.2024. In the appeal report, it is submitted that "College is running B.Ed. course since 2008, recognition to B.Ed. course was granted to the college vide ref no. F.NRC/NCTE/RJ-1581/2008/60909 dt. 04.09.2008 (attached). (ii). Revised recognition order of B.Ed. course is granted to the college vide ref. no. F. No./NRC/NCTE/F-7/RJ1581/2015/ 105144-49 dt. 06.05.2015, college is having affiliation from Maharaja Surjmal Brij University, Bharatpur (Attached). (iii). College is also running 4-year integrated B.A. B.Ed./B.Sc. B.Ed. course recognition to the course is granted vide letter no. F. No. NRC/NCTE/Application no. 2016-16661/(ld no. 11077) 281st Meeting/2018/189743 dt. 28.02.2018 (attached). College is having affiliation from Maharaja Surjmal Brij University, Bharatpur (Attached). (iv). We have applied for conversion of 4-year integrated programme to ITEP via online NCTE portal having registration no. 2526202402181429 and fees for the same is paid on 05.03.2024 (attached) as college is running 2 Education courses hence falling under composite/multidisciplinary courses. (v). As per NCTE Refusal order college is not running the said course which is not true. Hence, it is requested that in light of the above facts it is clear that college is running B.Ed. & 4-years integrated course (B.A. B.Ed./B.Sc. B.Ed.) continuously. Kindly resume the college



proposal of conversion of 4-years integrated course to ITEP and issue further instructions."

III. OUTCOME OF THE CASE

The Appeal Committee in its 10th Meeting, 2024 held online on 14th August, 2024 perused the relevant records and the documents submitted by appellant institution in the Appeal Report, documents on record and oral arguments advanced during the meeting.

The Appeal Committee noted that the appellant institution had submitted an application to the Western Regional Committee for grant of recognition for seeking permission for running the ITEP Course on 05.03.2024. The recognition of the institution for ITEP programme was refused by the SRC vide order dated 14.05.2024.

The instant matter placed in its 8th Meeting, 2024 & 9th Meeting, 2024 held on 06.06.2024 & 15.07.2024 respectively. The appellant institution along with its appeal report has submitted a copy of Recognition Order dt. 28.02.2018 for B.A. B.Ed./B.Sc. B.Ed. course with an annual intake of 2 units of 50 students each from the academic session 2018-2019. The Appeal Committee in order to consider the case of the appellant institution on merit, decided to ask the WRC and the institution to submit their report/reply.

The instant matter again placed in its 10th Meeting, 2024 held on 14.08.2024. The Appeal Committed noted that the institution vide letter dated 29.07.2024 & 09.08.2024 submitted its reply. The WRC vide letter no. F. No. TRS Application No. 2526202402181429/ITEP/225328 dated 16.07.2024 also submitted a clarification report stated as under: -

"As per office record, recognition order was issued vide order no. F. No. NRC/NCTE/Application No. 2016-16661/(ID No.11077)/281st meeting/2018/189743 dt. 28.02.2018 to the aforesaid institution for 04-year Integrated programme B.A. B.Ed./B.Sc. B.Ed. with an annual intake of 2 units (100) students."

The Appeal Committee after perusing the documents and oral argument advanced during the hearing the Committee noted that a recognition order vide order No. F. No.



NRC/NCTE/Application No. 2016-16661/(ID No.11077)/281st meeting/2018/189743 dt. 28.02.2018 was issued by the WRC, NCTE. The Maharaja Surajmal Brij Vishwavidyalaya has granted the affiliation to the institution.

Noting the submission and verbal arguments advanced during the hearing, Appeal Committee decided to remand back the case to WRC with a direction to revisit the matter and verify the authenticity of the recognition order from the records of WRC, Affiliating body, and if a recognition order has been issued by the WRC, NCTE to the Institution for running B.A. B.Ed./B.Sc. B.Ed. programme then appropriate action shall be taken by the WRC as per provisions of the NCTE Regulations. The Appellant institution is directed to forward to the WRC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the WRC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above.
