MINUTES OF THE 58th GENERAL BODY MEETING OF NCTE (THROUGH CIRCULATION)

The agenda of 58th General Body meeting of NCTE was circulated to the Members of the General Body of NCTE vide e-mail dated 18 & 19 August 2023 for their consent.

Agenda Item No 1: Syllabi/Course Content (Suggestive) Integrated Teacher Education Programme (ITEP)for Implementation from the academic session 2023-24

- 1. The NCTE has notified the Gazette Notification "NCTE-Regl011/80/2018-MS(Regulation)-HQ dated 22nd October 2021" which includes granting recognition to the eligible institutions, determining intake, eligibility, admission procedure, curriculum and programme implementation, assessment, and evaluation etc. In para 1.8 of Gazette, it is mentioned that the ITEP shall be implemented in a phase wise manner starting from piloting in multidisciplinary HEIs/TEIs and thereby country wide expansion as per NEP 2020 timeframe.
- 2. Based upon Appendix 15 of aforesaid Gazette Notification, 42 institutions across the country have been granted recognition in the 1st phase of Piloting ITEP for the academic year 2023-24. These institutions include Central & State-owned institutions, IITs, NITs, RIEs and Govt. B.Ed. Colleges in collaboration with nearby multidisciplinary HEIs, affiliated to the same University, in conformity with the UGC guidelines or universities notified as Skill Universities along with multidisciplinary environment. The recognition as granted to the 42 institutions vide Public Notice dated 1st May 2022 to run the ITEP programme in pilot mode determine minimal degree qualification for school teachers corresponding to the stages like Fundamental, Preparatory, Middle and Secondary guided by the 5+3+3+4 design as envisaged in NEP 2020.
- 3. Based on Para 4 "Curriculum and Programme Implementation" of aforesaid Notification, Expert Committees, as formed for developing and designing the Curriculum Framework and Syllabi/Course Content, has finalized the ITEP Suggestive Syllabi/Course Content. It was vetted by the ITEP Core Committee and submitted to NCTE on 2nd August 2023 for further needful.
- 4. The ITEP Curriculum Framework has been approved in 57th GB Meeting of NCTE held on 4th July 2023 on circulation. The decision of the council is as follows:- "The agenda item 'Curriculum Framework of ITEP' for implementation from the academic session 2023-24 is approved, as proposed."
- 5. An Information Sharing Meeting was also conducted on 17.08.2023 at NCTE, in hybrid mode, of the National Oversight Committee, Members of ITEP Core Committee and Chairs of ITEP committees, Ministry of Education GoI, other autonomous/ statutory bodies and NCTE wherein ITEP and the ITEP Curriculum Framework were discussed. Prof. Jagdeep Singh, Vice Chancellor, Punjab University Bhatinda, Chairperson NOC appreciated the ITEP Curriculum Framework which had been prepared.
- 6. In view to the above, Agenda for Syllabi/Course Content (Suggestive) Integrated Teacher Education Programme (ITEP) (Stage Specific) for Implementation from the academic session 2023-24 was placed before the GB on circulation for approval.
