ORDER

WHEREAS, Sidra B.Ed. College, Vill.- Moregram, P.O.- Madhaipur, Via-Mangalbari, Dist.- Malda, West Bengal- 732142 (Code No. APE01045) was granted for B.Ed. course with an intake of 100 from the academic session 2014- 2015 vide ERC Order No.24268 dated 25.02.2014, followed by revised order vide No.32569 dated 31.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 270th Meeting held on 25th – 26th March, 2019, considered the matter along with the reply dated 23.02.2019 submitted by the institution in response to Show Cause Notice and observed as under:

- (i) Show Cause Notice u/s 17(1) was issued on 08.02.2019.
- (ii) The institution failed to submit revalidated FDRs in joint operation mode along with bank authorization certificate as per NCTE Regulations, 2014. The plea of the institution for not getting the same from the bank is not accepted as the said instruction has already been uploaded on ERC website i.e. www.ercncte.org for the use of the institution and all concerned.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. APE01045 is withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.

3. **AND WHEREAS**, the order of withdrawal was not issued to the institution and the matter was re-considered by ERC in its 271st meeting held on 24th – 25th April, 2019 under the agenda item No. 271.1.17 before confirmation of proceedings of 270th ERC meeting.

4. **AND WHEREAS**, the ERC in its 271st meeting held on 24th – 25th April, 2019 analyzed the representation vide Ref. No.44/SBEDC/SECY/MG-MAL/2019 dated 05.04.2019 along with enclosures submitted by the institution on the basis of decision taken in 270th meeting uploaded on ERC website and decided as under:

Decision taken by ERC for withdrawal of recognition to B.Ed. course is rectified and the **recognition be restored from the academic session 2019-2020**. Accordingly, order be issued to the institution and all concerned.
