ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted recognition to Central University of South Bihar, SH-7, Gaya Panchanpur Road, Village-Karhara, Post-Fatehpur, P.S.-Tekari, Dist.-Gaya, Bihar–824236 for M.P.Ed. programme of two year duration with an annual intake of 40 *vide* order No. ERC/NCTE/Regl014/97/2021-Regulation Section-ERC/M.P.Ed./306th (Virtual)Meeting/2022/65893 dated 19.07.2022.

2. AND WHEREAS, the institution has approached to the Hon'ble Supreme Court of India in Writ Petition (Civil) No. 853 of 2022 regarding change of academic session. The Hon'ble Court vide its Order dated 07.11.2022 inter-alia directed as under:-

"Issue a writ a mandamus or any other appropriate writ or order or direction to the ERC of NCTE to grant modified recognition for conduction M.P.Ed. programme (40 seats) from the present academic session 2023-24, already granted by the Respondent and permit the Petitioner university to commerce the said programme from the present academic session 2022-23".

3. AND WHEREAS, the matter was considered by the ERC in its 313th (Virtual) meeting of the ERC held on 16th November, 2022 and the committee decided as under:-

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed that:

- The University was granted recognition for running M.P.Ed. programme with an annual intake of 40 students from the academic session 2023-24 vide Order No. ERC/NCTE/Regl014/97/2021-Regulation Section-ERC/M.P.Ed./306th (Virtual)/Meeting/2022/65893 dated 19.07.2022.
- The institution has approached to the Hon'ble Supreme Court of India in Writ Petition (Civil) No. 853 of 2022 regarding change of academic session. The Hon'ble Court vide its Order dated 07.11.2022 has inter-alia directed as under:

"Issue a writ of mandamus or any other appropriate writ or order or direction to the ERC of NCTE to grant modified recognition for conducting M.P.Ed. programme (40 seats) from the present academic session 2023-24, already granted by the Respondent and permit the Petitioner university to commerce the said programme from the present academic session 2022-23.
