ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Chatta Primary Teachers Training Institute, Plot/Khasra No-1863, Plot No-112, 118, 119, 120, 1130, Khana Jn. Road, Po-Khana Jn., Dist.-Burdwan, West Bengal-713141 for B.Ed. programme of two year duration with an annual intake of 100 vide order No. ER-239.6. 135(Part-4)/ERCAPP3789/B.Ed./2017/53016 dated 02.05.2017.

2. AND WHEREAS, as per decision taken by ERC in its 282nd meeting held on 08th & 9th July, 2020, Show Cause Notice was issued to the institution under Section 17(1) of NCTE Act, 1993. The reply submitted by the institution was considered by ERC in its 290th meeting held on 04th March 2021and final Show Cause Notice was issued on 18.03.2021. The institution had submitted its reply against Show Cause Notice vide letter dated 12.04.2021.

3. AND WHEREAS, the reply of the institution was considered by ERC in its 304th (Emergent) meeting held on 11th April, 2022 and the committee decided to issue withdrawal order on certain grounds. Accordingly, withdrawal order was issued to the institution on 22.04.2022.

4. **AND WHEREAS**, the institution filed Writ Petition No. 8844 of 2022 before the High Court of Delhi at New Delhi. The Hon'ble Court passed an order dated 01.06.2022. The operative part of the order is as under:-

"...In terms of the second proviso to Section 17(1) of the NCTE Act, 1993, the Withdrawal Order takes effect at the end of the academic session next following the date of communication of such order, and therefore, the Withdrawal Order, having been passed on 22nd April, 2022, would take effect from the end of the Academic Session 2022-23."

In view of the above, it is made clear that Petitioner is entitled to take part in counselling and admit students for the Academic Session 2022-23. NCTE is directed to reflect Petitioner's status as a recognised institution for the year 2022-23 on its web portal and also to communicate the same to Petitioner's affiliating university and concerned State Government within a period of three days from today.

i.e., 2022-23 and will not be permitted to take any fresh admissions prior to grant of recognition by ERC.

Since Petitioner's reply to the show cause notice is yet to be examined, the direction to the institution not to take fresh admissions of the student is set aside and shall remain in abeyance till such time the ERC takes a final view on the reply filed by the Petitioner".

In compliance of said court order, a letter was sent to the institution on 17.06.2022.

5. **AND WHEREAS**, the institution preferred an appeal against the withdrawal order and the Appellate Authority, NCTE vide order dated 22.04.2022 remanded back the case to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time.

6. AND WHEREAS, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 313th (virtual) meeting held on 16.11.2022 and the Committee observed that:-

- The Appeal Committee of the Council vide its Order No. F.No.89-147/E-257178/2022 Appeal/7th Mtg.-2022 APPLERC202214382 dated 19.10.2022concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time.
- In compliance of the Order, the institution submitted the documents to the office of ERC on 03.10.2022.

In view of above, the Committee decided that recognition granted to the institution vide Order dated 02.05.2017 for conducting B.Ed. programme with an annual intake of 2 units (100 students) is hereby restored.

Orders may be issued accordingly

7. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. Chatta Primary Teachers Training Institute, Plot/Khasra No-1863, Plot No-112, 118, 119, 120, 1130, Khana Jn. Road, Po- Khana Jn., Dist.- Burdwan, West Bengal-713141 for B.Ed. programme for 100 seats (2 basic units of 50 students each) is hereby restored.
