WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to **Nirmala Chitta Teachers' Training Institute, Plot No.-1673, Vill.-Pabra, P.O.-Tentulhiti, Tehsil/Taluka-Para, Town/City-Purulia, Dist.-Purulia, West Bengal-723155.** For conducting B.Ed. programme with an annual intake of 50 seats *vide* order No. ER-242.6.43/APP3270/B.Ed./2017/53893 dated 28.07.2017 from the session 2018-2019.

2. **AND WHEREAS**, a letter No. NCTE-CDN016(13)/18/2018-CDN-HQ dated 02.08.2018 was received from NCTE HQ. In compliance of the said letter, the matter was placed before 284th meeting of ERC-NCTE held on 17-18 September 2020 and the Committee decided to issue the show cause notice to the institutions which have been recognized without NET qualified teachers. Accordingly, first SCN was issued to the institution on dated 30.09.2020. The reply dated 26.03.2021 submitted by the institution was received on 31.03.2021 in ERC.

3. **AND WHEREAS**, the matter was placed before ERC in its 303rd (Virtual) meeting held on 24th March, 2022 and the committee decided to issue final show cause notice under Section 17(1) of the NCTE Act, 1993 be issued to all ninety seven (97 TEIs). Accordingly, Final Show Cause Notice was issued to the institution on dated 09.04.2022. The reply of the institution was received in ERC on 21.05.2022.

4. **AND WHEREAS**, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 313th (virtual) meeting held on 16th November, 2022 and the Committee observed that:

"The institution has submitted its reply dated 21.05.2022 in response to the Final Show Cause Notice dated 09.04.2022 which is still deficient on the following grounds:

- The institution has submitted the list of faculty approved by the affiliating University on 18.03.2021. This list of faculty is not in the prescribed format of NCTE. Also, academic & professional educational qualification viz. B.Ed., M.Ed., M.A. (Education) & M.A. etc. and experience of teaching staff is not mentioned therein.***
- The institution has not uploaded the requisite information on its web-site as required under clause 7(14) of the NCTE Regulations, 2014 as amended from time to time.***

- *From the Performance Appraisal Report (PAR) for the academic session 2020-21, it is observed that the institution has not updated its website as per NCTE Regulations, 2014.*

Hence, Committee decided that the recognition for B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order."

5. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to **Nirmala Chitta Teachers' Training Institute, Plot No.-1673, Vill.-Pabra, P.O.-Tentulhiti, Tehsil/Taluka-Para, Town/City-Purulia, Dist.-Purulia, West Bengal-723155** vide order No. ER 242.6.43/App3270/B.Ed./2017/53893 dated 28.07.2017 for running B.Ed. programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.

6. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
