#### WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to Prakash Punj Teachers Training College, Plot No.-1859, 1860, 1887, 1886, Vill.-Bijalipur, P.O.-Atiyawan, Tehsil/Taluka-Ghosi, Town/City-Jehanabad, Dist.-Jehanabad, Bihar-804432 for conducting B.Ed. programme of two year duration with an annual intake of 200 students (Four Basic Units of 50 students each) from the academic session 2019-2020 *vide* order No. F.No.ER-255.6.25/ERCAPP3271/B.Ed./2018/56927 dated 10.05.2018, as per NCTE Regulations, 2014.

- 2. AND WHEREAS, a letter No. NCTE-CDN016(13)/18/2018-CDN-HQ dated 02.08.2018 was received from NCTE HQ. In compliance of the said letter, the matter was placed before 284<sup>th</sup> meeting of ERC-NCTE held on 17-18 September, 2020 and the Committee decided to issue the show cause notice to the institutions which have been recognized without NET qualified teachers. Accordingly, first SCN was issued to the institution on dated 28.09.2020. The reply dated 05.11.2020 submitted by the institution was received on 16.11.2020 in ERC.
- 3. AND WHEREAS, the matter was placed before ERC in its 303<sup>rd</sup> (Virtual) meeting held on 24<sup>th</sup> March, 2022 and the committee decided to issue final show cause notice under Section 17(1) of the NCTE Act, 1993 be issued to all ninety seven (97 TEIs). Accordingly, Final Show Cause Notice was issued to the institution on dated 09.04.2022. The reply of the institution was received in ERC on 09.05.2022.
- **4. AND WHEREAS,** the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 313<sup>th</sup> (virtual) meeting held on 16<sup>th</sup> November, 2022 and the Committee observed that:

"The institution has submitted its reply dated 04.05.2022 in response to the Final Show Cause Notice dated 09.04.2022 which is still deficient on the following grounds:

- The institution has submitted the list (s) of faculty approved on 30.04.2018 & 13.12.2019 by the affiliating university. The institution has not submitted the latest list of faculty duly approved by the affiliating University.
- The institution web-site is not working.
- From the Performance Appraisal Report (PAR) for the academic session 2020-21, it is observed that the institution has not updated its website as per NCTE Regulations, 2014.

Hence, Committee decided that the recognition for B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order."

- NOW THEREFORE, in terms of above decision of ERC, the recognition granted 5. to Prakash Punj Teachers Training College, Plot No.-1859, 1860, 1887, 1886, Vill.-Town/City-Jehanabad, P.O.-Ativawan. Tehsil/Taluka-Ghosi, Jehanabad. Bihar-804432 vide order No. F.No.ER-255.6.25/ERCAPP3271/B.Ed./2018/ 56927 dated 10.05.2018 for running B.Ed. programme is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.
- Further, if the institution is not satisfied by the order, they can prefer an appeal under 6. Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
