WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to **Dharikshan Singh Teachers Training College, Vill.-Kulharia, Street/Road-NH-30, Taluka/Mandal-Ara, Town/City-Kulharia, Dist.-Bhojpur, Bihar-802160** for conducting B.Ed. programme of two year duration with an intake of 100 students (Two Basic Units of 50 students each) from the academic session 2016-2017 *vide* order No. F.No.ER-213.6.11/ERCAPP2764/B.Ed./2016/46171 dated 02.05.2016 followed by order No. F.No.ERC/242.6.8/B.Ed./(Addl. Intake)/2017/Appl.Code No. ERCAPP201646276 Appl. ID No. 11324/54637 dated 11.10.2017 as per NCTE Regulations, 2014 for an annual addl. Intake of 50 (Existing 100 intake + additional 50 intake) thus making the sum total intake of 150 (Three Basic Units of 50 students each) from the academic session 2018-19.

- 2. AND WHEREAS, a letter No. NCTE-CDN016(13)/18/2018-CDN-HQ dated 02.08.2018 was received from NCTE HQ. In compliance of the said letter, the matter was placed before 284th meeting of ERC-NCTE held on 17-18 September, 2020 and the Committee decided to issue the show cause notice to the institutions which have been recognized without NET qualified teachers. Accordingly, first SCN was issued to the institution on dated 30.09.2020. The reply not submitted by the institution.
- 3. AND WHEREAS, the matter was placed before ERC in its 303rd (Virtual) meeting held on 24th March, 2022 and the committee decided to issue final show cause notice under Section 17(1) of the NCTE Act, 1993 be issued to all ninety seven (97 TEIs). Accordingly, Final Show Cause Notice was issued to the institution on dated 09.04.2022. The reply of the institution was received in ERC on 11.05.2022.
- 4. AND WHEREAS, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 313th (virtual) meeting held on 16th November, 2022 and the Committee observed that:

"The institution has submitted its reply dated 04.05.2022 in response to the Final Show Cause Notice dated 09.04.2022 which is still deficient on the following grounds:

- The institution has submitted the list(s) of faculty approved on 13.09.2019 & 01.06.2017 by the affiliating university. The institution has not submitted the latest list of faculty duly approved by the affiliating University.
- The institution has not appointed teaching faculty for Health and Physical Education, Fine Arts and Performing Arts.

- The institution has not uploaded the requisite information on its web-site as required under clause 7(14) of the NCTE Regulations, 2014 as amended from time to time.
- From the Performance Appraisal Report (PAR) for the academic session 2020-21, it is observed that the institution has not updated its website as per NCTE Regulations, 2014.

Hence, Committee decided that the recognition for B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order."

- 5. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to Dharikshan Singh Teachers Training College, Vill.-Kulharia, Street / Road-NH-30, Taluka/ Mandal-Ara, Town/City-Kulharia, Dist.-Bhojpur, Bihar-802160 vide order No. F.No.ERC/242.6.8/B.Ed./(Addl. Intake)/2017/Appl.Code No. ERCAPP201646276 Appl. ID No.11324/54637 dated 11.10.2017 for running B.Ed. programme for basic and additional units is hereby withdrawn with effect from the end of academic session next following the date communication of withdrawal order.
- 6. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
