#### ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Nanu Babu Educational and Charitable Trust, Vill - Dumari, Po-Dumari, Tehsil/Taluka- Begusarai, Town/City- Begusarai, District- Begusarai, Bihar-851117 has applied for grant of recognition to Tara College of Education, Plot No. 72, 73, Vill/Po- Bikrampur, Tehsil/Taluka - Cheriyabariyarpur, Town/City- Manjaul, District- Begusarai, Bihar- 851132 (Code No. ERCAPP3346) for D.El.Ed. Course online 02.06.2015 for two year duration and hard copy received by Eastern Regional Committee of NCTE on 10.06.2015.

- AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and videography, and the certificates received from the affiliating body, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.
- AND WHEREAS, as per decision of 218th ERC Meeting held on 11th -12th July 2016, formal 3. recognition order under clause 7(16) for conducting D.El.Ed. Course was issued vide No. ER-218.6.51/ ERCAPP3346/D.El.Ed./2016/48766 dated 03.08.2016 with an intake of 100 (two basic units) from the academic session 2017-2018 to the institution.
- AND WHEREAS, a representation vide Ref. No. 14/2017 dated 18.07.2017 received from the institution requesting to grant only one unit (50 intake) in place of two units (100 intake) as it has appointed only eight faculties. The Committee considered the matter in details and observed as under:
- The institution submitted list of eight faculties approved by Bihar School Examination Board on (i) 28.04.2016 in response to LOI u/c 7(13) decided in 211th ERC Meeting. However, inadvertently, decision was taken by ERC in its 218th meeting to grant recognition for D.El.Ed. course with intake of 100 instead of 50.

#### In view of the above, the Committee decided as under:

One unit of 50 intake capacity for D.El.Ed. course, out of 100 intake already granted vide order No. 48766 dated 03.08.2016 be withdrawn from the academic session 2017-2018 and a fresh revised recognition order under clause 7(16) of the NCTE Regulation, 2014 for D.El.Ed. course with intake of 50 (one basic unit) from the academic session 2017-2018 be issued to the institution.

- 5. **NOW THEREFORE,** as per decision of ERC, one unit of 50 intake capacity for D.El.Ed. course out of 100 intake already granted vide Order No. 48766 dated 03.08.2016 is **withdrawn** from the **academic session 2017-2018**.
- 6. NOW THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act 1993, the Eastern Regional Committee, NCTE hereby grants recognition to Tara College of Education, Plot No. 72, 73, Vill/Po- Bikrampur, Tehsil/Taluka Cheriyabariyarpur, Town/City- Manjaul, District- Begusarai, Bihar: 851132 for conducting D.El.Ed. Course of two years duration with an intake 50 (One basic unit) from the academic session 2017-2018 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 7. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc., as applicable.
- 8. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 9. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:-
- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
- c) Name of faculty members who left or joined during the last quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application;
- j) The institution shall be free to post additional relevant information, If it so desires.
- k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.

- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 11. The institution shall make available list of students admitted on its official website.
- 12. The Educational Institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.
- 13. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
