ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to **Millia Teachers Training College, Village-Radha Nagar, Kasba, Street/Road-NH-57, Taluka/Mandal-Kasba, Town/City-Radha Nagar, Kasba, District-Purnia, State-Bihar, Pin Code-854330** for conducting B.Ed. programme of two years duration with an annual intake of 100 students for (two units) vide Order No. F.No. ERC/247.6.13/B.Ed./2017/55537 dated 02.01.2018 from the academic session 2018-2019, as per NCTE Regulations, 2014.

2. AND WHEREAS, letter No. NCTE-CDN016(13)/18/2018-CDN-HQ dated 02.08.2018 was received from NCTE HQ. In compliance of the said letter, the matter was placed before 284th meeting of ERC-NCTE held on 17-18 September, 2020 and the Committee decided to issue the Show Cause Notice to the institutions which have been recognized without NET qualified teachers. Accordingly, SCN was issued to the institution on dated 28.09.2020. The reply of the institution was received in ERC on 16.11.2020.

3. AND WHEREAS, the matter was placed before ERC in its 303rd (Virtual) meeting held on 24th March, 2022 and the Committee decided to issue final Show Cause Notice under Section 17(1) of the NCTE Act, 1993 be issued to all ninety seven (97 TEIs). Accordingly, Final Show Cause Notice was issued to the institution on dated 09.04.2022. The reply of the institution was received in ERC on 19.05.2022.

4. AND WHEREAS, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 331st (virtual) meeting held on 26th July, 2023 and the Committee observed that:

“The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the matter was considered in reference to the Final Show Cause Notice dated 09.04.2022 and the Committee observed that:

- In reference to the Final Show Cause Notice dated 09.04.2022, the faculty list submitted by the institution reveals that one of the faculties at Sl. No. 1 namely Pramod Kumar Poddar appointed Assistant Professor does not have NET certificate/Ph.D.*

- *The institute website is not operational as on the date of the meeting.*

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order."

Accordingly, withdrawal order was issued to the institution on dated 09.08.2023.

5. **AND WHEREAS**, the institution preferred an appeal against the ERC withdrawal Order dated 09.08.2023. The Appellate Committee *vide* Order No. F.No.89-181/E-317904/2023 Appeal/13th Meeting,2023/APPLERC202314697/122383 dated 31.10.2023,decided as under:

"After perusal of the Appeal Report, documents on record and oral arguments advanced during the online hearing, Appeal Committee of the Council concluded to remand back the case to ERC with a direction to verify the submitted documents filed by the Appellant institution with Appeal from the records available with ERC and if it feel necessary and appropriate then documents may also be verified from the concerned competent authority. The Appellant institution is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the ERC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time in terms of direction given herein above".

6. **AND WHEREAS**, the reply of institution received in ERC office on dated 14.11.2023 was considered by the ERC in its 336th meeting of the ERC held on 20.12.2023 and the Committee decided as under:-

"The original file of the institution alongwith Appeal Order No. F.No.89-181/E-317904/2023 Appeal/13th Meeting,2023/APPLERC202314697/122383 dated 31.10.2023, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

- *The Committee noted that the withdrawal order 09.08.2023 has already been set aside by the Appellate Authority vide its Order dated 31.10.2023 and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running B.Ed. programme is restored until a fresh withdrawal order is issued by ERC. Order be issued accordingly."*

7. **NOW THEREFORE**, in terms of above decision of ERC, the recognition granted to the institution viz. **Millia Teachers Training College, Village-Radha Nagar, Kasba, Street/Road- NH-57, Taluka/Mandal-Kasba, Town/City-Radha Nagar, Kasba, District-Purnia, State-Bihar, Pin Code-854330** *vide* Order No. F.No.ERC/247.6.13/B.Ed./2017/55537 dated 02.01.2018 for an annual intake of 100 students for two basic units is restored until a fresh withdrawal order is issued by ERC.
