ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, R S Teachers Training College, Plot-No:-332, 333, 334, 338, 339, Street No.-239, Vill/Po- Katras Bazar, Tehsil/ Taluka-Baghinara, Town/City-Katras, Dist.Dhanbad, Jharkhand-828114 (Run by Radhe Shyam Memorial Trust, Plot No.-332, Street/Road-Hirak Road, Vill./P.O.-Katras Bazar, Tehsil/Taluka-Baghmara, District-Dhanbad, Jharkhand-828114) applied for grant of recognition to R S Teachers Training College, Plot-No:-332, 333, 334, 338, 339, Street No.-239, Vill/Po- Katras Bazar, Tehsil/ Taluka-Baghinara, Town/City-Katras, Dist. Dhanbad, Jharkhand-828114 (Code No.-ERCAPP1178) for B.Ed. programme of one year duration online on 29.09.2011 and hard copy received by Eastern Regional Committee of NCTE on 07.10.2011.

2. **AND WHEREAS**, the institution viz. R S Teachers Training College, Plot-No:-332, 333, 334, 338, 339, Street: No.-239, Vill/Po- Katras Bazar, Tehsil/ Taluka-Baghinara, Town/City-Katras, Dist. Dhanbad, Jharkhand-828114 was granted recognition for B.Ed. course of one year duration with an intake of 100 from the academic session 2014-2015 vide ERC Order No.F.ERC/7-160.6.3.13/NCTE/B.Ed./2013/20578 dated 31.08.2013, followed by revised order vide No.F.ERC/NCTE/ERCAPP1178/B.Ed.(Revised Order)/2015/32601 dated 31.05.2015 with an annual intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

3. **AND WHEREAS**, the ERC in its 267th meeting held on 10th-11th February, 2019 considered the matter of compliance report in light of NCTE Regulations, 2014 submitted by the institution and as decided by ERC, show cause notice under Section 17(1) issued to the institution vide letter No.F.3-3/Regulation/NCTE/ERC/2016-2019/59372 dated 21.02.2019 with direction to comply following within 21 days from the date of issue of the letter:

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit

4. **AND WHEREAS**, the ERC in its 279th Meeting held on 14th-16th February, 2020 considered reply in response to show cause notice and as decided by ERC, second show cause notice under Section 17(1) issued to the institution vide letter No.F.ER-279.40/(ERCAPP1178)/B.Ed./2020/62597 dated 05.03.2020 with direction to comply following within 21 days from the date of issue of the letter:

- (ii) Faculty list duly signed by the concerned affiliating body is required to be submitted.
- (iii) Original FDRs of Rs. 5 lakh and Rs. 7 lakh to be submitted.
- (iv) Certified copy of Fire Safety Certificate duly signed by the Govt. Competent Authority to be submitted.
- (v) Requisite information of the institutional website has not updated as per Clause 7(14)(i) of the NCTE Regulations, 2014.

5. **AND WHEREAS**, the ERC in its 282nd Meeting held on 8th-9th July, 2020 considered reply in response to show cause notice and as decided by ERC, third show cause notice under Section 17(1) issued to the institution vide letter No.F.ERC/282.44/ERCAPP1178/B.Ed./2020/62876 dated 11.08.2020 with direction to comply following within 21 days from the date of issue of the letter:

- (i) Faculty list for the session 2018-2019 & 2019-2020 and till date.
- (ii) Proof of disbursement of salary for all staff (teaching-non teaching).

6. **AND WHEREAS**, the ERC in its 283rd meeting held on 24th-25th August, 2020 considered the matter along with the reply dated 07.03.2020 received in this office on 12.03.2020 submitted by the institution in response to Final Show Cause Notice and observed as under:-

- (i) There is a mismatch between faculty list submitted by the institution and details of the same uploaded in the institutional website.
- (ii) Certified copy of the land document has not submitted.
- (iii) Original list of teaching faculty duly approved by the concerned affiliating body has not been submitted.
- (iv) Validity of fire safety certificate is expired on 23.03.2018.


In view of the above, the Committee decided as under:

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-2022. Accordingly, withdrawal order issued to the institution vide F.No.ER-283.26/ERCAPP1178/B.Ed./2020/62983 dated 07.09.2020.

7. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's withdrawal order dated 07.09.2020. The Appellate Authority vide its Order No F.No.89-221/E-167263/2020 Appeal/29th Mtg.-2020/2nd December, 2020/95585 dated 16.12.2020 remanded back the case to ERC to revisit the matter for issue of revised speaking order on the virtual merits of the case.

8. **AND WHEREAS**, the ERC in its 288th meeting held on 29th January, 2021 considered the matter along with the reply dated 22.12.2020 received in this office on 28.12.2020 submitted by the institution in reference to appeal order dated 07.09.2020 and observed as under:-

(i) Fresh faculty list duly approved by the concerned affiliating body to be submitted.

Accordingly, show cause notice issued to the institution vide Letter No.F.ERC/288.21/ERCAPP1178/B.Ed./2021/63579 dated 05.02.2021.

9. **AND WHEREAS**, the ERC in its 292nd meeting held on 20th April, 2021 considered the matter along with the reply dated 05.03.2021 received in this office on 09.03.2021 submitted by the institution in response to Show Cause Notice and observed as under:-

(i) Fresh faculty list duly approved by the concerned affiliating body to be submitted.

(ii) Valid fire safety certificate issued by the competent Govt. Authority to be submitted.

Hence, Final show cause notice under section 14(3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice."

Accordingly, final show cause notice issued to the institution vide letter No.F.ERC/292.23/ERCAPP1178/B.Ed./2021/64048 dated 29.04.2021.

10. **AND WHEREAS**, the ERC in its 302nd ERC (Virtual) Meeting held on 28th February and 01st March, 2022 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, representations dated 24.05.2021, 16.08.2021 from the institution in reference to grounds of show cause notice dated 29.04.2021 and the Committee made following observations:-

(i) Certified copy of Fire Safety Certificate duly signed by the competent authority has not been submitted.


(ii) The institution has not submitted individual affidavit on Rs. 10/- non-judicial stamp paper for the newly appointed faculty i.e. faculty mentioned at Sl. No. 1, 2,3, 8, 9, 12, 13, and 15 of approved faculty list dated 11.08.2021 along with their educational qualifications/testimonials/Ph.D certificates as required under NCTE Regulations.

(iii) The institution has not submitted experience certificate with educational qualifications/testimonials/Ph.D. certificate and individual affidavit on Rs. 10/- non-judicial stamp paper in respect of newly appointed Principal (Dr. Mousumi Chaudhari).

(iv) The institutional website has not been maintained and updated as per NCTE Regulations.

Hence, recognition granted to B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session 2022-2023. On withdrawal of recognition, the affiliation, if any granted under Clause 8(10) of NCTE Regulations, 2014 by the concerned affiliating body from the next academic session stands withdrawn. Hence, the institution is not entitled to apply for counselling from the next academic session i.e.2022-2023 and the institution is also not permitted to take any fresh admission of students from the academic session 2022-2023.
