 - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
 - c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.

(i) Building completion certificate is not signed by Govt. Engineer.

Recognition granted to **B.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

- 5. **NOW THEREFORE**, recognition granted to the institution viz. ICFAI College of Education, Agartala, ICFAI University, Bidurkartaa Chowmohani, Jagannath Bari Road, Agartala, Tripura 799001 (Code No. APE00470) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from 2020-2021.
