ORDER

WHEREAS, ICFAI College of Education, Agartala, ICFAI University, Bidurkartaa Chowmohani, Jagannath Bari Road, Agartala, Tripura – 799001 (Code No. APE00470) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2006-2007 vide ERC order No.1449 dated 23.11.2005, followed by revised order vide No. 32426 dated 30.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 266th meeting held on 31st January, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 14.02.2019 to the institution on the following grounds:

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

3. **AND WHEREAS**, the ERC in its 271st meeting held on 24th – 25th April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 18.05.2019 to the institution on the following grounds:

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

4. **AND WHEREAS**, the ERC in its 274th meeting held on 15th – 16th July, 2019 considered the matter and observed as under:

1st show cause notice u/s 17(1) issued on 14.02.2019, followed by final show cause notice dated 18.05.2019 and the institution is still deficient on the following grounds:-

- (i) Building completion certificate is not signed by Govt. Engineer.

Recognition granted to **B.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 **from the academic session 2020-2021**.

5. **NOW THEREFORE**, recognition granted to the institution viz. ICFAI College of Education, Agartala, ICFAI University, Bidurkartaa Chowmohani, Jagannath Bari Road, Agartala, Tripura – 799001 (**Code No. APE00470**) for **B.Ed. Course** is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from **2020-2021**.

6. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
