**ORDER**

WHEREAS, M.Ed Department of Kolhan University, Street No.- 305, Vill.- Chaibasa, P.O.- Chaibasa, Tehsil/Taluka- Chaibasa, Town/City- Chaibasa, Dist.- Pashchim Singhbhum, Jharkhand- 833202 (Code No. ERCAPP1932) was granted recognition for M.Ed. course of one year duration with an annual intake of 35 vide ERC order No.24392 dated 03.03.2014 from the academic session 2014.2015.

2. AND WHEREAS, Revised Recognition Order (RRO) was issued to the institution vide ERC order No.32688 dated 31.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 (One basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

3. AND WHEREAS, the ERC in its 274<sup>th</sup> meeting held 15<sup>th</sup> – 16<sup>th</sup> July, 2019 considered the matter and as decided, recognition to M.Ed. Course was withdrawn u/s 17(1) vide order No. 61169 dated 05.08.2019 from the academic session 2020-2021 on the following grounds:-

- (i) The submitted faculty list is not in accordance with the NCTE prescribed proforma.
- (ii) Building completion certificate is not submitted.

4. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 05.08.2019. The Appellate Authority vide its Order No.89-374/E-136541/2019 Appeal/34<sup>th</sup> Mtg.-2019/22<sup>nd</sup> November, 2019/85866 dated 05.12.2019 concluded that appellant is required to submit copy of required documents to ERC within 15 days of the issue of appeal order and thereupon ERC shall revisit the matter for taking an appropriate decision afresh.

5. AND WHEREAS, on the direction of Appellate Authority, the institution submitted representation vide letter dated 16.12.2019 received in this office on 19.12.2019. The ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> – 16<sup>th</sup> February, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 05.12.2019 and decided as under:-

**Restoration of recognition order of M.Ed. course to be issued.**




