ORDER

WHEREAS, Ashu Kisku Memorial B.Ed. and Rabi Kisku Teachers Training Institute, Plot No.- 327/47, Vill.- Lupungdih, PO.- Tankacha, Tehsil/Taluka Chandil, Town/City Chandil, Dist.- Pashchim Singhbhum, Jharkhand-832401(ERCAPP656) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC Order No. 18905 dated 14/06/2013, followed by revised order vide No.32369 dated 29.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 272nd meeting held on 30th - 31st May & 1st June, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 18/06/2019 to the institution on the following grounds:

- (i) Fresh up-to-date faculty list approved by affiliating body needs to be submitted.
- (ii) Photocopy of building plan is not readable.
- (iii) The original FDRs are to be returned to the institution. FDRs Rs.12 lakh (Rs.5 lakh + Rs.7 lakh) towards Endowment and Reserve fund in joint mode with RD, ERC, NCTE along with bank certificate as per NCTE Regulations, 2014 needs to be submitted.
- (iv) Website not updated.
- (v) Fire safety certificate issued from competent Govt. Authority is to be submitted.

3. AND WHEREAS, the ERC in its 279th Meeting held on 14th -16th February, 2020. considered the matter and reply received on dated 27/06/2019 & 02/07/2019 from the institution in response to Show Cause Notice dated 18/06/2019 and observed as under.

- 1st show cause notice u/s 17(1) issued on 20/04/2018 follow by Final show cause notice issued dated 27/11/2018 and the institution is still deficient on the following ground:-
- (i) Original renewed FDRs of Rs.5 lakh & Rs. 7 lakh is not submitted as per NCTE Regulation, 2014.
 - (ii) Fire safety certificate is not renewed.
 - (iii) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

4. NOW THEREFORE, recognition granted to the institution viz. Ashu Kisku Memorial B.Ed. and Rabi Kisku Teachers Training Institute, Plot No.- 327/47, Vill.- Lupungdih, PO.- Tankacha, Tehsil/Taluka Chandil, Town/City Chandil, Dist.- Pashchim Singhbhum, Jharkhand-832401 (Code No. ERCAPP656) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.




