REVISED ORDER

WHEREAS, in terms of Section 15(1) of the NCTE Act, 1993, Deomata Educational and Medical Trust, Plot no - 2878/3670, Street/Road - NH - 30, Jagdishpur, Vill - Utarwari Jungle, Po - Dulour, Tehsil/Taluka - Jagdishpur, Town/City - Jagdishpur, Dist - Bhojpur, Bihar - 802158 has applied for grant of permission to **Apsam College of Education, Plot no - 2878/3670, Street/Road - NH - 30, Jagdishpur, Vill - Utarwari Jungle, Po - Dulour, Tehsil/Taluka - Jagdishpur, Town/City - Jagdishpur, Dist - Bhojpur, Bihar - 802158 (Code No. ERCAPP3814)** for **B.Ed. programme** online on **29.06.2015** for two year duration and hard copy received by Eastern Regional Committee of NCTE on **08.07.2015**.

2. **AND WHEREAS**, as per the decision of 210th ERC Meeting held on 7th -9th April 2016, formal permission order under clause 7(16) for conducting B.Ed. course was issued vide No. 45719 dt. 27.04.2014 with an additional intake 50 (existing 100 intake + additional 50 intake) thus making total intake 150 from the academic session 2016-17.

3. **AND WHEREAS**, the institution preferred an appeal to the Appellate Authority of NCTE Hqrs. against the ERC's order dated 27.04.2016. The Appellate Authority vide order No. 89-291/2016 Appeal/9th Meeting-2016/35625 dated 04.08.2016 remanded to ERC for re-visiting the case with reference to extant Regulations. The ERC in its 223rd meeting held on 14th -15th October, 2016 considered the appeal order and decided that the previous decision of ERC remains unchanged and the matter was forwarded to NCTE Hqrs. as a miscellaneous application for further directions.

The NCTE Hqrs. vide letter No. 92-08/2016/ Corres. ERC/Appeal/52545 dated 13.04.2017 referred the case to ERC to re-visit as per decision of the Appellate Authority as contained in the Appellate Order pertaining to the institution.

4. **NOW THEREFORE**, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants recognition to **D.L.S. Shiksha Mahavidhyalay, Vill:- Sidhari (Badulganj), Street / Road:- Sidhari (Badulganj), Taluka/ Mandal:- Pirpaiti, Town/City :- Sidhari (Badulganj), Dist:- Bhagalpur, Bihar-813206** for conducting **D.El.Ed. programme** of two years duration with an another intake of **50 (one basic unit), (existing 150 intake + another 50 intake), thus making the total intake of 200 (Two hundred)** from the academic session **2018-2019** under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.

- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
5. Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
7. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee, covering, inter-alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:-
- a) Sanctioned programmes along with annual intake in the institution;
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
 - c) Name of faculty members who left or joined during the last quarter;
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application;
 - j) The institution shall be free to post additional relevant information, If it so desires.
 - k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.
8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
9. The institution shall make available list of students admitted on its official website.
10. The Educational institution shall follow Uniform Accounting System as brought out by ICAI and accepted by MHRD.

11. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition / permission by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
