ORDER

WHEREAS, in terms of Section 14(3)(a) of the NCTE Act, 1993, the recognition was granted to Nandalal Ghosh B.T. College, Panpur, P.O.-Narayanpur, Dist.-North 24 Parganas, West Bengal-743123 for conducting B.Ed. programme of one year duration with an annual intake of 100 students *vide* Order No. ERC/7-75.6(II)24/2007/7920 dated 03.05.2007, followed by revised recognition order for B.Ed. programme of two years duration with an annual intake of 100 students (Two Basic Units of 50 students each) from the academic session 2015-2016 *vide* Order ERC/NCTE/APE00643/B.Ed./(Revised Order)/2015/31935dated 23.05.2015, as per NCTE Regulations, 2014.

- **2. AND WHEREAS**, recognition of the institution was withdrawn *vide* Order No. ER-274.14.105/APE00643/B.Ed./2019/61301 dated 20.08.2019.
- 3. AND WHEREAS, the Appellate Authority vide Order No. F.No.-89-370/E-135961/2019Appeal/34thMtg.-2019/22nd November, 2019/85850 dated 05.12.2019, decided as under:

"Appeal Committee of the Council concluded to remand back the case to ERC to revisit the matter keeping in view the replies dated 02.07.2019 and 30.07.2019 already submitted by appellant institution. After considering ERC should issued appropriate speaking order afresh."

- **4. AND WHEREAS,** on further scrutiny of documents submitted by the institution vide its representations dated 30.07.2019 in reference to grounds of withdrawal order dated 20.08.2019 in light of NCTE Regulations, 2014, as per observations of the Committee in its 279th Meeting held on 14th 16th February, 2020, Show Cause Notice dated 02.03.2020 was issued to the institution.
- 5. AND WHEREAS, resentation received on 11.03.2020 & 06.08.2020 from the institution in reference to grounds of Show Cause Notice dated 02.03.2020, the ERC in its 283rd Meeting held on 24th & 25th August, 2020, decided to issue the Final Show Cause Notice dated 15.09.2020.
- 6. AND WHEREAS, no reply was submitted by the institution in reference to Final Show Cause Notice dated 15.09.2020. The ERC in its 289th Meeting held on 15th February, 2021, decided to issue the withdrawal order dated 25.02.2021.
- 7. **AND WHEREAS,** the Appellate Authority *vide* Order No. F.No.-89-275/E-285042/2022 Appeal/3rdMeeting, 2023/APPLERC202214500/116552 dated 07.03.2023, decided as under:

"Appeal Committee of the Council concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verity the submitted documents from the concerned issuing authority."

8. AND WHEREAS, representation dated 11.03.2023 & 20.03.2023 received in ERC office on dated 22.03.2023 & 23.03.2023, were considered by the ERC in its 326th (Virtual) meeting of the ERC held on 23.05.2023 and the committee decided as under:-

"The original file of the institution alongwith Appeal Order No. F.No.-89-275/E-285042/2022 Appeal/3rdMeeting, 2023/APPLERC202214500/116552 dated 07.03.2023, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

- The Committee noted that the withdrawal order 25.02.2021 has already been set aside by the Appellate Authority vide its Order dated 07.03.2023 and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running B.Ed. programme is hereby restored. Order be issued accordingly."
- 9. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. Nandalal Ghosh B.T. College, Panpur, P.O.-Narayanpur, Dist.-North 24 Parganas, West Bengal-743123 vide Order ERC/NCTE/APE00643/B.Ed./(Revised Order)/2015/31935 dated 23.05.2015 for an annual intake of two basic units of 50 students each is hereby restored subject to fulfillment of the condition as per NCTE Regulations, 2014.
