ORDER

WHEREAS, in terms of Section 15(3)(a) of the NCTE Act, 1993, the recognition was granted to District Institute of Education and Training (DIET), Pasighat, East Siang District, Arunachal Pradesh-791102 for conducting D.El.Ed. programme of two year duration with an annual intake of 50 students *vide* Order No. ERC/7-73.6(a).23/2007/6234 dated 02.02.2007, as per NCTE Regulations, 2014.

- **2. AND WHEREAS**, recognition of the institution was withdrawn *vide* Order No. F.No.ER-316.2/APE00405/D.El.Ed./AP/2022/67082 dated 02.01.2023.
- 3. AND WHEREAS, the Appellate Authority *vide* Order F.No.-89-45/E-291280/2023 Appeal/4th Meeting, 2023 APPLERC202314557/117894 dated 10.04.2023, decided as under:

"Appeal Committee of the Council concluded to remand back the case to ERC with a direction to consider the documents submitted in appeal which are required to be sent to them by the appellant institution and take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time. The Appellant is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal. The ERC is at a liberty to verity the submitted documents from the concerned issuing authorities.

4. AND WHEREAS, ERC in its 326th (Virtual) meeting of the ERC held on 23.05.2023 and the committee decided as under:-

"The original file of the institution alongwith Appeal Order No. 89-45/E-291280/2023 Appeal/4th Meeting, 2023 APPLERC202314557/117894 dated 10.04.2023, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC.

• The Committee noted that the withdrawal order 02.01.2023 has already been set aside by the Appellate Authority vide its Order dated 10.04.2023 and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running D.El.Ed. programme is hereby restored. Order be issued accordingly."
