<u>ORDER</u>

WHEREAS, Renuka Debi B.Ed. College, PO-Shyamnagar, Betai-Plassey Road, Dist-Nadia, West Bengal-741155 was granted recognition for B.Ed. Course with an annual intake of 100 vide ERC Order No.12815 dated 30.08.2008 from the academic session 2008-2009, followed by revised recognition order vide No.31824 dt. 22.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

AND WHEREAS, the ERC in its 279^{th} meeting held on 14^{th} - 16^{th} February, 2020 decided that recognition granted to B.Ed. course be withdrawn from the academic session 2020-2021. Accordingly, withdrawal order issued vide No.62498 dt. 02.03.2020 on the ground mentioned therein.

3. **AND WHEREAS,** institution preferred an appeal to the NCTE HQrs against the ERC's withdrawal order dated 02.03.2020. The Appellate Authority vide Order No.89-268/E-170922/2020 Appeal/1st Mtg.-2021/18th January, 2021 dated 28.01.2021 remanded back the case to ERC with a direction to consider the relevant website pages to be sent to them by the appellant and take further necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward to the ERC copies their website pages within 15 days of receipt of orders on the appeal.

4. **AND WHEREAS**, the institution had submitted representation dt.18.02.2021 received in this office on 19.02.2021. The ERC in its 290th (Part-I) meeting held on 3rd March, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, appeal order dated 28.01.2021 and decided to issue show cause notice under section 14 of the NCTE Act, 1993, accordingly, show cause notice was issued vide No.63837 dated 17.03.2021 with grounds mentioned therein.

5. **AND WHEREAS**, the institution did not submit any representation in response to show cause notice dated 17.03.2021 and the matter was considered by ERC in its 293rd meeting held on 09th June, 2021and decided to issue final show cause notice under section 14 of the NCTE Act, 1993, accordingly, final show cause notice issued vide No.64205 dated 11.06.2021 on the following grounds:

(i) Show Cause Notice was issued on 17.03.2021.

(ii) No reply received from the institution in stipulated time.

6. **AND WHEREAS,** the ERC in its 300th (Virtual) Meeting held on 28th December, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, representations from the institution in response to final show cause notice and decided as under:

"Restoration of recognition order to the institution viz. Renuka Debi B.Ed. College, PO- Shyamnagar, Betai- Plassey Road, Dist- Nadia, West Bengal-741155 for B.Ed. course with annual intake of 100 students (02 units) be issued."

7. NOW THEREFORE, withdrawal order dated 02.03.2020 issued to the institution viz. Renuka Debi B.Ed. College, PO-Shyamnagar, Betai-Plassey Road, Dist-Nadia, West Bengal-741155 for B.Ed. course is hereby restored with annual intake of 100 students (02 units).

8. The terms and conditions of the revised recognition order no.31824 dt.22.05.2015 issued to the institution shall remain unchanged.
