ORDER

WHEREAS, the institution viz. David Hare Training College (Institute of Advanced Studies in Education), 25/3, Ballygunge Circular Road, Calcutta, West Bengal -700019 has been granted recognition for both B.Ed. and M.Ed. courses respectively.

2. **AND WHEREAS**, ERC in its 248th meeting held on 12th -13th January, 2018 considered the representation from Registrar of The West Bengal University of Teachers' Training, Education Planning and Administration vide their Ref. No. WBUTTEPA/RO/ 198/2017 dated 13.06.2017 has been received with request to change the name of "David Hare Training College (Institute of Advanced Studies in Education)" into the new name of "The West Bengal University of Teachers' Training, Education Planning and Administration" as this college has been upgraded by the Govt. of West Bengal into "The West Bengal University of Teachers' Training, Education Planning and Administration" from the year 2014, wherein the existence of Teacher Education programme being converted as the Deptt. of Education under this University.

In view of the above, the Committee decided as under:

The nomenclature of the institution viz. "David Hare Training College (Institute of Advanced Studies in Education), 25/3, Ballygunge Circular Road, Calcutta, West Bengal -700019" **be changed to** "The West Bengal University of Teachers' Training, Education Planning and Administration, 25/2 & 25/3, Ballygunge Circular Road, Kolkata, West Bengal -700019".

The Committee is of the opinion that the Department of Teacher Education which was previously David Hare Training College (Institute of Advanced Studies in Education) be permitted to run the programme under this University.




