## <u>ORDER</u>

WHEREAS, Vidyasagar Foundation School of Education & Training, Vill-Tamna, PoSimulia, Dist-Purulia, West Bnegal-723102 (APE00876) was granted recognition for B.Ed. course with an annual intake of 100 vide ERC's order dated 30.08.2008. Revised recognition order issued on 28.05.2015 with an annual intake of 100 for two basic units from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHEREAS,** the ERC in its 275<sup>th</sup> meeting held on 26<sup>th</sup> July, 2019 considered the matter and decided to withdraw recognition to B.Ed. course u/s 17(1) of NCTE Act 1993 from the academic session 2020-2021. Accordingly, withdrawal order was issued vide F.No.ER-275.14.18/APE00876/B.Ed./2019/61475 dated 02.09.2019 to the institution.

3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC's order dated 02.09.2019. The Appellate Authority vide order No.89-419/E-139384/2019 Appeal/37<sup>th</sup> Mtg.-2019/27<sup>th</sup> November, 2019/86541 dated 23.12.2019 decided to remand back the case to ERC for revisiting the matter.

4. **AND WHEREAS,** the institution submitted reply vide letters dated 02.01.2020 received on 06.01.2020. The ERC in its  $279^{\text{th}}$  meeting held on  $14^{\text{th}} - 16^{\text{th}}$  February, 2020 considered the matter and as decided, Show Cause Notice was issued on 28.02.2020 to the institution.

5. **AND WHEREAS,** the institution submitted reply vide letters dated 11.03.2020 received on 16.03.2020. The ERC in its  $282^{nd}$  meeting held on  $8^{th} - 9^{th}$  July, 2020 considered the matter and as decided, Final Show Cause Notice was issued on 22.07.2020 to the institution.

6. **AND WHEREAS,** the institution submitted reply vide letters dated 20.07.2020 received on 31.07.2020, the ERC in its 284<sup>th</sup> meeting held on 17<sup>th</sup> & 18<sup>th</sup> September, 2020 considered the matter and decided to B.Ed. course is withdrawn under section 17(1) of NCTE Act 1993 from the next academic session 2021-22 is stand valid as per the withdrawal order issued by the ERC F.No. ER-275.14.18/APE00876/B.Ed./2019/61475 dated 02.09.2019. Accordingly, withdrawal order was issued vide F.No.ER-284.30/APE00876/B.Ed./2020/63379 dated 17.12.2020 to the institution.

7. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 17.12.2020. The Appellate Authority vide order No.89-02/E-173468/2021 Appeal/7<sup>th</sup> Mtg.-2021/23<sup>rd</sup> February, 2021/97942 dated 12.03.2021 decided to remand back the case to ERC for revisiting the matter.

The ERC in its 292<sup>nd</sup> meeting held on 20<sup>th</sup> April, 2021 considered the matter and as decided, Show Cause Notice was issued on 29.04.2021 to the institution.

9. **AND WHEREAS,** the institution submitted reply vide letters dated 05.05.2021 received on 11.05.2021. The original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to show cause notice, were carefully considered by ERC in its 293<sup>rd</sup> meeting held on 9<sup>th</sup> June, 2021 and the committee decided as under:-

## "Restoration of recognition order for B.Ed. course with an annual intake of 100 (two units) be issued."

10. NOW, THEREFORE, recognition withdrawn vide order No. F.No.ER-284.30/APE00876/B.Ed./2020/63379 dated 17.12.2020 to the institution viz. Vidyasagar Foundation School of Education & Training, Vill-Tamna, PoSimulia, Dist-Purulia, West Bnegal-723102 (Code No. APE00876) for B.Ed. Course is hereby restored recognition with an annual intake of 100 (two units).

11. The terms & conditions of the Order No. F.ERC/NCTE/APE00876/B.Ed.(Revised Order)/2015/32328 dated 28.05.2015 issued to the institution shall remain unchanged.
