ORDER

WHEREAS, R. M. College Saharsa, Plot No.855, Vill./Po.Saharsa, Tehsil/Taluka-Kahra-Saharsa, Town/City-Saharsa, Dist-Saharsa, Bihar-852201 was granted recognition for B.Ed. Course with an annual intake of 100 vide ERC Order No.16588 dated 02.03.2013 from the academic session 2013-2014, followed by revised recognition order vide No.32070 dt.25.05.2015 with an annual intake of 100 (Two Basic Units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

- AND WHEREAS, the ERC in its 274th meeting held on 15th 16th July, 2019, decided that recognition granted to B.Ed. course be withdrawn from the academic session 2020-2021. Accordingly, withdrawal order issued vide No.61442 dt.28.08.2019.
- AND WHEREAS, institution preferred appeal against the withdrawal order at NCTE HQrs. and the Appellate Authority vide order 89-421/E-139377/2019 Appeal/9th Mtg.-2020/28th February, 2020/ 91506 dated 15.07.2020 confirms the withdrawal order against the appeal.
- AND WHEREAS, institution filed a petition CWJC No.8706 of 2020 at Hon'ble High Court Patna and as per the Oral Order dt.15.04.2021 High Court institution submitted its representation dt.11.05.2021 received on 01.06.2021.
- AND WHEREAS, the ERC in its 293rd meeting held on 9th June, 2021 considered the original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the order dated 15.04.2021 passed by the Hon'ble High Court of Patna in C.W.J.C. No.8706 of 2020 were carefully considered by the ERC and Committee decided as under:-

Restoration of recognition order for B.Ed. course with an annual intake of 100 (two units) be issued.

NOW THEREFORE, withdrawal order dated 28.08.2019 issued to the institution viz. R. M. College Saharsa, Plot No.855, Vill./Po.Saharsa, Tehsil/Taluka-Kahra-Saharsa, Town/City-Saharsa, Dist-Saharsa, Bihar-852201 for B.Ed. course is hereby restored permitting the total annual intake of 100 (two basic units).

The terms and conditions of the revised recognition order No.32070 dt.25.05.2015 issued to the institution shall remain unchanged.
