- 3. **AND WHEREAS**, the institution has preferred an appeal Order No. F.No.89-337/E-133153/2019Appeal/30th Mtg.-2019/14th October,2019/83401 dated 25.10.2019 against the ERC withdrawn order dated 26.08.2019 but the appeal committee decided to remand back the case to ERC for considering the compliance with is required to be submitted by appellant institution within 15 days of the issued of appeal order.
