**ORDER** 

WHEREAS, Krishna Bora B.Ed. College, Lanka, Nagaon, Assam – 782446 (APE00212) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2004-2005 vide ERC order dated 08.12.2004, followed by revised recognition order issued on 22.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

- 2. **AND WHERAS,** the ERC in its  $272^{nd}$  meeting held on  $30^{th} 31^{st}$  May &  $1^{st}$  June, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 60715 dated 14.06.2019 from the academic session 2020-2021 to the institution.
- 3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 14.06.2019. The Appellate Authority vide order No.89-306/E-128026/2019 Appeal/27<sup>th</sup> Mtg.-2019/27<sup>th</sup> August, 2019/82350 dated 26.09.2019 remanded back to ERC for revisiting the matter after the appellant submits revised list of faculty within 15 days of issue of appeal order.
- 4. **AND WHEREAS**, the institution has submitted reply vide letter dated 01.10.2019 received in this office on 09.10.2019. The ERC in its 277<sup>th</sup> meeting held on 19<sup>th</sup> 20<sup>th</sup> December, 2019 considered the matter and as decided, Show Cause Notice was issued on 26.12.2019 to the institution.
- 5. **AND WHEREAS**, the institution has submitted reply vide letter dated 04.01.2020 received in this office on 10.01.2020. The ERC in its 280<sup>th</sup> meeting held on 29<sup>th</sup> February & 1<sup>st</sup> March 2020 considered the matter and as decided, Final Show Cause Notice was issued on 03.03.2020 to the institution on the following grounds:
  - (i) Faculty namely
    - a. Shri Debasish possess 55.8 1% in M.A.(Education) and 46% in B.Ed., which is less than the prescribed 55% m B.Ed. as stipulated m Appendix -4 of Regulation, 20 14.
    - b. Mrs. Gitika Phukan possess 57.62% m M.A.(Education) and 50% m B.Ed., which ts less than the prescribed 55% m B.Ed. as stipulated m Appendix-4 of Regulation, 2014.
    - c. Md. Anarul Islam possess 66.47% in M.A.(Education) and 51.71% m B.Ed., which is less than the prescribed 55% m B.Ed. as stipulated m Appendix-4 of Regulation, 2014.
    - d. Mathematics teacher has not been appointed. However, Mr. Mainul Islam appointed on part-time basis, which 1s not permissible as per Appendix-4 of Regulation, 2014.

(ii) The institution is directed to submit revised list duly approved by the affiliating University as per Appendix-4 of Regulation, 2014.
